13	Statement of purpose of bill as introduced: This bill proposes to waive
14	50 percent of the registration fee for certain motor vehicles upon proof that the
15	registered owner or co-owner is a veteran who received a discharge under
16	other than dishonorable conditions and to exempt from State income taxation
17	the first \$15,000.00 of Vermont state government, federal government, and
18	U.S. Armed Forces pension plan income. This bill also requires the Vermont
19	Office of Veterans Affairs to develop and maintain a database of veterans in
20	Vermont but indicates that any information that is collected is exempt from
21	public inspection and copying.

4	It is hereby enacted by the General Assembly of the State of Vermont:
5	Sec. 1. 23 V.S.A. § 378 is amended to read:
6	§ 378. VETERANS' EXEMPTIONS
7	(a) No fees shall be charged an honorably discharged to a veteran of the
8	U.S. Armed Forces who received a discharge under other than dishonorable
9	conditions and is a resident of the State of Vermont for the registration of a
10	motor vehicle that the veteran has acquired with financial assistance from the
11	U.S. Department of Veterans Affairs, or for the registration of a motor vehicle
12	owned by him or her during his or her lifetime obtained as a replacement
13	thereof, when his or her application is accompanied by a copy of an approved
14	VA Form 21-4502 issued by the U.S. Department of Veterans Affairs
15	certifying him or her to be entitled to the financial assistance.
16	(b) A veteran of the U.S. Armed Forces who received a discharge under
17	other than dishonorable conditions and is a resident of the State of Vermont
18	shall be entitled to a 50 percent reduction of the registration fees owed under
19	sections 361 (pleasure cars), 364 (motorcycles), 364a (motor-driven cycles),
20	364b (all-surface vehicles), 373 (exhibition vehicles), 382 (diesel-powered
21	pleasure cars), 3204 (snowmobiles), 3204a (antique snowmobiles), 3305

(motorboats), and 3504 (all-terrain vehicles) of this title and 3 V.S.A.
