6	Statement of purpose of bill as introduced: This bill proposes to implement
7	Vermont's individual mandate to maintain health insurance coverage. It would
8	also codify in State law certain health insurance consumer protections,
9	including a ban on preexisting condition exclusions and a requirement to
10	provide coverage for dependents up to 26 years of age. The bill would require
11	looking through the structure of an association to provide health insurance
12	plans based on the size of each underlying employer. It would prohibit
13	licensed brokers from accepting payment for enrolling Vermont residents in
14	certain health expense-sharing arrangements and would require the Green
15	Mountain Care Board to quantify the impact of the Medicaid and Medicare
16	cost shifts and uncompensated care on health insurance premiums. The bill
17	would also direct the Agency of Human Services to develop strategies for
18	increasing the affordability of health insurance and to evaluate options for the
19	future of Vermont's health insurance markets.
