Statement of purpose of bill as introduced: This bill proposes to update and
make technical corrections to certain statutes concerning the Vermont
Department of Libraries.

An act relating to the Department of Libraries

It is hereby enacted by the General Assembly of the State of Vermont:

Sec. 1. 3 V.S.A. § 260 is amended to read:

§ 260. LOCATION OF OFFICES

* * *

(c) ~~The principal office of each of the following boards and divisions~~
Division for Historic Preservation shall be located in Montpelier; ~~Division for~~
~~Historic Preservation and Board of Libraries.~~ The principal office of the Board
of Libraries shall be in Barre.

Sec. 2. 12 V.S.A. § 1699 is amended to read:

§ 1699. FOREIGN LAWS AND DECISIONS; DETERMINATION BY
COURT

The statutes, laws, and decisions of another state may be evidenced, prima facie, in the courts of this State by a printed copy thereof, which purports to be published by the authority of such other state, or which is kept in the State Library at ~~Montpelier~~ Barre. The determination of ~~such~~ the laws shall be made by the court and not by the jury, and shall be reviewable.

Sec. 3. 16 V.S.A. § 212 is amended to read:

§ 212. SECRETARY'S DUTIES GENERALLY

The Secretary shall execute those policies adopted by the State Board in the legal exercise of its powers and shall:

* * *

(7) Arrange conferences and summer schools for superintendents and teachers and employ suitable speakers, lecturers, and instructors for the same; fix the amount of tuition for the instruction; provide for educational gatherings, institutes, summer schools, and other supplementary educational activities; and provide for cooperation with the ~~Board of Libraries established by 22 V.S.A. § 602~~ State Librarian.

2 § 605. DUTIES AND FUNCTIONS OF THE DEPARTMENT OF
3 LIBRARIES

4 The duties and functions of the Department of Libraries shall be to provide,
5 administer, and maintain:

7 (2) A collection of ~~State documents and of documents relating to other~~
8 ~~states and local and federal governments~~ documents. It shall arrange for and
9 designate depositories of State documents which designation is to include
10 ~~Bailey~~ Howe Library at the University of Vermont. The Department may
11 acquire reports and documents published by federal agencies and by other
12 states and countries, and may arrange for the exchange of official reports and
13 publications with federal agencies, and with governmental agencies in other
14 states and countries.

16 (4) A general library collection of a sufficient size and scope to
17 reinforce and supplement the resources of local ~~and regional~~ libraries. All
18 materials of the Department of Libraries shall be available for free circulation
19 to all citizens, institutions, and organizations under regulations of the State

11 ~~contract for printing that, in case the matter contracted for is not delivered to~~

4 § 163. DUTIES OF THE AUDITOR OF ACCOUNTS

5 In addition to any other duties prescribed by law, the Auditor of Accounts
6 shall:

7 * * *

8 (4) From time to time, as audits are completed, report his or her audit
9 findings first to the Speaker of the House of Representatives and the President
10 Pro Tempore of the Senate, then to the Governor, the Secretary of
11 Administration, the Commissioner of Finance and Management, and the head
12 of the department, institution, or agency covered by the report. The audit
13 reports shall be public records and a copy of each report shall be furnished to
14 and kept in the ~~State Library~~ Vermont State Archives and Records
15 Administration for public use. Draft audit reports, working papers,
16 correspondence, and other materials relied on by the Auditor of Accounts to
17 produce the draft audit report shall be confidential and exempt from public
18 inspection and copying under the Public Records Act until the audit is
19 completed, but shall be provided to the audited entity upon request unless the
20 record is exempt from public inspection and copying under another provision
21 of law. Draft audit reports, working papers, correspondence, and other

1 materials received by an audited entity prior to completion of the audit shall
2 remain confidential until completion of the audit, and shall not be further
3 disclosed by the audited entity until completion of the audit.
