8	Statement of purpose of bill as introduced: This bill proposes to extend the
9	deadline for school district mergers ordered by the State Board of Education to
10	July 1, 2020.
11 12	An act relating to the extension of the deadline of school district mergers required by the State Board of Education
13	It is hereby enacted by the General Assembly of the State of Vermont:
14	Sec. 1. SCHOOL DISTRICT MERGERS; STATE BOARD OF
15	EDUCATION ORDER
16	Notwithstanding any provision to the contrary of 2010 Acts and Resolves
17	No. 153, 2012 Acts and Resolves No. 156, and 2015 Acts and Resolves No.
18	46, each as amended:

(1) Merger deadline extension.

1	(A) Mergers into a newly formed district. A school district that is
2	formed by order of the State Board of Education under 2015 Acts and Resolves
3	No. 46, Sec. 10, as amended, shall become operational on July 1, 2020. The
4	State Board of Education shall amend the default Articles of Agreement
5	included with the State Board's order to merge to accommodate this time
6	<u>frame.</u>
7	(B) Mergers into an existing district. The merger of a school district
8	into an existing district that is required by order of the State Board of
9	Education under 2015 Acts and Resolves No. 46, Sec. 10, as amended, shall be
10	effective on July 1, 2020; provided that a majority of the voters of the existing
11	district present and voting at an annual or special meeting warned for the
12	purpose approve the addition of that district to the existing district.
13	(2) Operations until merger. Until the merger under subdivision (1) of
14	this section becomes operational or takes effect, each school district that will
15	merge shall continue to operate and shall take such action as is necessary or
16	required by law to effect the merger.
17	(3) Draft Articles of Agreement. The school districts that are required
18	by the State Board order to merge into a newly formed district shall, on or
19	before July 1, 2019, form a committee with members appointed in the same
20	manner and number as required for a study committee under 16 V.S.A.
21	chapter 11 that shall draft Articles of Agreement for the newly formed district.

1	On or before October 31, 2019, the committee shall hold at least one public
2	hearing to consider and take comments on the draft Articles of Agreement.
3	(4) Approval of Articles of Agreement. The committee's draft Articles
4	of Agreement shall be submitted for approval by the voters of each school
5	district that is required by the State Board order to merge into a newly formed
6	district at an annual or special meeting warned for the purpose. If, on or before
7	March 31, 2020, the committee's draft Articles of Agreement are not approved
8	by a majority of the voters present and voting at a meeting warned for the
9	purpose of each school district that is required by the State Board order to
10	merge into the newly formed district, then the provisions in the State Board's
11	default Articles of Agreement shall apply to the newly formed district.
