6	Statement of purpose of bill as introduced: This bill proposes to make
7	amendments to Vermont laws pertaining to captive insurance companies and
8	risk retention groups.
9	An act relating to captive insurance companies and risk retention groups
10	It is hereby enacted by the General Assembly of the State of Vermont:
11	* * * Dividends; Distributions; Incorporated Protected Cells * * *

13	§ 6005. DIVIDENDS
14	No captive insurance company may pay a dividend out of, or other
15	distribution with respect to, capital or surplus without the prior approval of the
16	Commissioner. Approval of an ongoing plan for the payment of dividends or
17	other distributions shall be conditioned upon the retention, at the time of each
18	payment, of capital or surplus in excess of amounts specified by, or determined
19	in accordance with formulas approved by, the Commissioner. Notwithstanding

1	the provisions of 11B V.S.A. chapter 13, a captive insurance company or
2	incorporated protected cell organized under the provisions of Title 11B may
3	make such distributions as are in conformity with its purposes and approved by
4	the Commissioner.

12	limited liability company Subject to the approval of the Commissioner, a
13	captive insurance company may be formed as any type of entity permissible
14	under Vermont law.
15	(b) An agency captive insurance company may be incorporated as a stock
16	insurer with its capital divided into shares and held by the stockholders, as a
17	nonprofit corporation with one or more members, or as a manager-managed
18	limited liability company.
19	(c) An association captive insurance company, an industrial insured captive

2	and held by the stockholders;
3	(2) incorporated as a mutual corporation;

7	(d) A captive insurance company incorporated or organized in this State
8	shall have one or more incorporators or one or more organizers, at least one of
9	which shall be a resident of this State.
10	(e)(c) In the case of a captive insurance company:
11	(1)(A) Formed as a corporation, before the articles of incorporation
12	Before any required formation documents are transmitted to the Secretary of
13	State, the incorporators or organizers shall petition the Commissioner to issue
14	a certificate setting forth the Commissioner's finding that the establishment
15	and maintenance of the proposed corporation entity will promote the general
16	good of the State. In arriving at such a finding, the Commissioner shall
17	consider:
18	(i)(A) the character, reputation, financial standing, and purposes
19	of the incorporators or organizers;

1	(ii)(B) the character, reputation, financial responsibility, insurance
2	experience, and business qualifications of the officers and directors or
3	members of the governing board; and

10	Commissioner to issue a certificate setting forth the Commissioner's finding
11	that the establishment and maintenance of the proposed association will
12	promote the general good of the State. In arriving at such a finding, the
13	Commissioner shall consider the items set forth in subdivisions (1)(A)(i)-(iii)
14	of this subsection.
15	(3) Formed as a limited liability company, before the articles of
16	organization are transmitted to the Secretary of State, the organizers shall
17	petition the Commissioner to issue a certificate setting forth the
18	Commissioner's finding that the establishment and maintenance of the
19	proposed company will promote the general good of the State. In arriving at
20	such a finding, the Commissioner shall consider the items set forth in
21	subdivisions (1)(A)(i)-(iii) of this subsection.

- (k) Captive insurance companies formed as reciprocal insurers under the provisions of this chapter shall have the privileges and be subject to the provisions of chapter 132 of this title in addition to the applicable provisions of this chapter. In the event of a conflict between the provisions of chapter 132 and the provisions of this chapter, the latter shall control. However, in approving assessments levied upon subscribers of a captive insurance company formed as a reciprocal insurer, the Commissioner may exempt the company from any provision of sections 4850 (assessments), 4851 (time limit for assessments), and 4852 (aggregate of liability) of chapter 132. To the extent a reciprocal insurer is made subject to other provisions of this title pursuant to chapter 132, such provisions shall not be applicable to a reciprocal insurer formed under this chapter unless such provisions are expressly made applicable to captive insurance companies under this chapter. The Commissioner may exempt a company's attorney-in-fact from the provisions of section 4840 (attorney's bond) of chapter 132 if: (1) the reciprocal insurer is formed as an association captive: (2) each member of the reciprocal insurer qualifies as "industrial insured" pursuant to subdivision 6001(9) of this subchapter; or
- (3) the reciprocal insurer is an incorporated protected cell of a sponsored captive insurance company.

(c) No pure captive insurance company may make a loan to or an investment in its parent company or affiliates without prior written approval of the Commissioner, and any such loan or investment must be evidenced by documentation approved by the Commissioner. Loans of minimum capital and surplus funds required by section 6004 of this title are prohibited.

(g) This subsection establishes governance standards for a risk retention
group.
(1) As used in this subsection:

(C)(i) "Independent director" means a director who does not have a material relationship with the risk retention group. A person that is a direct or indirect owner of or subscriber in the risk retention group—or is an officer, director, or employee of such an owner and insured, unless some other position of such officer, director, or employee constitutes a "material relationship"—as contemplated under subdivision 3901(a)(4)(E)(ii) of the federal Liability Risk Retention Act, is considered to be "independent." A director has a material relationship with a risk retention group if he or she, or a member of his or her immediate family:

(i)(I) In any 12-month period, receives from the risk retention group, or from a consultant or service provider to the risk retention group, compensation or other item or items of value in an amount equal to or greater than five percent of the risk retention group's gross written premium or two percent of the risk retention group's surplus, as measured at the end of any fiscal quarter falling in such 12-month period, whichever is greater. This provision also applies to compensation or items of value received by any business with which the director is affiliated. Such material relationship shall continue for one year after receipt of the item or items of value is received or the compensation eeases or falls below the threshold established in this subdivision, as applicable.

I	(11)(11) Has a relationship with an auditor as follows: Is affiliated
2	with or employed in a professional capacity by a current or former internal or
3	external auditor of the risk retention group. Such material relationship shall
4	continue for one year after the affiliation or employment ends.
5	(iii)(aa) Has a relationship with a related entity as follows: Is
6	employed as an executive officer of another company whose board of directors
7	business entity that is affiliated with the risk retention group by virtue of
8	common ownership and control, if such entity meets all of the following
