- 13 (a) As used in this section:
- 14 (1) "Health insurance plan" means any health insurance policy or health
- 15 <u>benefit plan offered by a health insurer, as defined in 18 V.S.A. § 9402, but</u>
- 16 does not include a policy or plan providing coverage for a specified disease or
- 17 <u>other limited benefit coverage.</u>
- 18 (2) "Hearing aid" means an amplifying device or other hearing
- 19 instrument to be worn by an individual with a hearing impairment to improve
- 20 <u>hearing, including any accessories specifically used in connection with such a</u>

1	device, but excluding theater or auditorium wide-area listening devices,
2	telephone amplifiers, or other devices designed to replace a hearing aid for
3	restricted situations.
4	(3) "Hearing aid professional services" means services associated with
5	the practices of prescribing, fitting, dispensing, servicing, or selling hearing
6	<u>aids.</u>
7	(b)(1) A health insurance plan shall provide coverage for hearing aids and
8	hearing aid professional services that is at least equivalent to the coverage
9	provided in the Vermont Medicaid program. Coverage may be limited to the
10	hearing aid that is the most appropriate model that is medically necessary to
11	meet the patient's medical needs.
12	(2) Any dispute between an insured and a health insurer concerning
13	coverage and the application of this section shall be subject to independent
14	external review under section 4089f of this title.
15	(c) A health insurance plan may require prior authorization for hearing aids
16	and hearing aid professional services in the same manner and to the same
17	extent as prior authorization is required for any other covered benefit.
18	(d) A health insurance plan shall provide coverage under this section for
19	the medically necessary repair or replacement of a hearing aid.
20	(e) A health insurance plan shall not impose any annual or lifetime dollar
21	maximum on coverage for hearing aids that is less than the annual or lifetime

1	dollar maximum that applies generally to all terms and services covered under
2	the plan.
3	(f) The coverage required by this section shall not be subject to a
4	deductible, co-payment, or coinsurance provision that is less favorable to a
5	covered individual than the deductible, co-payment, or coinsurance provisions
6	that apply generally to other nonprimary care items and services under the
7	health insurance plan.
8	Sec. 2. EFFECTIVE DATE
9	This act shall take effect on January 1, 2020 and shall apply to all health
10	insurance plans issued on and after January 1, 2020 on such date as a health
11	insurer offers, issues, or renews the health insurance plan, but in no event later
12	than January 1, 2021.
