7	Statement of purpose of bill as introduced: This bill proposes to: (1) require
8	the Commission on Alzheimer's Disease and Related Disorders to produce an
9	assessment and State plan to overcome Alzheimer's Disease; (2) create a work
10	group to study and make recommendations pertaining to continuing education
11	requirements on the diagnosis, treatment, and care of patients with cognitive
12	impairments, including Alzheimer's disease and dementia; (3) allow physician
13	disclosure of diagnosis and treatment plans with patient's family with patient's
14	consent; and (4) require hospitals to adopt an operational plan for the
15	recognition and management of patients with dementia or delirium in acute
16	care settings.

An act relating to planning for the care and treatment of patients withcognitive impairments

1	It is hereby enacted by the General Assembly of the State of Vermont:
2	* * * Assessment and State Plan * * *
3	Sec. 1. ALZHEIMER'S DISEASE; ASSESSMENT AND STATE PLAN
4	(a) The Commission on Alzheimer's Disease and Related Disorders,
5	established pursuant to 3 V.S.A. § 3085b, shall develop and carry out an
6	assessment of all State programs that address Alzheimer's disease. The
7	Commission shall create and maintain an integrated State plan to overcome
8	Alzheimer's disease, which shall include implementation steps and
9	recommendations for priority actions based on the assessment. The purposes
10	of the State plan shall include to:
11	(1) accelerate the development of treatments that would prevent, halt, or
12	reverse the course of Alzheimer's disease;
13	(2) help coordinate the health care and treatment of individuals with
14	<u>Alzheimer's disease;</u>
15	(3) ensure the inclusion of ethnic and racial populations who have a
16	higher risk for Alzheimer's disease or are least likely to receive care in clinical,
17	research, and service settings, with the purpose of decreasing health disparities
18	in Alzheimer's disease;
19	(4) coordinate with federal government entities to integrate and inform
20	the fight against Alzheimer's disease;

1	(5) provide information and coordination of Alzheimer's disease
2	research and services across all State agencies; and
3	(6) implement a strategy to increase the diagnostic rate of Alzheimer's
4	disease in the State.
5	(b) On or before January 1, 2022, the Commission shall submit its
6	assessment and State plan to the Governor, the House Committees on Health
7	Care and on Human Services, and the Senate Committee on Health and
8	Welfare.

10	Sec. 2. CONTINUING EDUCATION ASSESSMENT; REPORT
11	(a) The Chair of the Commission on Alzheimer's Disease and Related
12	Disorders shall appoint three members of the Commission to serve as a work
13	group for the purpose of making recommendations on continuing education
14	requirements related to the diagnosis, treatment, and care of patients with
15	cognitive impairments, including Alzheimer's disease and dementia. The work
16	group shall consider continuing education requirements for physicians,
17	physician assistants, advanced practice registered nurses, registered nurses,
18	licensed practical nurses, and nursing assistants and appropriate training for
19	adult protective services caseworkers. In developing its recommendations, the
20	work group shall consult with the Vermont Medical Society, Vermont

1	Association of Hospitals and Health Systems, and other professional groups
2	relevant to the professions specified in this subsection.
3	(b)(1) The work group shall submit its findings and recommendations to
4	the full Commission on or before November 1, 2020.

15	To the extent permitted under federal law, a physician licensed pursuant to
16	26 V.S.A. chapter 23 or 33, upon express or implied consent of a patient
17	diagnosed with Alzheimer's disease, shall report the Alzheimer's diagnosis to
18	a family member of the patient or agent as defined in section 9701 of this title
19	and provide the family member or agent information about care planning
20	services, including assistance understanding the diagnosis; medical and

1	nonmedical options for treatment, services, and supports; and information
2	regarding how to obtain treatment, services, and supports.
3	§ 9202. HOSPITAL OPERATION PLAN
4	A hospital licensed pursuant to chapter 43 of this title shall implement an
5	operational plan for the recognition and management of patients with dementia
6	or delirium in acute care settings. The operational plan shall consider
7	applicable recommendations made by the Commission on Alzheimer's Disease
8	and Related Disorders, established pursuant to 3 V.S.A. § 3085b. Each
9	hospital's operational plan shall be completed on or before January 1, 2022 and
10	shall remain on file at the hospital and made available to the Department of
11	Health upon request.
