9	(2) the members and staff of an affected public body shall not be
10	required to be physically present at a designated meeting location; and
11	(3) an affected public body of a municipality may post any meeting
12	agenda or notice of a special meeting in two publicly accessible designated
13	electronic locations in lieu of the two designated public places in the
14	municipality, or in a combination of a designated electronic location and a
15	designated public place.
16	(c) When an affected public body meets electronically under subsection (b)
17	of this section, the affected public body shall:
18	(1) use technology that permits the attendance and participation of the
19	public through electronic or other means;
20	(2) whenever feasible, allow the public to access the meeting by
21	telephone; and

1	(3) post information that enables the public to directly access and
2	participate in meetings electronically and shall include this information in the
3	published agenda for each meeting.
4	(d) Unless unusual circumstances make it impossible for them to do so, the
5	legislative body of each municipality and each school board shall record any

(2) During a declared state of emergency under 20 V.S.A. chapter 1, a board of civil authority within a municipality affected by an all-hazard shall not be required to physically inspect any property that is the subject of an appeal. If the appellant requests in writing that the property be inspected for purposes of the appeal, a member or members of the board shall conduct the inspection through electronic means. If the appellant does not facilitate the inspection through electronic means, then the appeal shall be deemed withdrawn. (3) As used in this subsection, "electronic means" means the transmittal of video or photographic evidence by the appellant at the direction of the board members conducting the inspection.
