<u>Whereas</u>, challenging competition resulted in Drake Hull trailing by two shots with four holes to play, but sensing an extraordinary effort was required, he then birdied three of the final four holes and especially savored his welldeserved two-shot tournament victory, now therefore be it

Whereas, in one 2017 game, an injured Eric Maxham insisted on continuing, despite his father's concern, and the younger Maxham persevered to score the game's final goal, and

<u>Whereas</u>, one teammate commented that Eric Maxham was always assisting his teammates and admiringly described Eric as "a crazy player," and

Whereas, in October 2018, in a game against Bellows Falls Union High School, Eric Maxham scored his 112th career goal, in the form of a 45-yard free kick, setting a new State high school goal-scoring record, and he is only the fourth Vermonter to exceed the century-goal mark, and

Whereas, Scott Maxham described his son's record as unfathomable, and

<u>Whereas</u>, Eric Maxham's remarkable feats on the soccer field continued as he concluded his high school career with 128 goals and 69 assists and set a Golden Horde single-season record of 38 goals, and

Whereas, when the Golden Horde lost the 2018 Division IV championship, in a heartbreaking 1–0 overtime defeat to the Arlington Eagles, several of the opposing team's players made a special effort to console Eric Maxham as a sign of their deep respect for this talented athlete, and

<u>Whereas</u>, Scott Maxham, whose post-game decorum at the championship game won special praise from the *Rutland Herald*, is concluding his West Rutland coaching career with over 100 victories, now therefore be it

<u>Whereas</u>, after the Vikings bested the Redhawks in the opening set 25–20, CVU sharpened its focus to win the following three sets 25–21, 25–22, and an overpowering 25–11 to win its third consecutive State crown, and CVU's three-season record now stands at 40 wins and one defeat, and

<u>Whereas</u>, women are encouraged to commit to making physical activity and healthy eating a priority to improve heart health, and

<u>Whereas</u>, the American Heart Association's Go Red for Women campaign motivates women to learn their family medical history and meet with a health care provider to determine their risk for cardiovascular diseases and stroke, and

<u>Whereas</u>, Go Red for Women encourages women to take charge of their heart health by knowing their total cholesterol levels, including HDL—or good—cholesterol, blood sugar levels, blood pressure, and body mass index, and

<u>Whereas</u>, Wear Red for Women Day publicizes the important educational mission of the Go Red for Women campaign, now therefore be it

Whereas, Hunger Free Vermont reports that 15 percent of the State's children under 18 years of age live in food-insecure households, and

<u>Whereas</u>, this stark reality places great importance on elementary and secondary schools providing students opportunities to eat nutritious meals, and

Whereas, 2007 Acts and Resolves No. 24 established the Rozo McLaughlin Farmto-School Program "to award local grants for the purpose of helping Vermont schools develop relationships with local farmers and producers," and

Whereas, the Rozo McLaughlin Farm-to-School Program enables elementary and secondary students to eat healthy foods, establishes partnerships between Vermont's farmers and local schools that are economically advantageous to the agricultural community, and introduces a new and healthy culinary culture into the State's school cafeterias, and

Whereas, according to a report that the Center for Rural Studies and the Department of Community Development and Applied Economics at the University of Vermont prepared with the Vermont Farm to School Network, every dollar spent in Vermont's schools on local food contributes an additional 60 cents to the local economy, and

<u>Whereas</u>, data from the Vermont Agency of Agriculture, Food and Markets documented that, between 2007 and 2018, the program had served over 65,000 students and children, affecting 163 schools and 22 child care programs, and

<u>Whereas</u>, the U.S. Department of Agriculture's Farm to School Census found that schools participating in farm-to-school programs reported twice the national average in vegetable consumption, and

Whereas, according to the Vermont Department of Health, consuming a poor diet is one of three behaviors that lead to four categories of disease that result in more than 50 percent of the deaths in Vermont: cancer, heart diseases and stroke, type 2 diabetes, and lung disease, and

<u>Whereas</u>, students who are involved in farm-to-school programs improve their immediate dietary routine and learn the importance of practicing healthy nutritional habits for the long term, and

<u>Whereas</u>, the Rozo McLaughlin Farm-to-School Program participants are visiting the State House today to remind legislators of its important economic and nutritional benefits, now therefore be it

Resolved by the Senate and House of Representatives:

That the General Assembly designates February 6, 2019 as Farm-to-School Awareness Day at the State House, and be it further

Whereas, Judge Francis McCaffrey, known to friends as Mac, was a man of great compassion and wisdom, and

Whereas, he demonstrated a great empathy for individuals whose daily challenges might appear insurmountable, and

Whereas, as a youth in New York City, Francis McCaffrey earned both a high school diploma and an All-NYC basketball player designation, and

Whereas, at Saint Michael's College, his basketball prowess contributed to the Purple Knights' appearance in an NCAA Final Four championship game, and

Whereas, Francis McCaffrey was inducted into the Vermont and the New England Basketball Hall of Fame and passed on his basketball enthusiasm to his children, and

Whereas, after graduating from Saint Michael's College, he earned a law degree from Fordham University Law School and then practiced law in New York City, Manchester, New Hampshire, and, ultimately, Rutland, and

Whereas, Francis McCaffrey's legal acumen surpassed his basketball prowess as he was selected to serve as a Vermont trial court judge and was later appointed the administrative judge for the trial court system, and

Whereas, although he presided over notable trials, Judge Frances McCaffrey believed a judge should never become the focus of judicial proceedings, and

Whereas, Judge Francis McCaffrey's most enduring contribution to the Vermont judiciary was perhaps presiding in the Rutland Drug Treatment Court after he retired, a role to which he brought judicial experience, legal expertise, and a genuine concern for the victims of drug addiction, and

Whereas, Francis McCaffrey practiced his deep faith through his membership in the Immaculate Heart of Mary Parish and close association with the Weston Priory, and this same faith prompted his roles as a founding member of Serenity House, a training teacher in the Thresholds Decision Program, and an avid supporter of his wife's pioneering leadership of Dismas of Vermont, and

Whereas, the illustrious life of Judge Francis McCaffrey ended on October 27, 2018, and his survivors include his beloved wife, Rita, their children and grandchildren, *now therefore be it*
