H.C.R. 67

House concurrent resolution designating Tuesday, March 19, 2019 as Project Trio Day at the State House

Offered by: All Members of the House

Offered by: All Members of the Senate

<u>Whereas</u>, promoting the college prospects of financially disadvantaged students is the laudable goal of the federal TRIO programs, and in Vermont these important academic preparatory programs serve many students, and

<u>Whereas</u>, Upward Bound, the original federally financed, college incentive program for disadvantaged students, was established under the auspices of the Economic Opportunity Act of 1964, and

<u>Whereas</u>, Talent Search, the second program, initially authorized by the Higher Education Act of 1965, assists students early in the college admissions and financial aid process, and

Whereas, as part of the federal Education Amendments of 1968, the third program, now known as Student Support Services, was established, and

Whereas, these three special programs for students from low-income backgrounds became known informally as TRIO, and

<u>Whereas</u>, the Higher Education Amendments of 1972 authorized the development of Educational Opportunity Centers, and the Education Amendments of 1976 authorized the Training Program for Federal TRIO Programs, and

Whereas, during the 1970s, a new component known as Veterans Upward Bound was established to offer support to veterans pursuing a postsecondary education and to assist them with the academic and personal skills required for college admission, and

<u>Whereas</u>, federal legislation in 1986 established the Ronald E. McNair Postbaccalaureate Achievement Program and, in 1990, the Department of Education established the Upward Bound Math/Science program, and

Whereas, in 1992, Congress codified and unified the authorization of the federal TRIO programs in 20 U.S.C 1070a–11, and

<u>Whereas</u>, in 2019, the TRIO federal education programs continue to provide an essential gateway for aspiring college students in Vermont and nationwide who might not otherwise gain college admission, now therefore be it

Whereas, in 1919, Vermont dairy farmers recognized that ensuring the best possible price for their milk required pooling their production and marketing resources, and in the small town of Cabot, a group of 94 dairy farmers implemented this idea and established the Cabot Creamery Co-operative (the Co-operative), and

Whereas, until the 1930s, the Co-operative's primary product was Rosedalebranded butter, and during that decade the first cheese-making equipment was installed at the creamery, enabling the production of cheddar and cottage cheese, and in the 1980s, the Rosedale brand was retired and the Cabot brand, now so closely associated with the Co-operative, served as its replacement, and

<u>Whereas</u>, in 1989, the Co-operative earned a first-place award in the cheddar category at the U.S. Championship Cheese Contest, initiating a flurry of national and international prizes that continues to this day, and

<u>Whereas</u>, although the Co-operative merged with Agri-Mark Dairy Co-operative, the Cabot brand remains strong, and the direct, historic tie to the farmers who established the Co-operative continues, and

<u>Whereas</u>, today, the Co-operative is owned by over 800 dairy farm families located in New England and New York State, and over 600 persons are Vermont-based Cabot employees working at manufacturing plants in Cabot and Middlebury, a productaging warehouse in St. Albans, and an administrative center in Waitsfield, and approximately 300 individuals are employed outside Vermont, predominately in Massachusetts and New York, and

Whereas, the Co-operative is proud of its numerous partnerships, beginning with its marketing collaboration with Vermont's ski areas and continuing with its current associations with over 4,000 nonprofit organizations for which Cabot employees volunteer their time and expertise, and

Whereas, during the past three decades, the Co-operative has invested \$228 million in Vermont for plants and equipment, and in 2018, the combined domestic and international sales of cheese, butter, and yogurt products totaled \$925 million, a strong start for its second century, now therefore be it

<u>Whereas</u>, dairy farmers have sought to introduce a degree of stability into their business operations through the establishment of producer cooperatives, and

Whereas, in 1919, the St. Albans Cooperative Creamery (the Cooperative) was formed, ensuring that its member farmers would not be bidding against each other or traveling long distances only to discover that potential purchasers no longer needed their milk, and

<u>Whereas</u>, the cooperative's over 350 dairy farms—located in Vermont, New York, and New Hampshire—produce more than a billion pounds of milk annually, and

Whereas, the economic impact of the Cooperative is significant to Franklin County, the State of Vermont, and beyond, and

<u>Whereas</u>, its manufacturing plant separates and processes milk into cream, condensed skim milk, and dry milk powder that ultimately are incorporated into butter, cheese, ice cream, yogurt, and other dairy products, and

<u>Whereas</u>, the Cooperative's state-of-the art laboratory performs quality-testing services required for producer payments and analyzes the products made at the manufacturing plant, and

Whereas, its store offers a wide selection of products for dairy farmers and nonmembers, as well as a delivery service right to a producer's farm, and

<u>Whereas</u>, the leadership of the Cooperative has worked diligently to ensure that the membership maintains access to milk markets through the ever-changing dairy sector, and

<u>Whereas</u>, the Cooperative's dairy farmer members are truly the reason that the St. Albans Cooperative has been operating for 100 years, and

Whereas, in 2019, the Cooperative is celebrating a century of strengthening the Vermont dairy community and contributing to our State's agricultural economy, both important roles that will continue as the organization begins its second century of operations to support its valued dairy farmer members, now therefore be it

<u>Whereas</u>, with ambitions for a career beyond the farm, Dennis LeBlanc enrolled at the University of Vermont, from which he graduated in 1972, the same year he and his wife, Cindy, a dental hygienist and also a UVM graduate, were married, and

Whereas, having decided to become a dentist, Dennis LeBlanc and Cindy moved to Philadelphia, where he entered Temple University School of Dentistry, and

<u>Whereas</u>, in 1976, with his newly awarded dental degree in hand, Dr. Dennis LeBlanc and Cindy LeBlanc headed home to the Northeast Kingdom, where Dennis LeBlanc intended to commence the practice of dentistry, and

Whereas, he worked in the dental office of Dr. George Leland in Orleans, gaining important practical experience as well as expert advice, and

<u>Whereas</u>, in 1977, now ready to venture out on his own, Dr. LeBlanc decided to open a practice in the Taylor Moore Building on Main Street in Derby, a town where he already had many acquaintances, and

<u>Whereas</u>, his talent as a dentist became well known, and the practice expanded, resulting in his 1998 purchase of a house, conveniently located on Derby's Main Street, which offered more office space, and

<u>Whereas</u>, perhaps unique among Vermont's dentists, Dr. Dennis Leblanc is a former Vermont Golden Gloves boxer, and he trained noted amateur boxer, Tony Robitaille, and later served on the former Vermont Boxing Control Board, and

Whereas, after 43 years of serving as Derby's dependable dentist, Dr. Dennis LeBlanc has turned over the practice to a carefully selected professional colleague,

and he and his wife are anticipating spending more time with their children and grandchildren, and traveling, now therefore be it

<u>Whereas</u>, seventh-generation Vermonter Shirley Searles Squires was born in Brattleboro and since 1941 has resided in Guilford, in a house that her father and uncle constructed, where she is a pillar of the community, and

<u>Whereas</u>, when she was 18 years of age, she married Maynard Squires, and they became the parents of a large family, which now includes a great number of grandchildren and great-grandchildren, and

Whereas, in 1990, her son, Ronald, was elected to represent the towns of Guilford and Vernon in the House of Representatives, and

<u>Whereas</u>, as the first openly gay member of the Vermont General Assembly, Ronald Squires's personal initiative and leadership were instrumental in the pioneering enactment of 1992 Acts and Resolves No. 135, An act relating to discrimination on the basis of sexual orientation, and

Whereas, in January 1993, shortly after being sworn in for a second term, former Representative Ronald Squires died of AIDS, and

Whereas, Shirley Squires turned her grief into action and became a passionate advocate for victims of AIDS, and

Whereas, for 26 years, Shirley Squires has marched in the annual Southern Vermont AIDS Walk, an event in memory of individuals who have died from HIV-related illnesses, and her efforts have raised over \$350,000 for the AIDS Project of Southern Vermont, and

 $\underline{Whereas},$ she is actively associated with the Brattleboro Area Hospice and Guilford Cares, and

Whereas, Shirley Squires's religious faith is of paramount importance to her and sustained her through the immediate aftermath of her son's death, and

Whereas, St. Michael's Catholic Church in Brattleboro plays a great role in her life, and she offers communion to home-bound parishioners, and

<u>Whereas</u>, Shirley Squires has collected approximately 1,600 Christmas nativities from around the world, welcomes the public to view the collection, and provides a basket in which visitors can place donation to the AIDS Project of Southern Vermont and the Brattleboro Area Hospice, and

Whereas, as a member of the Yellow Ribbon Group, she participated in sending care packages to U.S. military personnel stationed in Iraq and Afghanistan, now therefore be it

<u>Whereas</u>, before refrigeration was available, local farmers would gather at Sunset Lake in Brookfield to harvest ice, and

<u>Whereas</u>, throughout January, strenuous efforts were made to plant an ice boom to haul out large blocks of ice, keep the ice clear, and create a channel in the lake to serve as a conduit for the ice, and

<u>Whereas</u>, in addition to local sales, Brookfield maintained a contract with the Central Vermont Railroad, which purchased blocks of ice for maintaining the cold temperature of milk en route to Boston, and

Whereas, once the train arrived in Boston, the ice blocks were sold to local icemen who in turn sold them to area customers, and

<u>Whereas</u>, Al Wilder is a Norwich University graduate and a 21-year U.S. Army veteran and concluded his military service as an advisor to the Vermont Army National Guard, and

<u>Whereas</u>, after his military discharge, Al Wilder owned the first self- service gasoline station in central Vermont, and for many years, he has resided on a hill overlooking Sunset Lake, and

Whereas, one day in 1978, he heard a noise on the lake and discovered that an ice harvesting demonstration had attracted a crowd of at least 50 persons, and

Whereas, thinking it would be fun to repeat this event, Al Wilder obtained saws and other equipment, mostly from the owners of local barns, and

<u>Whereas</u>, in 1980, on the last Saturday in January, while Al Wilder and his late wife, Jackie, owned the Fork Shop Restaurant, he organized the first Brookfield Ice Harvest at the Floating Bridge, and

Whereas, Al Wilder's ice harvest garnered much attention, and this annual event is eagerly anticipated every January, and

<u>Whereas</u>, Al Wilder remained the ice harvest's primary organizer for over 30 years, and although he has now relinquished this role, he remains closely associated with this annual winter celebration, now therefore be it

Whereas, as a pharmacy preceptor, The Pharmacy has mentored over a dozen pharmacy students, who were studying to enter the profession, and

<u>Whereas</u>, The Pharmacy achieved the distinct honor of being the first Vermont pharmacy to be awarded the coveted designation of Fellow of the American College of Apothecaries, and

<u>Whereas</u>, on multiple occasions, The Pharmacy has won the People's Choice Award for Outstanding Pharmacy in the Bennington area, and

<u>Whereas</u>, The Pharmacy has provided financial support to many worthy nonprofit organizations, and

Whereas, The Pharmacy's financial generosity was an important factor in both Philip O'Neill and Edward Molloy receiving the Bowl of Hygeia Award in recognition of their outstanding records of exemplary community and civic leadership, and

Whereas, The Pharmacy Northshire is the retailer's branch store in Manchester, and

<u>Whereas</u>, Edward Molloy retired in 2013, but Philip O'Neill remains an active pharmacist who operates The Pharmacy with the support of a great professional and administrative staff, now therefore be it

<u>Whereas</u>, maximizing the ability for older Vermonters to remain residents in their own homes is a public policy goal with broad appeal, and

Whereas, starting in the late 1970s, a new approach to meeting this worthy objective was introduced through the establishment of adult day care centers, and

<u>Whereas</u>, the Bennington Elderly Action Committee secured State financing to establish Bennington Project Independence (BPI), which was incorporated in 1978 and opened in the basement of a local Baptist church in September 1979, and

<u>Whereas</u>, the founders of BPI were Beth Cheadle, Reverend Kenneth Costin, Dale Loomis, Joseph LoPiccolo, Virginia North, John Powell, Claire O'Leary, Mary Seidel, William F.D. Smith, Joseph Thorpe, and David Vilner, and

Whereas, BPI provided daytime on-site support services to both older area residents and younger adults with disabilities, and

<u>Whereas</u>, the original location soon proved inadequate to meet BPI's expanding needs, and in 1982 it moved to the Bennington Senior Citizens Service Center building, which also soon proved too confining, and

<u>Whereas</u>, a larger and more creatively designed headquarters, with the potential for future growth, was needed, and

Whereas, as the result of the extraordinary generosity of Lillian Seward, phase one of the Dr. Richard A. Sleeman Center opened its doors in 2009, and it constituted both a memorial to Lillian Seward's brother and the realization of BPI's dream for a more durable and accommodating home, and

Whereas, the center is a meticulously designed state-of-the art facility that provides exceptional care in a homelike environment, and

Whereas, BPI now serves approximately 50–55 persons per day, and potential future expansion will enable that number to increase, and

<u>Whereas</u>, brain injuries can occur unexpectedly and instantaneously and can result in cognitive, emotional, and physical challenges that may last a lifetime, and

<u>Whereas</u>, the Brain Injury Association of America estimates that 3.5 million Americans, including both children and adults, annually sustain brain injuries, while the organization's local affiliate, the Brain Injury Association of Vermont, estimates that 10,000 Vermonters have long-term challenges related to brain injury, and

<u>Whereas</u>, brain injuries may result from an infection, a lack of oxygen, a stroke, a brain tumor, or as a ramification of a drug overdose, and

<u>Whereas</u>, a subcategory of brain injury is traumatic brain injury, which can be precipitated by an external event such as an assault, an automobile accident, a fall, or a sports-related injury, and

<u>Whereas</u>, the Brain Injury Association of Vermont has compiled data that indicate that 4,500 Vermonters annually sustain traumatic brain injuries, and

<u>Whereas</u>, the best hope for a person to resume normal living and work activities after sustaining a brain injury is to seek medical attention as soon as possible, and

<u>Whereas</u>, the Brain Injury Association of Vermont offers educational and support programs, including intake and referral services, at no charge, and

<u>Whereas</u>, it specifically makes available the web-based Vermont School Concussion Management Toolkit that provides informative digital resources to school athletic officials, coaches, student athletes, and parents, and

<u>Whereas</u>, the Brain Injury Association of America has designated March as Brain Injury Awareness Month, and Vermont legislative recognition of this important health issue will increase Vermonters' awareness of brain injuries, now therefore be it

<u>Whereas</u>, in 1962, he settled in Northfield, beginning an extraordinary 55-year faculty career at Norwich University, interrupted only for his completion of a doctoral degree in engineering science from Columbia University, and concluding with his retirement in 2017 at 83 years of age, and

<u>Whereas</u>, Don Wallace served his hometown as a dedicated and effective public servant whose endeavors touched diverse aspects of the community, and

Whereas, for 26 years, he volunteered as an emergency medical technician with the Northfield Ambulance Squad, helping those in need of immediate medical assistance, and

Whereas, from 1986 until 2001, Don Wallace was the Northfield representative to the Central Vermont Solid Waste Management District, and in this role he was instrumental in the development of the town's waste reduction program and the construction of a local transfer station and directed the community's annual Green-Up Day activities, and

<u>Whereas</u>, for a term that extended from 1999 until 2008, Don Wallace's intelligence and unique perspective on municipal management were important factors in the deliberations of the Northfield Selectboard on which he served, and

<u>Whereas</u>, mountaineering was a lifelong passion of Don Wallace's, which he first experienced as a youth on family excursions, and

<u>Whereas</u>, Don Wallace was the fourth person to summit all 115 of the high peaks in the northeast, and he summited the high points in all 50 states, including the extremely challenging Denali in Alaska, and

<u>Whereas</u>, this true Norwich University don and respected citizen of Northfield died, at 84 years of age, on November 18, 2018, and his survivors include his companion, Mary Bellinzier, and his children, now therefore be it

<u>Whereas</u>, Dan Roberts's firefighting colleagues know they can rely on him to assist in any role, be it entering a burning building to fight a fire, dousing countless chimney and brush fires or, on happier notes, helping to flood the Tunbridge Central School's skating rink for its annual ice surfacing and hiding eggs for the department's Easter egg hunt, and

Whereas, his service as the department's deputy chief extended "at least" 15 years, and

<u>Whereas</u>, former Tunbridge Fire Chief Brenda Field recollected that if a "challenging or, in particular, physically overwhelming" task was at hand, "Dan was the man," and Tunbridge's lack of a hydrant system is illustrative of this, and

<u>Whereas</u>, Brenda Field told the story about how Dan Roberts met the challenge to move the "heavy portable pump, suction hose, strainer, gas can and rolls of supply hose down to the river" on a subzero night when the ground was buried under three feet of snow, and

<u>Whereas</u>, Dan Roberts's dedication to serving the Town of Tunbridge at all hours of the day and night is admirable and an excellent example for others to emulate, now therefore be it

<u>Whereas</u>, in 1970, as a newly minted sergeant, Larry Wade was assigned to "King Troop" and was responsible for leading the Bureau of Criminal Investigation, and in 1978, he was placed in charge of the newly formed fire investigation unit where he remained until retiring, as a captain, in 1986, and

<u>Whereas</u>, Larry Wade graduated from the FBI National Academy, helped develop the arson course curriculum that the National Fire Academy adopted for its instructional program, and won numerous professional honors, and

<u>Whereas</u>, from 1987 until 1998, his many friends in the Vermont General Assembly knew Larry Wade as the always professional and courteous Assistant Sergeant at Arms and Head Doorkeeper, roles he served with distinction and pride, and

<u>Whereas</u>, Larry Wade belonged to many fraternal organizations, was a member of the Barre Congregational Church, and served as a justice of the peace in both Barre City and Barre Town, and

<u>Whereas</u>, while recently residing at Woodridge Rehabilitation and Nursing in Berlin, he held leadership roles on its resident council and, despite his blindness, dictated a memoir, *Memories of Putney*, which was later published, and

<u>Whereas</u>, on January 29, 2019, Larry Wade died at 87 years of age, and his survivors include his children, grandchildren, and great-grandchildren, now therefore be it
