Whereas, Frank Fressie has distinguished himself in combat and both as an educator and an elected official in his local community of Poultney, and

Whereas, as a member of the U.S. Navy during World War II, he arrived in Nagasaki, Japan, shortly after the atomic bomb had been dropped, and during the Korean War, Frank Fressie returned to military service as a U.S. Marine, was wounded, and received a Purple Heart, and

<u>Whereas</u>, Frank Fressie graduated from the State University of New York at Binghamton, earned his master's degree at the State University of New York at Albany, Williams College awarded him a doctorate, and he studied in Torino, Italy, as a Fulbright Scholar, and

Whereas, his several high school principalships included, most notably, Poultney High School where a new school gymnasium was constructed during his tenure, and he served as interim superintendent for the Rutland Southwest Supervisory Union from May 1983 through May 1984, and

Whereas, the Poultney electorate knew Frank Fressie as a person capable of successfully completing a challenging assignment, and it elected him to serve as a town lister from 1994 until 2004, during which time two town reappraisals were conducted, and

Whereas, with his outstanding record as an educator and as a lister, Frank Fressie was a compelling candidate to serve on the Poultney Selectboard, where he thoughtfully carried out his duties from 2008 until March 2019, and

<u>Whereas</u>, Frank Fressie's military history proved to be an invaluable resource in his leadership of a veterans' peer group at the White River Junction VA Medical Center, and

 $\underline{\text{Whereas}}$, he offered wise and practical advice in his role as an AARP defensive-driving instructor, and

Whereas, the American Cancer Society is an organization with which Frank Fressie was an active volunteer, and

Whereas, he enjoys golfing, fishing, and hunting are all recreational pursuits that he enjoys, and

Whereas, Town Meeting Day 2019 marked the conclusion of Frank Fressie's outstanding public service in Poultney's municipal government, now therefore be it

Whereas, in 1980, he formed the Medicine Chest, a home-based business dedicated to sales to doctors and hospitals of reasonably priced medical supplies and equipment, and

Whereas, in 1988, Frank Buonincontro decided to open his own retail store, establishing the Marble Works Pharmacy in Middlebury's historic locale, and

Whereas, his entrepreneurial daring was evident, as, unlike in 2019, minimal commercial activity existed in the area, and

Whereas, the Marble Works Pharmacy evolved into a popular destination for the purchase of medications and associated products, especially because Frank Buonincontro offered his customers friendly and highly professional service, and they appreciated that the pharmacy was open on Sundays, and

Whereas, Marble Works Pharmacy's retailing success led Frank Buonincontro to open drugstores in Bristol and Vergennes, and

Whereas, for eight years, Frank Buonincontro cohosted the *Over the Counter* medical information radio show on Middlebury's WFAD, and

<u>Whereas</u>, he served on the boards of both Counseling Service of Addison County and Hospice Volunteer Services, volunteered with the Meals on Wheels organization, and flew his own Cessna 172 aircraft, and

Whereas, Frank Buonincontro and his wife, Sue, have been married for 56 years and are the parents of five and the grandparents of eight, and on Saturday, March16, 2019, Frank Buonincontro is being honored at a celebration of hospice programs at the Middlebury Inn, now therefore be it

Whereas, social workers support and empower people, helping them to acquire the ability to solve problems, cope with personal roadblocks, and obtain the resources they need to succeed, and

Whereas, these talented professionals are deeply immersed in our society, being active in government, local communities, schools, social service agencies, universities, health and mental health organizations, the U.S. military, corporations, and the private sector, and

Whereas, social workers are the largest group of mental health service providers in the United States, and the U.S. Department of Veterans Affairs is one of the biggest employers of social workers with advanced degrees, and

Whereas, social workers help individuals process through issues such as death, grief, trauma, epidemics, environmental pollution, and natural and human-caused disasters, and

Whereas, for decades, social workers have been in the forefront of social justice issues, advocating for equal rights for women, African Americans, Latinx, persons with disabilities, the LGBTQ community, and various ethnic, cultural, religious, and social groups, and

Whereas, for more than a century, the social work profession has been helping create changes to make our society a better place to live, and

Whereas, social workers continue to bring individuals, communities, social service agencies, and governments together to help society solve some of the most pressing issues of the day, now therefore be it

Whereas, Alzheimer's disease is a "type of dementia that causes problems with memory, thinking and behavior," and

Whereas, it is the sixth-leading cause of death in the nation and the fifth-leading cause for persons 65 years of age or older, and Vermont has the country's highest Alzheimer's death rate, and

Whereas, from 2000 to 2017, the national heart disease death rate decreased nine percent, but in the same time period, the comparable national rate for Alzheimer's increased 145 percent, and since 2000, Vermont has seen an increase of 176 percent, and

Whereas, 13,000 Vermonters, 65 years of age or older, are living with Alzheimer's disease or a related form of dementia, and

Whereas, annually, 30,000 Vermonters provide an estimated 34 million hours of unpaid Alzheimer's care valued at \$434 million, and

Whereas, the Alzheimer's Association estimates that, nationally, 16 million Americans provide uncompensated care for an estimated 18.5 billion hours that is valued at \$234 billion, and

Whereas, caring for a person with any form of dementia, including Alzheimer's, can be emotionally, financially, and physically challenging, and

Whereas, a 2015 Alzheimer's Association report found that more than 50 percent of persons with Alzheimer's are not informed of their diagnosis, and

Whereas, in 2019, total Alzheimer's-related costs are estimated at \$290 billion, and this figure could potentially reach \$1.1 trillion by 2050, and

Whereas, today, individuals whose lives Alzheimer's directly impacts, as well as persons dedicated to improving public awareness of Alzheimer's and finding a cure, are visiting the State House, now therefore be it

Resolved by the Senate and House of Representatives:

That the General Assembly designates Friday, March 29, 2019 as Alzheimer's Awareness Day at the State House, and be it further

Whereas, in 1984, at 37 years of age, Edie Bell decided to resume her previously interrupted college education, enrolling at Lyndon State College (LSC) as an English major, and she proved to be an excellent student, and

Whereas, at graduation, she delivered one of the commencement addresses and was granted membership into the Arthur B. Elliot Honor Society, the highest honor LSC bestows on a graduate, and

Whereas, while studying at LSC, she met and married professor Robin Brown, and when Southern Illinois University appointed him its art department faculty chair, the couple moved and

Whereas, Edie Bell-Brown took advantage of her new college abode, pursuing a master's degree in English, and she was presented an honors convocation award and inducted into the Phi Kappa Phi Honor Society, and

Whereas, after her husband died in 1999, Edie Bell-Brown returned to Lyndon and embarked on a fulfilling two-decade odyssey of teaching, community service, and political activism, and

Whereas, she taught English part-time at LSC and tutored adult learners enrolled in Johnson State College's External Degree Program, and

Whereas, Edie Bell-Brown's love of literature and poetry proved ideal for her sixyear tenure as president of the Friends of the Cobleigh Public Library in Lyndon, and

Whereas, since 2014, she had served as a Lyndon Justice of the Peace, and

Whereas, Edie Bell-Brown became an unabashed activist in the Democratic Party, serving as vice chair and treasurer of the Lyndon Town Democratic committee, in several posts on the Caledonia County Democratic committee, as Caledonia County's representative to the Vermont State Democratic committee, and she ran for her local seat in the House of Representatives, and

Whereas, after a long battle with cancer, Edie Bell-Brown died at 71 years of age on December 11, 2018, leaving many close friends who now cherish her memory and her good works, now therefore be it

Whereas, during her tenure, VEDA's total financial assets increased from \$65 million to \$300 million, and

Whereas, in 1997, she was instrumental in transitioning VEDA into a private funding mechanism, enabling it to borrow its lending funds in the capital markets and use the financial moral obligation of the State, and

Whereas, Jo Bradley's leadership was essential for the creation of VEDA's entrepreneurial loan fund and technology loan fund, and

Whereas, she facilitated expanded funding for agricultural and small business projects as well as a sizable increase in the percentage of the VEDA portfolio dedicated to renewable energy projects, and

<u>Whereas</u>, federal financial support for VEDA was maximized, in part, due to Jo Bradley's foresight and knowledge of available opportunities, and

Whereas, during the major economic downturn in 2008 and 2009, VEDA initiated a Vermont economic recovery and opportunity program that dispensed \$69 million in loans, issued with the lowest interest rates in VEDA's history, and

Whereas, the economic support VEDA granted in the wake of Tropical Storm Irene was swift and nearly heroic, and

<u>Whereas</u>, after 22 years of superb leadership that earned her the respect of her professional peers, Jo Bradley is stepping down as chief executive officer of VEDA, now therefore be it
