House concurrent resolution honoring William Eugene Griffin on the completion of an extraordinary career as the Vermont Chief Assistant Attorney General

Whereas, in 1957, recognizing that the lawyers in the Attorney General's office work for an elected official, the General Assembly established the classified position of Chief Assistant Attorney General, for whom political considerations would be irrelevant, and

Whereas, Bill Griffin graduated from the University of Western Ontario in 1965 and in 1968 earned his law degree at Northwestern University School of Law, and

Whereas, his more than half century as a lawyer in public service began in San Francisco, where he worked for the Neighborhood Legal Assistance Program and for the city's Economic Opportunity Council, and

Whereas, in 1970, Bill Griffin, who is an ardent skier, and his wife, Pat Griffin, moved to Vermont, purchasing an old Calais homestead, which they restored, and they farmed its adjacent land, and

Whereas, he began his Vermont legal career as an assistant Attorney General and then worked in other State offices, and

Whereas, in 1980, Attorney General John Easton appointed Bill Griffin as the office's Civil Division Chief and in 1981 named him as the Chief Assistant Attorney General, and

Whereas, Bill Griffin has served the State of Vermont in this role with dignity, wisdom, humor, and always calm, independent legal judgement, and

Whereas, Bill Griffin has served seven Attorneys General, defended numerous State laws, including cases protecting the integrity of the legislative process, recovered millions of dollars for environmental clean-ups, written advisory opinions on a broad scope of issues, and for 26 years chaired the judiciary's Civil Rules Committee, and

Whereas, as a lover of opera, he studied Italian in Italy, and

Whereas, in recognition of his service to the State of Vermont, a commendation that all living Attorneys General and Governors of Vermont have signed is being presented to Bill Griffin with much gratitude, now therefore be it

Resolved by the Senate and House of Representatives:

That the General Assembly honors William Eugene Griffin on the completion of an extraordinary career as the Vermont Chief Assistant Attorney General, and be it further

#### H.C.R. 141

House concurrent resolution congratulating the Capitol Police on the department's 20th anniversary

Offered by: Representative Kitzmiller of Montpelier

Whereas, in 1972, Ray H. Quero was appointed as the first State House Security Officer, and

Whereas, by the late 1990s, as security concerns were increasing at the State House, the General Assembly determined it prudent to protect the legislative premises with its own full-time police force, and

Whereas, to meet this emerging need, in the 1999 Capital Bill, the General Assembly created the Capitol Police Department, under the jurisdiction of the Sergeant at Arms, and

Whereas, in accordance with this new statutory provision, codified as 2 V.S.A. § 70, "[a] Capitol Police officer shall have all the same powers and authority as sheriffs and other law enforcement officers anywhere in the State," and

Whereas, the Sergeant at Arms appointed David Alan Janawicz, a graduate of the Vermont Police Academy, as the force's first chief, and

Whereas, under his leadership, the Capitol Police gained the respect of the General Assembly's members and staff and expanded in size and technical sophistication, and

Whereas, in 2008, following David Janawicz's death, the Sergeant at Arms appointed Leslie Robert Dimick, a veteran of the Hardwick Police Force, a graduate of the U.S. Army Military Police Academy, and a veteran Capitol Police officer as the second Capitol Police Chief, and he continued and improved upon the excellent work of his predecessor, and

Whereas, most recently, upon Leslie Dimick's retirement, the Sergeant at Arms appointed law enforcement veteran Matthew Romei, a graduate of Norwich University, as the third Capitol Police Chief, and he has the able support of Sergeant Dale Manning and officers Brian Hoar, Jason Gould, Sara Quesnel, and Kurt Snyder, and

Whereas, in 2019 the Capitol Police continue to perform, with distinction, their security roles at the State House, which now include cyber-related issues, now therefore be it

Resolved by the Senate and House of Representatives:

That the General Assembly congratulates the Capitol Police on the department's 20th anniversary, and be it further

Whereas, despite the lower percentage of American adults who smoke tobacco products than in prior generations, the detrimental impact of lung cancer remains a major health issue in Vermont and throughout the United States, and

Whereas, in 2018, lung cancer killed more Americans, including Vermonters, than any other variant of the disease, and

Whereas, according to the American Lung Association, every five minutes a woman in the United States is informed she has lung cancer, and

Whereas, the Association also reports that during the past four decades, for men, the rate for new cases of lung cancer has declined 35 percent, but unfortunately, for women, the comparable rate has increased 87 percent, and

Whereas, the most recent Vermont Department of Health data indicate that 176 women die from lung cancer on an annual basis, and

Whereas, increased awareness of the potential for developing lung cancer and the devastating consequences that can result, especially among women, plus continued advocacy for further research should lead to increased early detection and improved treatment options, and

Whereas, Lung Force is a special initiative of the American Lung Association with the goal of "bringing women together to make lung cancer history," and

Whereas, an important method for increasing public awareness of lung cancer's consequences is the public information activity that the American Lung Association conducts, now therefore be it

Resolved by the Senate and House of Representatives:

That the General Assembly recognizes the second full week in May as Women's Lung Health Week in Vermont, and be it further
