House concurrent resolution honoring the tenth bishop of the Episcopal Diocese of Vermont, the Right Reverend Thomas Clark Ely, for his visionary leadership

Whereas, Bishop Tom Ely graduated cum laude from Western Connecticut State University, earned his master's degree in divinity at the University of the South in Sewanee, Tennessee, and was ordained as a deacon and next as an Episcopal priest in the Diocese of Connecticut, and

Whereas, his first assignment was as an assistant priest in the Middlesex, Connecticut, area, and he subsequently served as Director of Youth Ministry and as Missioner of Connecticut's Greater Hartford Regional Ministry, and

Whereas, in 2001, the then Reverend Tom Ely was honored to be elected as the tenth bishop of the Episcopal Diocese of Vermont, and

Whereas, Tom Ely's inspiring leadership as bishop has centered on a ministry that proclaims social justice and compassion on a wide variety of issues, even those that are controversial, and he has often been pioneering in this regard, and

Whereas, his duties require him to travel thousands of miles each year, and

Whereas, as a member of the Cristosal Foundation Board of Directors, Bishop Tom Ely has worked passionately to improve human rights in El Salvador, and

Whereas, he has spoken in support of full equality for the LGBTQ community, including same-sex marriage and complete inclusion in all aspects of the life of the Episcopal Church, and

Whereas, Bishop Tom Ely's active involvement in Bishops United Against Gun Violence coincides with his concerns on this issue, and

Whereas, the creation of the Bishop Tom Ely Solar Farm at Rock Point in Burlington reflects his belief that we are stewards of our natural resources, and

Whereas, Bishop Tom Ely has been a leader with Vermont Interfaith Action, Kids 4 Peace, and the Vermont Ecumenical Council, through which he has partnered on worthy projects with other Christian denominations, Muslims, and Jews, and

<u>Whereas</u>, Tom Ely is concluding his tenure as bishop, now therefore be it Resolved by the Senate and House of Representatives:

Whereas, Joe Choquette skied in the Rockies with the University of Vermont Catamount ski team in his role as the team's public relations expert, and for three decades, he was the rink announcer and official scorer for the

Catamount men's hockey team and fondly recalls the team's first ECAC Division I championship, and

Whereas, Vermont sports journalists held Joe Choquette in such high regard that they elected him Vermont Sportswriters and Sportscasters Association president, and

Whereas, his professional career included serving on the staff of the American Petroleum Institute, as the Vermont Petroleum Association's executive director and, for the past 19 years, as the external affairs manager for the law firm Downs Rachlin Martin, and

Whereas, while employed at the American Petroleum Institute, he dined at the New York Yacht Club; played on a golf course on Kiawah Island, South Carolina; toured the White House, the U.S. Capitol, and the many museums in our nation's capital city; and enjoyed many opportunities that would not otherwise have been available to him, and

Whereas, on December 13, 2018, he received the Matthew Lyon Award for his lifetime commitment to the First Amendment from the Vermont Press Association and the public's right to know the truth, and

Whereas, Joe Choquette served as president of the Vermont Society of Association Executives, the Montpelier Chamber Orchestra Society, and the Montpelier Rotary Club, and

<u>Whereas</u>, in 2019, the Vermont Council on World Affairs sponsored its inaugural Academic WorldQuest competition, which immigration attorney Leigh Cole organized and University of Vermont professor Edward R. McMahon judged, and

<u>Whereas</u>, the 2019 Academic WorldQuest Vermont event attracted over 30 students from five schools: Champlain Valley Union High School, Colchester High School, Essex High School, South Burlington High School, and Vermont Commons, and

Whereas, after the timed question-and-answer competition was completed and the scores were tallied, the Essex team emerged victorious and will represent Vermont at the national Academic WorldQuest competition to be held in Washington, D.C., and

Whereas, the internationally astute Essex team's roster consisted of seniors Calvin Burnett, Sam Evans, Peregrine Ibarra, and David Wrenner, and Essex faculty member Charlie Burnett advised the students, now therefore be it

Whereas, Vaughn Altemus served as an adjunct faculty member at Trinity College, in the fields of administration of justice and political science, and at Champlain College, teaching an introductory American government course, and

Whereas, in 1997, Vaughn Altemus joined the professional staff of what was then the Department of Education, and in 2001, he assumed the role of education finance manager, a position that made him responsible for analyzing actual and budgeted expenditures of the State's school districts, and

Whereas, later he was assigned to the office of the Secretary of Education to work primarily on legislation that realigned the structure of some of the State's school districts, and he remained in this position until his retirement in 2015, and

<u>Whereas</u>, Vaughn Altemus served from January 1999 through March 2015 on the Board of Trustees of the Vermont State Teachers' Retirement System, a panel responsible for supervising the retirement system for the State's licensed educators, and

Whereas, for a decade, beginning in 2008, Vaughn Altemus was a member of the Vermont Pension Investment Committee, which is responsible for the investment and management of the combined funds of the municipal employees', State employees', and teachers' retirement systems, and

Whereas, Vaughn Altemus completed an admirable record of public service, now therefore be it

Whereas, in the late 1950s, two Rutland County women, Ellen Hollrock Porter and Olive Smith, were worried about the many stray animals that were locally present, and they personally cared for some of these animals, and

Whereas, these women brought together a group of individuals to discuss the establishment of a local humane society, and

Whereas, a Pittsford farmer, Ed Wheeler, served as the incipient organization's first humane agent, and before the construction of a dedicated facility, his farm was home to the original shelter, and

Whereas, on April 29, 1959, this informal group took an important institutional step, incorporating as the Rutland County Humane Society (RCHS), and

Whereas, the organization purchased land from the Stevens Farm in Pittsford for a new shelter, and

Whereas, in October 1966, the RCHS broke ground for the shelter, which cost \$45,000 to build and was opened in October 1967, and

Whereas, in 1975, the RCHS added a stable to the shelter for housing large animals, and

<u>Whereas</u>, improvements to the RCHS shelter, both in 1998 and later in 2009, upgraded the facility's administrative operations, introduced higher health and safety standards, and offered more comfortable accommodations for the animals, and

<u>Whereas</u>, since its establishment, the RCHS has assisted over 113,000 animals of various species, including dogs, cats, guinea pigs, and birds, and in the organization's early years, it also worked with skunks, loons, fawns, goats, and horses, and

Whereas, in addition to sheltering animals, the RCHS has conducted ancillary programs, including dog training, Junior Humane Society, neutering and spaying, pet adoption, pet therapy, and fundraising and membership activities, and

Whereas, since its founding, broad community support has enabled the RCHS to fulfill its mission of caring for animals in Rutland County, now therefore be it

Resolved by the Senate and House of Representatives:

That the General Assembly congratulates the Rutland County Humane Society on its 60th anniversary, and be it further

Whereas, although she experienced early challenges mastering English, Katherine Paterson persevered and graduated summa cum laude, as an English major, from King College in Bristol, Tennessee, and earned a master's degree from the Presbyterian School of Christian Education in Richmond, Virginia, and

Whereas, because political restrictions prohibited her from serving as a Christian missionary in China, she instead worked in Japan, and her study there of Japanese and Chinese culture influenced her future writing, and

Whereas, Katherine Paterson began her career as an author with the 1966 religious education book Who Am I, and her first novel, published in 1973, The Sign of the Chrysanthemum, was set in the Japanese medieval period, and

Whereas, her most popular work, Bridge to Terabithia, for which she won the 1978 Newbery Medal for American children's literature, was based on the death of her son David's friend, and in 1981, Katherine Paterson was the recipient of a second Newbery Medal for her novel Jacob Have I Loved, and

Whereas, on two occasions, Katherine Paterson was the recipient of the prestigious National Book Award, in 1977 for *The Master Puppeteer* and in 1979 for *The Great Gilly Hopkins*, and

Whereas, Katherine Paterson is the author of more than 30 books, including 16 novels for children, and the recipient of numerous honors, including the Hans Christian Andersen Award, what has become the Children's Literature Legacy Award, and special recognition from several major American libraries, and

Whereas, her 2006 novel Bread and Roses, Too gained its inspiration from a historic photograph of children standing on the steps of the Old Labor Hall in Barre, and

Whereas, in 2019, Katherine Paterson was one of 17 writers whom the American Academy of Arts and Letters honored with a lifetime achievement award, in her instance, the E.B. White Award, for her contributions to children's literature, now therefore be it

S.C.R. 12. Senate concurrent resolution honoring former Representative and Senator Seth B. Bongartz for his impressive leadership as president of Hildene.

Whereas, Seth Bongartz graduated from Burr & Burton Academy, Skidmore College, and after an interlude as a woodworker, State Representative, State Senator, and board member of the Nature Conservancy

and the Ottaquechee Land Trust, he earned a law degree at Case Western Reserve University School of Law, and

Whereas, for over a decade, he worked at a private law firm in Bennington where environmental law was an important component of his legal practice, and

Whereas, in 1904, Robert Lincoln, the only surviving son of President Abraham Lincoln, purchased acreage in Manchester and had built a large "ancestral home" for himself and his wife, and he applied the name Hildene to the property, and

Whereas, in the 1970s, after the last Hildene-residing Lincoln descendant died, the Manchester community succeeded in halting Hildene's sale to developers, and a new nonprofit organization, the Friends of Hildene, was formed to restore this magnificent homestead, and

Whereas, in 2002, Hildene hired as its president Seth Bongartz, a man truly dedicated to the organization's core values of integrity, perseverance, and civic responsibility and to its action agenda of land conservation, historic preservation, sustainability, and civil civic discourse, and

Whereas, Seth Bongartz has stated that placing Hildene on the international tourist map has been his greatest accomplishment, and

Whereas, in 2007, the restored historic carriage barn was opened as a welcome center and museum store, creating a spacious entryway and a new revenue resource, and

Whereas, in 2011, the Many Voices exhibit, featuring a restored Sunbeam Pullman Car, debuted, and it tells the racially charged story of the Pullman railroad porters, an especially symbolic example of civil civic discourse, as Robert Lincoln was president and board chair of the Pullman Palace Car Company, and

Whereas, in December 2019, Seth Bongartz will complete his innovative and successful 18-year tenure as president of Hildene, now therefore be it

Resolved by the Senate and House of Representatives:

That the General Assembly honors former Representative and Senator Seth B. Bongartz for his impressive leadership as president of Hildene, *and be it further*
