Whereas, "point of order" was certainly the phrase most closely associated with former Representative David Deen, as he was always alert to parliamentary missteps, citing his mastery of *Mason's Manual of Legislative Procedure*, and

<u>Whereas</u>, as Chair of the Committee on Natural Resources, Fish, and Wildlife, he devoted considerable attention to environmental matters, and

Whereas, David Deen was born in Abington, Pennsylvania, attended the University of Connecticut, and earned a master's degree in environmental science from the Antioch New England Graduate School, and

Whereas, his first successful foray into electoral politics occurred during the 1987–1988 biennium, serving a term as a Windham County Senator, and

Whereas, in 1991, David Deen returned to the General Assembly as the member of the House from Westminster, starting an extraordinarily productive 27–year tenure, and

Whereas, his conscientious and dedicated work produced critical legislation intended to improve the quality of the State's waters and preserve Vermont's constitutionally enshrined right to hunt and fish, and

Whereas, former Representative David Deen helped oversee State taxation policy as Vice Chair of the Committee on Ways and Means and reviewed municipal affairs as a member of the Committee on Local Government, and

Whereas, David Deen is an avid fisherman, holds memberships in several fishing organizations, and has worked as a professional fishing guide, and

<u>Whereas</u>, he served as a river steward for the Connecticut River Watershed Council, exemplifying his concern for the quality of Vermont's waters, and

Whereas, after nearly three decades as the member of the House from Westminster, former Representative David Deen, husband, father, grandfather, and great-grandfather, cast his final legislative vote in June 2018, concluding a long and illustrious State legislative career, now therefore be it

<u>Whereas</u>, outside the classroom, Skip Cooke was a successful baseball, basketball, and football coach, and

Whereas, in 1982, Skip Cooke's faculty peers selected him as the school's outstanding teacher of the year, and in 1983, he served for several months as acting assistant principal, and

Whereas, in 1984, having confirmed his skill as a school administrator, Skip Cooke began an unusual 35-year tenure as the Fair Haven Grade School principal, and

Whereas, in 2008, the National Association of Elementary School Principals named Skip Cooke as a National Distinguished Principal of the Year, and

Whereas, in June 2019, Skip Cooke will end his long and highly successful professional association with the Fair Haven Public Schools, now therefore be it

Whereas, after graduating from Bellows Free Academy in 1944, at 17 years of age, Edmund Wilcox embarked on his 53-year career operating the Wilcox family dairy farm on Georgia Shore, and

Whereas, as a dairy farmer, he was a member of the Georgia Banner Grange, and during his 60-year association with the Grange rose to the rank of 7th degree, and

Whereas, while the farm provided him an economic livelihood, Edmund Wilcox's life encompassed a far broader expanse as a civic leader, educator, historian, music lover, and writer, and

Whereas, for a decade, Edmund Wilcox served as a town lister, and his other municipal roles included membership on the conservation commission and school board, and he also volunteered for various town assignments, and

Whereas, in 2015, the Georgia Conservation Commission recognized Edmund Wilcox for his 20-plus years of "Outstanding Dedication and Service to the Town of Georgia," and

Whereas, Edmund Wilcox was an active member of the Georgia Historical Society and wrote many articles for its Georgia Town History series, and the society honored him as its 2010 Volunteer of the Year, and

<u>Whereas</u>, Edmund Wilcox's historical interests were reflected in his Green Mountain Folklore Society and Vermont Old Cemetery Association memberships, and

Whereas, he polished his writing skills as a member of the St. Albans Writers Workshop, and

Whereas, as a man of wide talents, Edmund Wilcox was a welcomed volunteer in the Georgia public schools, and

Whereas, Edmund Wilcox loved music and would start singing at a moment's notice, and he shared this passion with the residents of local nursing homes, and

Whereas, Edmund Wilcox died on March 22, 2019, at 92 years of age, and his survivors include his sister and a nephew and nieces, now therefore be it

Whereas, in the mid-1800s, St. Johnsbury resident Franklin Fairbanks recorded daily weather data and general meteorological observations, and

Whereas, in 1891, he established the Fairbanks Museum, which in 1961, became the Fairbanks Museum & Planetarium (the museum), and

Whereas, shortly after the museum opened, it began collecting meteorological information for the newly established U.S. Weather Bureau, and since 1894 it has continuously gathered these contemporaneously useful and historically revealing statistics, and

Whereas, because of these pioneering commitments to gathering weather information, St. Johnsbury proudly holds the record as the Vermont community with the longest uninterrupted stream of weather data, and

Whereas, in 1949, the museum's meteorological activities assumed a different dimension when its director, Fred Mold, commenced broadcasting weather forecasts on what has become St. Johnsbury radio station WSTJ, and

Whereas, in 1981, Vermont's weather analysis entered an exciting, new era when the museum established the *Eye on the Sky* forecasting service and hired two full-time meteorologists, Mark Breen and Steve Maleski, not only to broadcast daily forecasts on Vermont Public Radio (VPR), but also to serve as weather science educators and present informative shows at the museum's planetarium, and

Whereas, the *Eye on the Sky* meteorological staff, now including Lawrence Hayes and Chris Kurdek, also produces the VPR astronomy program, *Eye on the Night Sky*, and weather forecasts for several commercial radio stations and newspapers, and its website features current forecasts, monthly weather almanacs, and a treasure trove of historical weather data, and

Whereas, in the early 2000s, the museum presented an *Eye on the Sky* Weather Gallery, and elements of the gallery are now featured in the Soucy Family Exploration Station, and

Whereas, since 2016, the *Eye on the Sky* has been headquartered in the architecturally and technologically state-of-the-art McGuire Center, now therefore be it
