<u>Whereas</u>, in 1919, Clarence Hazelett began developing continuous casting machines in Connecticut, and in 1924, he formalized his operations, establishing the Hazelett Storage Battery Company, and

Whereas, in 1956, his sons, William and Richard, relocated to Colchester and incorporated the company as the Hazelett Strip-Casting Corporation, and

<u>Whereas</u>, today, David Hazelett leads the company, known as the Hazelett Corporation, a "world leader in designing and manufacturing advanced twinbelt strip casters," and

Whereas, in 2019, the Lake Champlain Regional Chamber of Commerce honored the Hazelett Corporation with its Business of the Year Award, now therefore be it

That the General Assembly congratulates the Hazelett Corporation on its centennial, and be it further

<u>Whereas</u>, as the first person to log 1,000 candy striper hours at her local hospital, Lindy Lynch demonstrated a youthful enthusiasm for community service that endured a lifetime, and

Whereas, a nursing graduate of Western Connecticut University, Lindy Lynch's service as a U.S. Army nurse earned her Soldier of the Year recognition, and

Whereas, Lindy Lynch's civilian life in Bennington included many praiseworthy endeavors, and

Whereas, local and statewide child care services benefited from her entrepreneurial and advocacy roles, for which the State of Vermont honored her, and

Whereas, in the public sector, Lindy Lynch served on the North Bennington School Board, and

<u>Whereas</u>, she lent her leadership ingenuity to the local Rotary and Chamber of Commerce, serving as president of both organizations as well as on the board of the Vermont Chamber of Commerce, and

Whereas, Lindy Lynch was a founding board member of radio station WBTN, served on the NorShaft Lions Park renovation committee and the Bennington Economic Development Task Force, was an organizer of the Bennington Car Show and a founder of the Bennington Garlic Festival and, not surprisingly, given her nursing background, an active Southwestern Vermont Medical Center volunteer, and

Whereas, this consummate and greatly admired civic leader, known as "Bennington's Number 1 Fan," died on August 3, 2019 at 63 years of age, and her survivors include her husband, Kevin, with whom she had co-operated Kevin's Restaurant in North Bennington, her mother, children, and grandchildren, now therefore be it
