Whereas, during his decades of U.S. Air Force service, Bob Sausville earned many honors, including the Distinguished Flying Cross, an Airman's Medal, and an Air Force Commendation Medal, and

Whereas, upon his military retirement in 1969, Bob Sausville and his wife, Geraldine, to whom he was married for 72 years, returned to Bennington, where he sold and repaired antique clocks, turning his childhood interest into a new career, and

Whereas, Bob Sausville delights in composing poetry, and his family published a volume of his work entitled *Humorous Verse*, and

Whereas, just days before his centennial birthday, Bob Sausville, now a father, grandfather, and great-grandfather, flew in a plane, this time as a passenger, for the first time in a half-century, a special capstone to an aviator's life, now therefore be it
