Whereas, beginning in 1991, Zoe Hardy served as Age Well's assistant nutrition director, and from 1998 to 2016 as its nutrition director, and in these roles, she forged partnerships with technical centers and businesses, and

Whereas, her effective stewardship of Age Well's Meals on Wheels program included significant increases in the number of meals served, the establishment of two specialized meal sites to serve refugees, and the development of a large contingent of valued volunteers, and

<u>Whereas</u>, Zoe Hardy oversaw the Age Well Wellness program, featuring both the Strong Living and Tai chi for balance classes, and

Whereas, in 2020, Zoe Hardy is concluding her successful 29-year career at Age Well, and her expertise will be missed, now therefore be it

Whereas, Bonnie Burke's life of helping others ended on December 18, 2019, and her survivors include her husband, Timothy, children, grandchildren, and great-grandchildren, now therefore be it

Whereas, in 2000, Nancy Heydinger established Girls on the Run (GOTR) at Vernon Elementary School, primarily for her daughters, to enable them to "grow up loving themselves and feeling complete," and her husband, Tom, was a supportive volunteer colleague, and

Whereas, the next academic year, she extended her personal project to the Academy School, initiating an organizational transformation of GOTR into a professionally staffed program now serving third- through eighth-grade girls at more than 150 schools, and

Whereas, the 2019 iteration of GOTR's Brattleboro race involved approximately 1,000 young female runners from 40 schools, and

Whereas, Nancy Heydinger recently concluded her role as GOTR's executive director, but she intends to remain actively involved with the organization, now therefore be it

Whereas, in 1995, five free health care clinics for the uninsured formed an informal coalition, and in 1997 this coalition was incorporated as the nonprofit Vermont Coalition of Clinics for the Uninsured, now known as Vermont's Free & Referral Clinics (VFRC), and

Whereas, in 1999, the General Assembly began appropriating funds, supporting the important work of VFRC, and

Whereas, since 1997, the clinics have served 64,000 Vermonters, and between 2007 and 2018 this number experienced a 94 percent increase, and

Whereas, in 2018, the assistance the nine clinics offered was valued at an estimated \$7.5 million, and they continue to play a critical health care role in Vermont, now therefore be it

House concurrent resolution in memory of Preservation Trust of Vermont Executive Director Paul Alan Bruhn

Whereas, Paul Bruhn graduated from Burlington High School and, following a brief stay at the University of Vermont, earned valuable tutelage in journalism, editing the *Chittenden Magazine*, and

Whereas, in 1974, he served as Patrick Leahy's campaign manager and became his chief of staff in Washington, D.C., and

Whereas, in 1980, Paul Bruhn assumed development and leadership of the Preservation Trust of Vermont and stewarded its growth as a force for good across Vermont for the next 39 years, and

Whereas, the Vermont Land Trust awarded him its only Cowbird Award, because of his unique ability to inspire others to assume responsibility for difficult projects he initiated, and

Whereas, in cooperation with U.S. Senator Patrick Leahy, he created a national program supporting historic gathering places throughout the country, now known as "Bruhn Grants," and

Whereas, public arts spaces were made possible and country stores preserved, in large part, because of Paul Bruhn's energy and enthusiasm, and

Whereas, in 1986, Paul Bruhn was one of the leaders who created the Vermont Housing and Conservation Coalition, and the outgrowth has resulted in a \$358 million Vermont investment in constructing homes and preserving land, and

Whereas, Paul Bruhn was an advocate for smart growth and the creation and enhancement of the downtown tax credit program, and

Whereas, in leading the Preservation Trust of Vermont, he was a mentor to numerous Vermonters seeking to improve the quality of life in their communities, and Paul Bruhn's greatly admired leadership at the Trust continued until his death on September 19, 2019, now therefore be it
