House concurrent resolution designating the month of February 2020 as Pharmacists' Month in Vermont

Whereas, Vermonters need ready access to prescribed and over-the-counter medications, and

<u>Whereas</u>, a primary source for Vermonters to access these medications is through licensed pharmacists, many of whom are employed at community-, hospital-, and health center-based pharmacies, and

<u>Whereas</u>, pharmacists frequently provide consumers with important information and guidance regarding the proper use of medication, and

<u>Whereas</u>, the Doctor of Pharmacy degree, which is now offered in Vermont, affords aspiring pharmacists excellent academic preparation, and

<u>Whereas</u>, today's pharmacists are well trained to help keep Vermonters healthy, now therefore be it
