### H.R. 5

House resolution, entitled

House resolution expressing solidarity with our federal workforce and urging Congress and the President to keep the federal government open

Offered by: Representatives Donovan of Burlington and Cina of Burlington

Whereas, our hardworking constituents elected us to the Vermont House of Representatives to advocate for their best interests in a fair and representative democracy, and

Whereas, a federal government shutdown would be in no one's interest and may cause harm to many Vermonters, and

Whereas, the policy debate over the disputed issues should happen with the government up and running, and

Whereas, the 800,000 federal employees and hundreds of thousands of federal contractors should not miss paychecks through no fault of their own, and

Whereas, no other business in the country would be permitted to operate without paying its employees, an unfair practice that should be illegal, and

Whereas, regardless of political party affiliation, we should all be able to agree that the federal workforce is vital, as it cares for the sick and elderly, helps our veterans heal and adjust to civilian life, finds cures for diseases, sends rockets into outer space, brings scientific breakthroughs to fruition, and administers loans that finance business activities, and

Whereas, put simply, there would be no America without a dedicated federal civil service and federal contractors, and

Whereas, these hardworking Americans are worried about paying for a roof over their heads, putting food on the table, and surviving, now therefore be it

# Resolved by the House of Representatives:

That this legislative body stands in solidarity with America's federal workforce and urges Congress to pass and the President to sign legislation to keep these individuals working for all Americans and the federal government open, and be it further

<u>Resolved</u>: That the Clerk of the House be directed to send a copy of this resolution to President Trump and the Vermont Congressional Delegation.

## Second Reading; Bill Amended; Third Reading Ordered

H. 7

**Rep. Hashim of Dummerston**, for the committee on Judiciary, to which had been referred House bill, entitled

An act relating to second degree aggravated domestic assault

Reported in favor of its passage when amended by striking all after the enacting clause and inserting in lieu thereof the following:

Sec. 1. 13 V.S.A. § 1044 is amended to read:

§ 1044. SECOND DEGREE AGGRAVATED DOMESTIC ASSAULT

- (a) A person commits the crime of second degree aggravated domestic assault if the person:
  - (1) Commits the crime of domestic assault and such conduct violates:
- (A) specific conditions of a criminal court order in effect at the time of the offense imposed to protect that other person;
- (B) a final abuse prevention order issued under 15 V.S.A. § 1103 or a similar order issued in another jurisdiction;
- (C) a final order against stalking or sexual assault issued under 12 V.S.A. § 5133 or a similar order issued in another jurisdiction; or
- (D) a final order against abuse of a vulnerable adult issued under 33 V.S.A. § 6935 or a similar order issued in another jurisdiction.
  - (2) Commits the crime of domestic assault; and
- (A) has a prior conviction within the last 10 years for violating an abuse prevention order issued under section 1030 of this title; or
- (B) has a prior conviction for domestic assault under section 1042 of this title or for an offense that, if committed within the State, would constitute a violation of section 1042 of this title.
- (3) For the purpose of this subsection, the term "issued in another jurisdiction" means issued by a court in any other state; in a federally recognized Indian tribe, territory, or possession of the United States; in the Commonwealth of Puerto Rico; or in the District of Columbia.
- (b) A person who commits the crime of second degree aggravated domestic assault shall be imprisoned not more than five years or fined not more than \$10,000.00, or both.

#### Sec. 2. EFFECTIVE DATE

This act shall take effect on passage.

The bill, having appeared on the Calendar one day for notice, was taken up, read the second time, report of the committee on Judiciary agreed to and third reading ordered.
