4	Statement of purpose of bill as introduced: This bill proposes to adopt
5	multiple provisions related to improving the agricultural economy. The bill
6	would require the Agency of Agriculture, Food and Markets (Agency) to
7	evaluate an Agricultural Loan Loss Reserve Fund to serve as credit
8	enhancement for farmers and forest products businesses. The bill would
9	appropriate additional funds to the Working Lands Program. The bill would
10	enact a limitation on liability for agritourism activity. The bill would require
11	the Agency to report to the General Assembly regarding the prioritization and
12	potential funding sources for additional farm and food business service
13	providers needed to support the agricultural industry in Vermont. The bill
14	would require the creation of a directory of legal and financial service
15	providers who provide services or expertise needed by working lands
16	businesses. The bill would appropriate funds for a grant to support the
17	statewide direct market electronic benefit transfer doubling programs. The bil
18	would appropriate funds to the Agency to provide grants to charitable food
19	organizations to purchase Vermont food. The bill would appropriate funds to
20	the Agency for a grant to fund the coordination of gleaning service across the

State. The bill would appropriate funds to the Agency for a grant to establish

7	It is hereby enacted by the General Assembly of the State of Vermont:

9	Sec. 1. APPROPRIATIONS; WORKING LANDS PROGRAM
10	In fiscal year 2021, \$1,5200,000.00 is appropriated from the General Fund
11	to the Agency of Agriculture, Food and Markets for grants to be awarded
12	through the Vermont Working Lands program, pursuant to 6 V.S.A. chapter
13	207, subchapter 2. These funds are in addition to the Governor's recommended
14	budget allocation of \$1,300,000 for this program, thus bringing the total
15	appropriations to the Working Lands Enterprise Program in
16	FY21 to \$1,500,000.

1	(1)(A) "Agritourism activity" means an interactive or passive activity
2	that is:
3	(i) carried out with or without payment to an agritourism host on a
4	farm regulated under 6 V.S.A. chapter 215, related to farming, food
5	production, historic tradition, or nature watching; and
6	(ii) conducted by an agritourism host for the education,
7	entertainment, or recreation of participants.
8	(B) "Agritourism activity" includes a farming activity; the viewing of
9	a historic, cultural, or natural attraction; a pick-your-own activity; nature
10	watching; and an activity involving an animal exhibition at an agricultural fair.
11	(C) "Agritourism activity" shall not include a roadside farm stand or
12	operation exclusively devoted to the sale of merchandise or food at retail.
13	(2) "Agritourism host" means a person who provides the facilities and
14	equipment necessary to participate in an agritourism activity.
15	(3) "Farm" means a parcel or parcels of land owned, leased, or managed
16	by a person and devoted primarily to farming that meets the threshold criteria
17	established by the Required Agricultural Practices.
18	(4) "Farming" has the same meaning as in 10 V.S.A. § 6001.
19	(5) "Inherent risk" means any danger or condition that is an integral part
20	of, or arises from, an agritourism activity, including:

1	(A) the propensity of a wild animal or domestic animal to behave in
2	ways that may result in injury or death to persons on or near the wild animal or
3	domestic animal;
4	(B) a hazard such as a surface or subsurface condition;
5	(C) a natural condition of land, vegetation, or waters;
6	(D) the ordinary dangers of structures or equipment used in farming:
7	<u>and</u>
8	(E) the potential of a participant to act in a negligent way that may
9	contribute to injury or death to the participant or others, such as failing to
10	follow safety procedures or failing to act with reasonable caution while
11	engaging in an agritourism activity.
12	(6) "Participant" means any person who is invited onto the farm for the
13	purpose of participating in an agritourism activity.
14	§ 5872. LIMITATION ON DUTY TO PROTECT
15	(a) Except as provided in subsection (b) of this section, an agritourism host
16	shall not have a legal duty to protect a participant from the inherent risks of an
17	agritourism activity and shall not be liable for injury to or death of a participant
18	resulting from the inherent risks of an agritourism activity, provided that the
19	agritourism host posts the warning required under section 5873 of this title.
20	(b) Nothing in subsection (a) of this section shall limit the liability of an
21	agritourism host who:

4	(2) has actual knowledge of:
5	(A) a dangerous condition on the land, facilities, or equipment used
6	in the activity, or
7	(B) the dangerous propensity of an animal used in the activity, that
8	proximately causes injury or death to the participant and does not make that
9	danger known to the participant;
10	(3) intentionally injures a participant; or
11	(4) commits any other act, error, or omission that constitutes willful or
12	wanton misconduct, gross negligence, or criminal conduct that proximately
13	causes injury or death to the participant.
14	(c) Any limitation on liability afforded by this section to an agritourism
15	host is in addition to any other limitations on liability otherwise provided by
16	<u>law.</u>
17	§ 5873. WARNING NOTICE; POSTING; CONTRACTS
18	(a) An agritourism host shall post and maintain a sign in a clearly visible
19	location at or near the main entrance to each agritourism activity and in black
20	letters at least one inch in height containing the warning notice specified in
21	subsection (c) of this section.

(b) Every written contract entered into between an agritourism host and a
participant for goods or services related to an agritourism activity shall contain
in clearly visible print the warning notice specified in subsection (c) of this
section.
(c) The warning notice required under subsections (a) and (b) of this
section shall read: "WARNING: Under Vermont law, an agritourism host is
not liable for the injury or death of a participant in an agritourism activity
resulting from the inherent risk of the agritourism activity. Inherent risks
include the risk of animals, weather, land conditions, and the potential for you
as a participant to act in a negligent way that may contribute to your own
injury or death. You are assuming the risk of participating in this agritourism
activity."
(d) Failure to comply with the requirements of this section shall result in
the agritourism host being unable to invoke the limitation on liability provided
in section 5872 of this title.
