Home Access Program Vermont Center for Independent Living House Appropriations Testimony February 20, 2020

Good afternoon. My name is Patricia Tedesco and I coordinate the Home Access Program at the Vermont Center for Independent Living. Thank you for the opportunity to be here today and for your long standing support for our program and the Vermont Housing and Conservation Board.

VCIL provides accessibility modifications for Vermonters who have permanent physical disabilities so they can remain in their homes and live more independently.

You have a packet with photos and stories of people who have benefited from this important program. You'll see a photo of Souley, who lives in White River Junction; He wanted to share his story with you:

"Before I received the bathroom, I had to crawl on my knees and once I was in the bathroom it was very difficult to turn around. I had trouble getting in and out of the bathtub. I also had to make sure that I was undressed before reaching the door. Now ... I can ride my wheelchair into the bathroom and shower. I can dress and undress in the bathroom. I can go from the wheelchair to the toilet and to the shower. ... Thank you for making my life more independent."

Taking a shower or getting in and out of our homes easily is something perhaps most of us don't think twice about. However for the people we help, these issues are a daily struggle.

VCIL is requesting that you fund VHCB at the highest level possible. VHCB's FY 21 funding level required by statute is estimated at \$22.4 million from the property transfer tax.

The average cost of a project through VCIL is about \$10,000, compared to about \$97,000 a year to live in a nursing home. Our program is evidence based - it is saving the state money in the human services budget. Also, this funding trickles down to give

local contractors, and their skilled craftspeople, good-paying jobs doing home modifications throughout the state.

With the traditional funding levels between \$425 and \$475 thousand dollars from VHCB and \$100 thousand dollars from DAIL, our program is able to help with about 50 home modifications. The housing bond funding achieved the goal for VCIL – to reduce the wait list. However, with no "shot in the arm" of additional funding, we simply do not have the resources to help the many families in need around the state.

We work vigilantly to collaborate with partners and funders to reduce the cost of each project, however, right now we have 39 people on our wait list – and with applications coming in steadily - we expect to hit 100 before the fall. And so it goes.

Since our funding depends in large part on VHCB's appropriation, we ask you to provide them with full statutory funding at \$22.4 million for FY 21.

Thank you for your time, I know you have difficult decisions to make.
