8	Statement of purpose of bill as introduced: This bill proposes to reenact
9	Vermont's Self-Employment Assistance Program.
10	An act relating to creating the Self-Employment Assistance Program
11	It is hereby enacted by the General Assembly of the State of Vermont:
12	Sec. 1. 21 V.S.A. § 1340a is added to read:
13	<u>§ 1340a. SELF-EMPLOYMENT ASSISTANCE PROGRAM</u>
14	(a) As used in this section:
15	(1) "Full-time basis" means that the individual is devoting the necessary
16	time as determined by the Commissioner to establish a business that will serve
17	as a full-time occupation for that individual.
18	(2) "Regular benefits" shall have the same meaning as in subdivision
19	1421(5) of this title.

1	(3) "Self-employment assistance activities" means activities approved
2	by the Commissioner in which an individual participates for the purpose of
3	establishing a business and becoming self-employed, including entrepreneurial
4	training, business counseling, and technical assistance.
5	(4) "Self-employment assistance allowance" means an allowance
6	payable in lieu of regular benefits from the Unemployment Compensation
7	Trust Fund to an individual who meets the requirements of this section.
8	(5) "Self-Employment Assistance Program" means the program under
9	which an individual who meets the requirements of subsection (d) of this
10	section is eligible to receive an allowance in lieu of regular benefits for the
11	purpose of assisting that individual in establishing a business and becoming
12	self-employed.
13	(b) The weekly amount of the self-employment assistance allowance
14	payable to an individual shall be equal to the weekly benefit amount for regular
15	benefits otherwise payable pursuant to this title.
16	(c) The maximum amount of the self-employment assistance allowance
17	paid pursuant to this section shall not exceed the maximum amount of benefits
18	established pursuant to section 1340 of this title with respect to any benefit
19	year.
20	(d)(1) An individual may receive a self-employment assistance allowance if
21	that individual:

1	(A) is eligible to receive regular benefits or would be eligible to
2	receive regular benefits except for the requirements described in subdivisions
3	(2)(A) and (B) of this subsection (d);
4	(B) is identified by a worker profiling system as an individual likely
5	to exhaust regular benefits;
6	(C) has received the approval of the Commissioner to participate in a
7	program providing self-employment assistance activities;
8	(D) is engaged actively on a full-time basis in activities that
9	may include training related to establishing a business and becoming
10	self-employed; and
11	(E) has filed a weekly claim for the self-employment assistance
12	allowance and provided the information the Commissioner requires.
13	(2) A self-employment allowance shall be payable to an individual at the
14	same interval, on the same terms, and subject to the same conditions as regular
15	benefits pursuant to this chapter, except:
16	(A) the requirements of section 1343 of this title, relating to
17	availability for work, efforts to secure work, and refusal to accept work, are not
18	applicable to the individual; and
19	(B)(i) the individual is not considered to be self-employed pursuant
20	to subdivision 1301(24) of this title;

1	(ii) an individual who meets the requirements of this section shall
2	be considered to be unemployed pursuant to section 1338 of this title; and
3	(iii) an individual who fails to participate in self-employment
4	assistance activities or who fails to engage actively on a full-time basis in
5	activities, including training, relating to the establishment of a business and
6	becoming self-employed shall be disqualified from receiving an allowance for
7	the week in which the failure occurs.
8	(e) The self-employment assistance allowance may be paid to up to 35
9	qualified individuals at any time.
10	(f)(1) The self-employment assistance allowance shall be charged to the
11	Unemployment Compensation Trust Fund.
12	(2) In the event that the self-employment assistance allowance cannot be
13	charged to the Unemployment Compensation Trust Fund pursuant to
14	subdivision (1) of this subsection, the allowance shall be charged in
15	accordance with section 1325 of this title.
16	(g) The Commissioner shall approve any program that will provide
17	self-employment assistance activities to qualified individuals.
18	(h) The Commissioner shall adopt rules to implement this section.
19	(i) The Commissioner may suspend the Self-Employment Assistance
20	Program with approval of the Secretary of Administration and notice to the
21	House Committee on Commerce and Economic Development and the Senate
