14	§ 2056i. DISSEMINATION OF CRIMINAL HISTORY RECORDS TO THE

16	PRIVATE CONRACTORS
17	(a) Definitions. As used in this section:
18	(1) "Criminal record" means the record of:
19	(A) convictions in Vermont; or
20	(B) convictions in other jurisdictions recorded in other state
21	repositories or by the Federal Bureau of Investigation (FBI).

1	(2) "Private contractor" includes an individual who is employed
2	by a business that is performing specific services or functions for the
3	Department of Buildings and General Services on State-owned or -leased
4	property pursuant to a contract with the State or a subcontract with a person
5	who has contracted with the State.
6	(b) Authority. The Department of Buildings and General Services may
7	obtain from the Vermont Crime Information Center a Vermont criminal record,
8	an out-of-state criminal record, and a record from the Federal Bureau of
9	Investigation for any applicant for a private contractor position who has given
10	written authorization, on a release form prescribed by the Center, pursuant to
11	the provisions of this subchapter and the user's agreement filed by the
12	Commissioner of Buildings and General Services with the Center. The user's
13	agreement shall require the Department to comply with all federal and State
14	statutes, rules, regulations, and policies regulating the release of criminal
15	history records and the protection of individual privacy. The user's agreement
16	shall be signed and kept current by the Commissioner. Release of interstate
17	and Federal Bureau of Investigation criminal history records is subject to the
18	rules and regulations of the Federal Bureau of Investigation's National Crime
19	Information Center.
20	(c) Request process. A request made under this section shall be
21	accompanied by a set of the person's fingerprints.

1	(d) Notice of records. Upon completion of a criminal record check, the
2	Vermont Crime Information Center shall send to the Commissioner a notice
3	that no record exists or, if a record exists, a copy of any criminal record.
4	(e) Process for sending information. The Commissioner may inform the
5	contractor in writing of the approved level of access granted but shall not
6	reveal the content of the record to the contractor.
7	(f) Notice of rights. Information sent to a person by the Commissioner of
8	Buildings and General Services under subsection (e) of this section shall be
9	accompanied by a written notice of the person's rights under subsection (g) of
10	this section, a description of the policy regarding maintenance and destruction
11	of records, and the person's right to request that the notice of no record or
12	record be maintained for purposes of using it to comply with future criminal
13	record check requests pursuant to subsection (i) of this section.
14	(g) Appeal. Any person subject to a criminal record check pursuant to this
15	section may challenge the accuracy of the record by appealing to the Vermont
16	Crime Information Center pursuant to rules adopted by the Commissioner of
17	Public Safety.
18	(h) Confidentiality. Criminal records and criminal record information
19	received under this section are designated confidential unless, under State or
20	federal law or regulation, the record or information may be disclosed to
21	specifically designated persons.

1	(i) Recheck of records request. The Commissioner may request a name
2	and date of birth or fingerprint supported recheck of the criminal record:
3	(1) if the record has not been rechecked in at least three years;
4	(2) if there is a reason to believe the subject's criminal record has
5	changed; or
6	(3) if it is otherwise required by law.
7	(j) Maintenance of records. The Commissioner shall maintain the record or
8	information pursuant to the user agreement for maintenance of records. At the
9	end of the time required by the user agreement for maintenance of the
10	information, the Commissioner shall destroy the information in accordance
11	with the user agreement.
