

1 TO THE HOUSE OF REPRESENTATIVES:

2 The Committee on Education to which was referred House Bill No. 140
3 entitled “An act relating to the Advisory Council on Special Education”
4 respectfully reports that it has considered the same and recommends that the
5 bill be amended by striking out all after the enacting clause and inserting in
6 lieu thereof the following:

7 Sec. 1. 16 V.S.A. § 2945 is amended to read:

8 § 2945. STATE ADVISORY COUNCIL PANEL ON SPECIAL
9 EDUCATION

10 (a) There is created the State Advisory Council Panel on Special Education
11 that shall consist of ~~19~~ members who are representative of the State population
12 and involved with, or concerned with, the education of children with
13 disabilities. All members of the Council Panel shall serve for a term of three
14 years or until their successors are appointed. Terms shall begin on ~~April~~ July 1
15 of the year of appointment. ~~A majority of the members shall be either~~
16 ~~individuals with disabilities or parents of children with disabilities.~~

17 (1) ~~Seventeen of the members shall be appointed by the~~ The Governor
18 ~~with the advice of the Secretary. Among the gubernatorial appointees shall be~~
19 shall make the following appointments upon the recommendation of the
20 indicated person or organization:

1 (A) a sufficient number of individuals with disabilities and parents of
2 children with disabilities (ages birth through 26 years of age), upon the
3 recommendation of any organization whose primary mission is to serve these
4 populations, to ensure that a majority of the members of the Panel are
5 individuals with disabilities and parents of children with disabilities, including:

6 (i) not less than two individuals with disabilities, at least one of
7 whom shall be a student when appointed; and

8 (ii) not less than two parents of children with disabilities (ages
9 birth through 26 years of age);

10 (B) one representative of the State protection and advocacy system,
11 upon the recommendation of Vermont Legal Aid;

12 (C) two teachers, upon the recommendation of the Vermont National
13 Education Association;

14 ~~(B)~~(D) two representatives of State agencies involved in the
15 financing or delivery of related services to children with disabilities, upon the
16 recommendation of the Secretary of Education;

17 ~~(C)~~(E) a one representative of independent schools, upon the
18 recommendation of the Vermont Independent Schools Association;

19 ~~(D)~~(F) at least one representative of a vocational, community, or
20 business organization concerned with the provision of transition services to

1 children with disabilities, upon the recommendation of the Secretary of
2 Education;

3 ~~(E)~~(G) a one representative from the State juvenile and adult
4 corrections agency, upon the recommendation of the Commissioner of
5 Corrections;

6 ~~(F)~~ individuals with disabilities;

7 ~~(G)~~ parents of children with disabilities, provided the child shall be
8 younger than 26 years old at the time his or her parent is appointed to the
9 Council;

10 (H) two State ~~and or~~ local education officials, ~~including officials~~ who
11 carry out activities under subtitle B of title VII of the McKinney-Vento
12 Homeless Assistance Act, upon the recommendation of the Secretary of
13 Education;

14 (I) ~~a representative~~ two representatives of higher education who
15 ~~prepares~~ prepare special education and related services personnel, upon the
16 recommendation of the Vermont Higher Education Collaborative;

17 (J) a one representative from the State child welfare department
18 responsible for foster care, upon the recommendation of the Secretary of
19 Human Services; and

20 (K) two special education administrators, upon the recommendation
21 of the Vermont Council of Special Education Administrators; and

1 ~~(L) two at-large members.~~

2 (2) ~~In addition, two members of the General Assembly shall be~~
3 ~~appointed, one from the House of Representatives and one from the Senate.~~
4 ~~The Speaker shall appoint the House member and the Committee on~~
5 ~~Committees shall appoint the Senate member. Appointees may be appointed~~
6 ~~to fill more than one role except that:~~

7 (A) individuals appointed to fill a role or roles pursuant to
8 subdivision (A) or (B) of this subdivision (a)(1) shall not be appointed to fill
9 any other role; and

10 (B) individuals appointed to fill a role or roles pursuant to
11 subdivisions (C)–(K) of this subdivision (a)(1) shall not be appointed to fill
12 roles pursuant to subdivision (A) or (B) of this subdivision (a)(1).

13 (b) ~~The Council~~ At the annual meeting, or other meeting if necessary, the
14 Panel shall elect its own chair a chair and an executive committee from among
15 its membership. ~~The Council shall meet annually at the call of the Chair, and~~
16 ~~other meetings may be called by the Chair at such times and places as he or she~~
17 ~~may determine to be necessary.~~

18 (1) The Executive Committee shall be composed of seven Panel
19 members, one of whom shall be the Chair of the Panel. A majority of the
20 members of the Executive Committee shall have been appointed to the Panel
21 pursuant to subdivision (a)(1)(A) of this section. The Executive Committee

1 shall call meetings of the Panel and shall direct the work of the Panel. The
2 Executive Committee shall meet four times a year.

3 (2) The Panel shall meet annually and up to three other times at the call
4 of the Executive Committee.

5 (c) The members of the ~~Council~~ Panel who are employees of the State shall
6 receive no additional compensation for their services, but actual and necessary
7 expenses shall be allowed State employees, and shall be charged to their
8 departments or institutions. The members of the ~~Council~~ Panel who are not
9 employees of the State shall receive a per diem compensation as provided
10 under 32 V.S.A. § 1010 for each day of official business and reimbursement
11 for actual and necessary expenses at the rate allowed State employees.

12 (d) The ~~Council~~ Panel shall:

13 (1) ~~assume all responsibilities required of the State advisory panel by~~
14 ~~federal law~~ advise the Agency of Education and State Board of Education of
15 the unmet needs within the State in the education of children with disabilities;

16 (2) ~~review periodically the rules, regulations, standards, and guidelines~~
17 ~~pertaining to special education and recommend to the State Board any changes~~
18 ~~it finds necessary~~ comment publicly on any rules or regulations proposed by
19 the State regarding the education of children with disabilities;

20 (3) ~~comment on any new or revised rules, regulations, standards, and~~
21 ~~guidelines proposed for issuance~~ advise the Agency of Education and State

1 Board of Education in developing evaluations and reporting data to the
2 Secretary under 20 U.S.C. § 1418; and

3 (4) ~~advise the State Board in the development of any State plan for~~
4 ~~provision of special education~~ Agency of Education and State Board of
5 Education in developing corrective action plans to address findings identified
6 in federal monitoring reports under 20 U.S.C. chapter 33, subchapter II; and

7 (5) advise the Agency of Education and State Board of Education in
8 developing and implementing policies relating to coordination of services for
9 children with disabilities.

10 Sec. 2. TERM LIMITS

11 The State Advisory Panel on Special Education shall establish term limits in
12 its bylaws.

13 Sec. 3. EFFECTIVE DATE

14 This act shall take effect on passage.

15 and that after passage the title of the bill be amended to read: “An act
16 relating to the State Advisory Panel on Special Education”
