12	shall serve for three years, except that a member elected to fill a vacancy shall

19	(2) The Representative Town Meeting consists of up to 140 elected
20	voters and youth voters. It is a guiding body for the Town and a source of

1	Civil Authority. It exercises exclusively all powers vested in the voters of the
2	Town. In addition to the elected members, the following shall be members ex
3	officio: the members of the Selectboard, the School Directors, the Treasurer,
4	the Clerk, the Moderator, and those State Senators and State Representatives
5	who reside in Brattleboro. Representative Town Meeting shall act upon all
6	articles on the Town meeting warning except those which that relate to the
7	election of officers, referenda, and other matters voted upon by Australian
8	ballot.

10	§ 2.5. SELECTBOARD
11	The Selectboard is a legislative body of five persons elected at large by the
12	voters and youth voters of the Town. The Selectboard directs the affairs of the
13	Town within areas specified in subchapter 4 of this charter.

16	(a) The Selectboard shall be elected at large by the voters and youth voters

4	(a)(1) At the first election of Town Meeting members to be held on the first
5	Tuesday in March after the acceptance of this subchapter, the qualified voters
6	of each district shall elect three Town Meeting members for every 180 voters
7	or major fraction thereof, subject to the provisions of subsection (c) of this
8	section. The first one-third elected in each district, in order of the number of
9	votes received, shall serve for three years; the second one-third in such the
10	order of election shall serve for two years; and the remaining one-third in such
11	the order of election shall be elected to serve for one year. In the event of a tie
12	vote the term of such members shall be designated by lot, and the presiding
13	officer of the district shall certify such the designation. All Town Meeting
14	members shall serve for terms commencing on the day of their election.
15	(2) Annually thereafter, on the first Tuesday in March, the voters <u>and</u>

7	Clerk's office shall vote in the same manner as those voting on election day
8	provided that the voter completes a "Request for Early Voter Absentee Ballot

11	(4) As authorized for certain Town elections pursuant to this charter, a
12	youth voter choosing to vote early shall vote in the same manner as a youth
