Re: Request for relief funding for increased demand due to COVID-19 crisis

Dear Representatives:

First, thank you so much for your hard work during this uncertain time. We appreciate your thoughtful response to this crisis -- there is a great spirit of togetherness right now and we are all feeling proud to call Vermont home.

We write today to request \$50,000 from the COVID-19 Relief Fund for the Junior League of Champlain Valley (JLCV) in support of its Diaper Bank. Due to COVID-19, the demand for, and our distribution of, diapers at no-cost has **increased tenfold in the last two months** in both the number of diapers given out and organizations served.

The JLCV Diaper Bank is the signature project of the Junior League of Champlain Valley, a 501(c)(3) organization, and is **entirely volunteer run and funded** through efforts of JLCV's dedicated members. Since its founding in 2018, the JLCV Diaper Bank has partnered with food shelves in Chittenden and Franklin Counties, distributing approximately 8,500 diapers per month, and 100,000 diapers annually.

Due to COVID-19, we have been **serving organizations in eleven counties**, and, incredibly, we have **distributed over 153,000 diapers since March**. Our operation is lean and, due to being entirely volunteer run, our expenses beyond basic supplies are minimal; any dollars allocated will go directly to Vermonters in need.

There is no federal or state government safety net available for families in need of diapers, and it can **cost over \$75 per month to diaper a child**. Before COVID-19, 1 in 3 U.S. families struggled to provide enough diapers to keep their children clean, dry, and healthy. The COVID-19 pandemic has disproportionately impacted families who lack access to diapers and other basic necessities;

panic purchasing, job losses, and stay home orders have forced more families to turn to nonprofit diaper banks and food shelves.

If awarded, **COVID-19 Relief Fund monies would allow the JLCV to further increase the Diaper Bank's capacity to serve at-risk Vermonters and sustain operations during this uncertain time.** We recognize that this is a one-time request to support the Diaper Bank's COVID-19 response through December 30. The requested money would fall into three categories:

1. Purchase of diapers to replace and bolster inventory - \$41,000. Through bulk buying programs, we are able to secure the lowest possible prices for diapers. In order to continue to assist Vermont through this crisis, we anticipate needing to purchase approximately 250,000 diapers, representing an approximate \$41,000 investment. While we've been fortunate to receive large donations from Seventh Generation and Huggies in recent years, including a supplemental donation from Seventh Generation during the COVID-19 pandemic, those donations alone will not support continued operation at the current level.

Without inventory replacement and enhancement, the JLCV will not be able to continue to meet broad community needs, and will need to scale back or cease operations sooner rather than later beyond our established partnerships with nine food shelves in Chittenden and Franklin counties. Exacerbating the impact of rapid utilization of our inventory, diaper drives in childcare centers and community spaces, which we typically rely on to boost our inventory, have ceased completely during this time, as have all but the most basic volunteer efforts.

2. Additional warehouse space - \$8,000. Our warehouse and repackaging space was stretched thin prior to the increased need for, and utilization of, the JLCV Diaper Bank. We anticipate having to rent additional space to properly store diapers in the quantity required for bulk buying, and to maintain the expanded operations needed to support Vermonters during this time. In the past, the Vermont Foodbank has generously donated warehouse space for excess inventory. However, we cannot rely on this generosity indefinitely, or in such a scope as would meet the demand we're seeing. Pricing for warehouse space, and accompanying storage logistics, represents \$8,000 of our total request.
3. Educate families in need - \$1,000. Ensuring that families struggling with diaper-need know where to find clean, dry diapers for their babies and toddlers outside of our previously existing network will require outreach and education. Additional funding would help us to more firmly establish the expanded distribution network that has emerged and effectively communicate to the general public where free diapers can be

obtained through expanded online information and messaging by our partners.
 Communication support represents \$1,000 of our total request.
