TO THE MEMBERS OF

IN THE ROOM FULL OF COTS THEY CALLED THE RECOVERY ROOM WAS A GIRL ABOUT MY AGE (19) WHO WAS SORBING IN AGONY. I WAS SO NAIVE TO ACTUALLY WONDER WHY. TWO YEARS LATER, AFTER AN OVARIAN CYST FULL OF "HUMAN DETRITUS" SUCH AS "EYEBROWS" ACCORDING TO THE DOCTOR, AND A TUBAL PREGNANCY THAT COULD NOT PLANT IT TO MY WOMB BECAUSE OF SCAR TISSUE, I FOUND OUT I WOULD BE BARREN FOR THE REST OF MY LIFE BECAUSE OF THAT ONE CHOICE TO HAVE AN ABORTION.

AT AGE 39 MY EYES WERE OPENED TO SEE THAT THE LIFE IN THE WOMB I HAD ABORTED HAD ACTUALLY BEEN MY OWN CHILD. THE GRIEF OF THAT AWARENESS BROUGHT ME CLOSE TO SUICIDE. I HAVE RECEIVED HEALING, BUT I URGE YOU TO UNDERSTAND ME: THIS IS NOT SOMETHING I WILL EVER GET OVER. ABORTION RUINED MY OPPORTUNITY TO EVER GIVE BIRTH TO A LIVING CHILD. JUST A CHOICE. BUT IT CHANGED MY LIFE IN HORRIBLE WAYS FOREVER.

PLEASE DO NOT TREAT ABORTION LIGHTLY.
PLEASE DO NOT PASS H.57.
