**Conservation Districts support** healthy aquatic habitats in a number of ways. Essex County NRCD coordinated a culvert replacement on a tributary to the Connecticut River to restore Aquatic Organism Passage, with funding support from U.S Fish & Wildlife.

## Hydroseeder Share Programs

To help towns adapt to water quality standards on roads, Conservation Districts coordinate grant-funded Hydroseeders for towns to share—speeding up maintenance and ensuring quick cover on bare ground in ditches. This program was first coordinated by the Lamoille County NRCD and funded by the Clean Water Initiative

The quiz provides an engaging tool with photos and videos to help illustrate and summarize the required practices. Vermont Farmers receive two hours of education credits upon completion.
