VHCB and Farmland Access

Statutory mission: Protect farmland and keep conserved farmland in active production and affordable to farmers

Policy goal: Prioritize projects that facilitate transfers to new and existing farmers

More than half of all farm conservation projects facilitate transfers:

- Generally, about half of transfers are to new farmers/family members, and half are to existing operations
- Viability program works with Vermont Land Trust to support succession planning and new/beginning farmers







Helping Young Farmers onto the Land with Conservation and Business Planning Support

Over the past 3 years, the Viability Program served 199 newly enrolled farm businesses. One third received transfer/succession planning services.

Through a USDA Beginning Farmer & Rancher Development Grant, VHCB, VLT and the Intervale Center assisted:

- 175 beginning & retiring farmers
- 82 farmers received land access coaching; 38 secured land
- 62 retiring farmers coached in succession planning









Farmland Access - Challenges

- 92% of VT farmers aged 65+ have no one younger than 45 working with them
- Majority of farms have no succession plan
- Average age of Vermont farmers is 57.3
- Rapidly changing marketplace for agricultural products;
 limited farm profitability and changing business models
- Retiring farmers need income, housing; harder to transition a business that is not profitable
- Cost of farmland and infrastructure high relative to profitability of ag business models









Farmland Access: Opportunities

- VHCB Farmland Conservation: majority of projects facilitate farmland transfers, reducing purchase price to buyers
- VLT Farmland Access Program and VHCB Farm & Forest Viability Program: supporting new and retiring farmers working on intergenerational transfers
- New sources of capital, financing and land use models in development
- Coordinated market development/Ag planning:
 VT Agriculture and Food System Plan: 2020









Farmland Access - Recommendations

- Double Farmland Access Capacity: Double the number of retiring and beginning farmers assisted by VLT and VHCB
- Emerging Markets: Increase support for emerging products and markets through business assistance, applied research, market analysis, and benchmarking for products from hemp and grains to grass-fed beef and milk. Professional development on new markets.
- Payment for Ecosystem Services: Compensate farmers for the stewardship of our natural resources.

Conservation Easements & the Option to Purchase at Agricultural Value: How it works

- Easement value equals difference between the farm's current appraised value and the value restricted to agricultural use with the OPAV.
- The OPAV resale restriction only applies to sales to non-farmers/non-family
- New farmers buy farm at appraised "after" value, making purchase affordable
- At least half of all conservation easement projects facilitate transfers
- Retroactive OPAVs: another farm transfer tool

Vermont Farmland Conservation Impacts



- 746 farms, 164,000 acres conserved with VHCB \$\$
- Approximately 460 farms utilized \$58 million in NRCS funding
- 12% of prime and statewide agricultural soils protected
- 20% of agricultural land conserved
- Focus on blocks of farmland in strong agricultural communities
- About 1/2 of all recent projects facilitate transfers to new owners



Connections to Climate & Water Quality






- Viable farm businesses can invest in soil health and regenerative agricultural practices.
- In FY19, the Viability Program granted \$702,377 to 22 farms for water quality infrastructure improvements, leveraging \$5.3 million.
- Farm conservation projects include special restrictions protecting riparian buffers and wetlands.
- Natural resource projects protect shoreline, rivers and headwaters.
- Farm retirement projects underway
- Governor Scott's Vermont Climate Action
 Commission called for increased investment
 in land conservation through VHCB.



Conservation and Water Quality





- Grass-based organic dairy purchased in 2011 from uncle
- 124-acre parcel conserved in 2015; 122-acre home farm conserved in 2017
- Located in Mississquoi watershed (critical source area for phosphorous loading); easement includes riparian buffers
- Farm needed manure pit, barnyard, ditching, laneways, pasture watering system—all installed in 2017-19, with NRCS funding



New Owners Helped onto the LandAg Enterprises Diversified and Strengthened

The Viability Program secured a 3-year federal grant from USDA for education and technical assistance to the next generation of farmers, supporting added capacity at the Intervale Center and VLT for succession/farmland access

A \$624,000 grant from the Northern Borders Regional Commission will be used to launch a 4-state Northeast business assistance program.








Vermont Farm & Forest Viability Program

- 1/3 of clients engaged in transfer or succession planning












Vermont Farm & Forest Viability Program

Rural Economic Development Initiative Grants

FY18-19: \$150,000 in special appropriations for grant writing has helped 16 rural enterprises and small towns win \$2.3M in federal, state, and philanthropic funding.

Funded projects include:

- Broadband expansion in Readsboro
- Revitalizing a community general store in Albany
- Outdoor recreation investment in the Northeast Kingdom
- Wood processing infrastructure in Kirby



Community Center in Bridgewater



REDI support won a \$30,000 VCDP grant to redevelop a historic school building into a community center with childcare and space for local businesses. The new childcare facility is expected to open in 2020.
