# **USS VERMONT (SSN 792)**

- Nuclear fast attack submarine under construction at Electric Boat Company in Groton, Connecticut.
- Third United States Navy warship to be named for our State.
- Third nuclear powered submarine with a Vermont namesake, after ETHAN ALLEN (SSBN 608) and MONTPELIER (SSN 765).
- PCU VERMONT: The Pre-Commissioning Unit (PCU) consists of the officers and crew currently assigned to the ship for training and construction monitoring. They will man the ship for sea trials, and will become the crew of the USS VERMONT (SSN 792) upon commissioning. PCU VERMONT Commanding Officer is Cdr. Henry M. Roenke, USN.



#### **MAJOR MILESTONES**

The major milestones in the life of a new ship are: Naming, Christening, and Commissioning.

 VERMONT was named by the Secretary of the Navy, Ray Mabus, in September, 2014, in a ceremony at the Lake Champlain Navy Memorial in Burlington.



- VERMONT was christened October 20, 2018 at Electric Boat Company in Groton, CT by Ms. Gloria Valdez, sponsor. Ms. Valdez is a former Assistant Secretary of the Navy, and a strong supporter of our namesake submarine. Congressman Peter Welch and Governor Phil Scott participated in the ceremony.
- VERMONT is expected to be commissioned late Spring or early Summer 2020.

#### **COMMISSIONING**

 Upon Commissioning, VERMONT will become USS VERMONT, and join the fleet as the nineteenth VIRGINIA CLASS nuclear fast attack submarine.



 The Commissioning Ceremony is one of the most important milestones in the life of a ship. It represents the acceptance of the ship by the United States Navy, and her entry into the active fleet.

## **Commissioning Community**

Virginia class submarines are named after states. Each namesake state becomes the Commissioning Community for its submarine. The State of Vermont is the Commissioning Community for Vermont. The role of the Commissioning Community is to establish a positive and lasting support relationship with the Pre-Commissioning Unit Officers and Crew and to provide meaningful gifts for the ship, sponsor and crew, and plan and conduct appropriate events for the Commissioning.

# **VERMONT (SSN 792) COMMISSIONING COMMITTEE**

- The Vermont (SSN 792) Commissioning Committee has been established to support VERMONT, her crew, and major events associated with the Commissioning Ceremony.
- Our tasks include: public awareness, hosting crew members, fund raising, and planning and hosting traditional commissioning events.
- We are a volunteer, non-profit (501c3) organization, with 27 members, registered with the Vermont Secretary of State.
