13	shall take effect on passage and shall apply retroactively to March 1, 2020.
14	(b) Secs. 5 and 6 shall take effect on July 1, 2020, provided that if the date
15	of passage of this act is after July 1, 2020, then notwithstanding 1 V.S.A.
16	§ 214, Secs. 5 and 6 shall take effect on passage and shall apply retroactively
17	to July 1, 2020.
