Subject: Review of Governor's Proposed FY 2021 State Budget

On behalf of the Committee on Commerce and Economic Development, I sincerely thank you and the Committee on Appropriations for the opportunity to review the provisions of the Governor's proposed FY 2021 Budget that fall under the policy jurisdiction of this Committee. In response to your request, the Committee reviewed the administration's proposals and ranked each with either a recommendation for funding and high, medium, or low priority, or, a recommendation against funding. The Committee respectfully submits the following concerning the relevant sections:

Other Provisions

- Base funding to the Department of Tourism and Marketing includes \$26,880 for VMBA and \$95,000 for the Vermont Convention Bureau (does not support continued inclusion of these funds)
- Increase to VOSHA base funding (\$73,000) to maintain current staffing levels (does not support) Recommends replacement with the following language:

Sec. 15. 21 V.S.A. § 711 is amended to read:

- § 711. WORKERS' COMPENSATION ADMINISTRATION FUND
- (a) The Workers' Compensation Administration Fund is created pursuant to 32 V.S.A. chapter 7, subchapter 5 to be expended by the Commissioner for the administration of the workers' compensation and for costs of the occupational disease safety and health programs that are not funded by federal OSHA grants and matching State General Fund appropriations. The Fund shall consist of contributions from employers made at a rate of 1.4 percent of the direct calendar year premium for workers' compensation insurance, one percent of self-insured workers' compensation losses, and one percent of workers' compensation losses of corporations approved under this chapter. Disbursements from the Fund shall be on warrants drawn by the Commissioner of Finance and Management in anticipation of receipts authorized by this section.
