- 14 June 30, 2020, select one of these options:
- 15 (1) request the Agency of Education to authorize an amount of
- 16 education spending for the school district equal to the education spending
- 17 amount authorized by the district's 2020 fiscal year school budget; or
- 18 (2) adopt the fiscal year 2021 budget, provided that:

1	(A) if the school board proposed a fiscal year 2021 budget to voters
2	that was defeated, then the budget adopted by the school board shall be less
3	than the amount of the budget that was defeated; or
4	(B) if, on or before the effective date of this act, the school board has
5	warned a fiscal year 2021 budget that has not been voted upon, then the budget
6	adopted by the school board shall be equal to or less than the amount of the
7	warned budget.
8	(b) Notwithstanding any provision of law to the contrary:
9	(1) if the school board requests the Agency of Education to authorize an
10	amount of education spending for fiscal year 2021 under subdivision (a)(1) of
11	this section, that shall be the amount of education spending for that fiscal year;
12	and
13	(2) if the school board adopts the 2021 fiscal year budget under
14	subdivision (a)(2) of this section, that shall be the school district's budget for

16	(c) In addition to the options under subsection (a) of this section, a school
17	district may vote to approve a budget or vote to reconsider or rescind an
18	approved budget in accordance with current law, provided that if the school

20	notwithstanding any provision of law to the contrary, a vote on the district's
21	2021 budget shall not be held after the board vote is taken.

2	subdivision (a)(1) of this section. Notwithstanding 16 V.S.A. § 4001(6), the
3	amount authorized by the Agency of Education under subdivision (a)(1) of this
4	section shall be the "education spending" of the school district for fiscal year
5	2021 under 16 V.S.A. chapter 133.
6	(e) If a school board selects an option under subsection (a) of this section, it
7	shall determine how funds shall be expended and shall have the authority to
8	expend any other funds received from other sources, including endowments,
9	parental fundraising, federal funds, nongovernmental grants, or other State
