3 Subject: Health; health insurance; individual mandate; preexisting conditions;
4 association health plans

5 Statement of purpose of bill as introduced: This bill proposes to implement
6 Vermont’s individual mandate to maintain health insurance coverage. It would
7 also codify in State law certain health insurance consumer protections,
8 including a ban on preexisting condition exclusions and a requirement to
9 provide coverage for dependents up to 26 years of age. The bill would require
10 looking through the structure of an association to provide health insurance
11 plans based on the size of each underlying employer. It would prohibit
12 licensed brokers from accepting payment for enrolling Vermont residents in
13 certain health expense-sharing arrangements and would require the Green
14 Mountain Care Board to quantify the impact of the Medicaid and Medicare
15 cost shifts and uncompensated care on health insurance premiums. The bill
16 would also direct the Agency of Human Services to develop strategies for
17 increasing the affordability of health insurance and to evaluate options for the
18 future of Vermont’s health insurance markets.

1 An act relating to health insurance and the individual mandate

2 It is hereby enacted by the General Assembly of the State of Vermont:

4 Sec. 1. 32 V.S.A. chapter 244 is amended to read:

5 CHAPTER 244. REQUIREMENT TO MAINTAIN MINIMUM
6 ESSENTIAL COVERAGE

7 § 10451. DEFINITIONS

8 As used in this chapter:

9 (1) “Applicable individual” means, with respect to any month, an
10 individual other than the following:

11 (A) an individual with a religious ~~conscience~~ exemption pursuant to
12 section 10456 of this chapter;

13 (B) an individual not lawfully present in the United States; or

14 (C) an individual for any month if for the month the individual is
15 incarcerated, other than incarceration pending the disposition of charges.

16 (2) “Eligible employer-sponsored plan” shall have the same meaning as
17 in 26 U.S.C. § 5000A, ~~as amended,~~ and any related regulations and federal
18 guidance, as in effect on December 31, 2017, ~~and any related regulations.~~

19 (3) “Family size” with respect to any taxpayer means the number of
20 individuals for whom the taxpayer is allowed a personal exemption for the
21 taxable year under subdivision 5811(21)(C)(i) of this title.

1 (4) “Household income” means, with respect to any taxpayer for any
2 taxable year, an amount equal to the sum of:

3 (A) the taxpayer’s adjusted gross income; plus

4 (B) the aggregated adjusted gross incomes of all other individuals

5 who:

6 (i) were taken into account in determining the taxpayer’s family
7 size; and

8 (ii) were required to file a State tax return for the taxable year.

9 (5) “Minimum essential coverage” shall have has the same meaning as
10 in 26 U.S.C. § 5000A, as amended, and any related regulations and federal
11 guidance, as in effect on December 31, 2017, and any related regulations. The
12 term also includes any other coverage or health insurance product deemed by
13 the Department of Financial Regulation to constitute minimum essential
14 coverage based on the criteria established in federal law and guidance in effect
15 on December 31, 2017.

16 § 10452. REQUIREMENT TO MAINTAIN MINIMUM ESSENTIAL
17 COVERAGE

18 An applicable individual shall ensure that the individual and any dependent
19 of the individual who is also an applicable individual is covered at all times
20 under minimum essential coverage.

1 § 10453. SHARED RESPONSIBILITY REQUIREMENT; PENALTY

2 (a) If a taxpayer who is an applicable individual, or any applicable
3 individual for whom the taxpayer is liable, fails to meet the requirement to
4 maintain minimum essential coverage set forth in section 10452 of this chapter
5 for one or more months of the taxable year, then, unless the applicable
6 individual qualifies for an exemption under section 10455 or 10456 of this
7 chapter, there shall be imposed on the taxpayer a penalty in an amount
8 determined under section 10454 of this chapter.

9 (b) Any penalty imposed pursuant to this chapter for any month shall be
10 included with the taxpayer’s return under chapter 151 of this title for the
11 taxable year that includes that month.

12 (c) If an individual with respect to whom a penalty is imposed by this
13 chapter for any month:

14 (1) is a dependent, as defined in 26 U.S.C. § 152, of another taxpayer for
15 the taxable year including that month, the other taxpayer shall be liable for the
16 penalty; or

17 (2) files a joint return for the taxable year including that month, the
18 individual and his or her spouse shall be jointly liable for the penalty.

19 (d) In the event that the federal government reinstates a financial penalty
20 for failure to maintain minimum essential coverage under 26 U.S.C. § 5000A,

1 the monthly penalty established by this chapter shall be suspended for each
2 month for which the federal financial penalty is in effect.

3 § 10454. AMOUNT OF PENALTY

4 (a) The amount of the penalty to be imposed with respect to any taxpayer
5 with household income greater than 250 percent of the federal poverty level for
6 any taxable year for failure to maintain minimum essential coverage shall be
7 equal to the taxpayer’s federal shared responsibility payment for the taxable
8 year under 26 U.S.C. § 5000A and any related regulations and federal
9 guidance, as in effect on December 15, 2017, except that the amount of the
10 penalty to be calculated pursuant to 26 U.S.C. § 5000A(c)(1)(B) shall be
11 determined using the Vermont average premium for bronze-level plans rather
12 than the national average premium for bronze-level plans.

13 (b) Except as provided in subdivision 10455(2) of this chapter, the
14 annualized amount of the penalty to be imposed with respect to any taxpayer
15 with household income less than or equal to 250 percent of the federal poverty
16 level for any taxable year for failure to maintain minimum essential coverage
17 shall be one-half of the applicable dollar amount established for the taxable
18 year pursuant to 26 U.S.C. § 5000A(c)(3), rounded to the nearest \$5.00
19 increment, for each applicable individual, provided that:

20 (1) the amount of the penalty for an applicable individual who has not
21 attained 18 years of age shall be one-fourth of the applicable dollar amount

1 established for the taxable year pursuant to 26 U.S.C. § 5000A(c)(3), rounded
2 to the nearest \$5.00 increment; and

3 (2) the maximum total penalty amount for a household with income less
4 than or equal to 250 percent of the federal poverty level for any taxable year
5 shall be 1.5 times the applicable dollar amount established for the taxable year
6 pursuant to 26 U.S.C. § 5000A(c)(3), rounded to the nearest \$5.00 increment.

7 § 10455. EXEMPTIONS

8 No penalty shall be imposed pursuant to section 10453 or 10454 of this
9 chapter with respect to any of the following:

10 (1) Individuals who cannot afford coverage.

11 (A) No penalty shall be imposed with respect to any applicable
12 individual for any month if the individual’s required contribution, determined
13 on an annual basis, for coverage for the month exceeds 8.3 percent of the
14 individual’s household income for that month, as averaged over the taxable
15 year. For purposes of this subdivision (A), the taxpayer’s household income
16 shall be increased by any exclusion from gross income for any portion of the
17 required contribution made through a salary reduction arrangement.

18 (B)(i) As used in this subdivision (1), “required contribution” means:

19 (I) in the case of an individual eligible to purchase minimum
20 essential coverage through an eligible employer-sponsored plan, the portion of
21 the annual premium that would be paid by the individual for coverage for the

1 individual’s applicable family size, provided that the applicable family size
2 shall not include any family member who is eligible for a medical assistance
3 program under Title XIX (Medicaid) or Title XXI (SCHIP) of the Social
4 Security Act; and

5 (II) in the case of an individual eligible only to purchase
6 minimum essential coverage in the individual market, the annual premium for
7 the lowest-cost bronze-level plan available through the Vermont Health
8 Benefit Exchange for the individual’s applicable family size, reduced by the
9 amount of the federal premium tax credit for which the individual or family
10 would be eligible under 26 U.S.C. § 36B and the amount of Vermont premium
11 assistance available to the individual or family under 33 V.S.A. § 1812(a),
12 provided that the applicable family size shall not include any family member
13 who is eligible for a medical assistance program under Title XIX (Medicaid) or
14 Title XXI (SCHIP) of the Social Security Act.

15 (ii) For purposes of subdivision (i)(I) of this subdivision (1)(B), if
16 an applicable individual is eligible for minimum essential coverage through an
17 employer by reason of a relationship to an employee, the determination under
18 subdivision (A) of this subdivision (1) shall be made by reference to the
19 required contribution of the employee for coverage for the applicable family
20 size, provided that the applicable family size shall not include any family

1 member who is eligible for a medical assistance program under Title XIX
2 (Medicaid) or Title XXI (SCHIP) of the Social Security Act.

3 (2) Taxpayers with lower income. No penalty shall be imposed with
4 respect to any applicable individual for any month during a calendar year if the
5 individual's household income for the most recent taxable year for which the
6 Department of Taxes determines information is available is less than
7 138 percent of the federal poverty level.

8 (3) Members of Indian tribes. No penalty shall be imposed with respect
9 to any applicable individual for any month during which the individual is a
10 member of an Indian tribe as defined in 26 U.S.C. § 45A(c)(6).

11 (4) Months during short coverage gaps.

12 (A) No penalty shall be imposed for any month the last day of which
13 occurred during a period in which the applicable individual was not covered by
14 minimum essential coverage for a continuous period of three months or less.
15 For purposes of this subdivision (4), the length of a continuous period shall be
16 determined without regard to the calendar years in which the months of the
17 period occurred.

18 (B) If a continuous period is greater than three months, no exemption
19 shall be provided for any month in the period.

20 (C) If an applicable individual was not covered by minimum essential
21 coverage for more than one continuous period of three months or less during

1 the same calendar year, the exemption provided by this subdivision (4) shall
2 apply only to the months in the first of such periods.

3 (D) The Commissioner of Taxes, in consultation with the
4 Commissioner of Financial Regulation, shall adopt rules pursuant to 3 V.S.A.
5 chapter 25 for collecting the penalty imposed by sections 10453 and 10454 of
6 this chapter in cases in which a continuous period includes months in more
7 than one taxable year.

8 (5) Hardships. No penalty shall be imposed with respect to any
9 applicable individual for any month if the individual is determined by the
10 Commissioner of Vermont Health Access to have suffered a hardship with
11 respect to the capability to obtain minimum essential coverage for that month.
12 The Commissioner of Vermont Health Access shall adopt rules pursuant to 3
13 V.S.A. chapter 25 defining the circumstances under which an applicable
14 individual shall be deemed to have suffered a hardship under this subdivision
15 (5) and setting forth the process for obtaining an exemption from the penalty.

16 (6) Nonresidents. No penalty shall be imposed with respect to any
17 applicable individual for any month during which the individual does not
18 qualify for Vermont residency, as defined in subdivision 5811(11)(A) of this
19 title.

1 § 10456. RELIGIOUS EXEMPTIONS

2 An individual shall be exempt from the requirement to maintain minimum
3 essential coverage and shall not be subject to a penalty under this chapter for
4 any month if the individual has in effect an exemption from the Commissioner
5 of Vermont Health Access certifying that the individual is:

6 (1)(A) a member of a recognized religious sect or division thereof that is
7 described in 26 U.S.C. § 1402(g)(1) and is an adherent of established tenets or
8 teachings of that sect or division; or

9 (B) a member of a religious sect or division thereof that is not
10 described in 26 U.S.C. § 1402(g)(1), who relies solely on a religious method of
11 healing, and for whom the acceptance of medical health services would be
12 inconsistent with the individual’s religious beliefs.

13 (2) As used in this section, “medical health services” does not include
14 routine dental, vision, and hearing services; midwifery services; vaccinations;
15 necessary medical services provided to children; services required by law or by
16 a third party; and such other services as the Commissioner of Vermont Health
17 Access may provide in rules implementing this chapter.

18 § 10457. ADMINISTRATION AND PROCEDURE

19 (a) Generally. The penalty provided in section 10453 and 10454 of this
20 chapter shall be assessed by the Department of Taxes and collected in the same
21 manner as an assessable penalty under chapter 151 of this title.

1 (b) Reporting coverage.

2 (1) Each applicable individual who files or is required to file an
3 individual income tax return as a resident of Vermont, either separately or
4 jointly with a spouse, shall indicate on the return, in a manner prescribed by
5 the Commissioner of Taxes, whether the individual:

6 (A) had minimum essential coverage in effect for each of the
7 12 months of the taxable year for which the return is filed as required by
8 section 10452 of this chapter, whether covered as an individual or as a named
9 beneficiary of a policy covering multiple individuals; or

10 (B) claims an exemption under section 10455 or 10456 of this
11 chapter.

12 (2) Unless exempted from the penalty pursuant to section 10455 or
13 10456 of this chapter, a penalty shall be assessed on the return if:

14 (A) the applicable individual fails to indicate on the return as
15 required by subdivision (1) of this subsection (b) or indicates that he or she did
16 not have minimum essential coverage in effect; or

17 (B) the applicable individual indicates that he or she had minimum
18 essential coverage in effect, but the Commissioner of Financial Regulation
19 determines, based on the information available to him or her, that the coverage
20 did not constitute minimum essential coverage.

1 (c) Collection of penalties. The Department of Taxes shall have all
2 enforcement and collection procedures available under chapter 151 of this title
3 to collect any penalties assessed pursuant to this chapter. All penalties
4 assessed pursuant to this chapter shall be deposited into the State Health Care
5 Resources Fund established by 33 V.S.A. § 1901d.

6 (1) If in any taxable year, in whole or in part, a taxpayer does not
7 comply with the requirement to maintain minimum essential coverage, the
8 Commissioner shall retain any amount overpaid by the taxpayer pursuant to
9 section 3112 of this title for purposes of making payments.

10 (2) If the amount retained pursuant to subdivision (1) of this subsection
11 is insufficient to satisfy the penalty assessed, the Commissioner shall notify the
12 taxpayer of the balance due on the penalty and any related interest.

13 (d) Appeals. Any applicable individual shall have the right to appeal a
14 penalty collected pursuant to sections 10453 and 10454 of this chapter or the
15 denial of an exemption pursuant to section 10455 or 10456 of this chapter.

16 (e) Rulemaking. The Commissioner of Taxes and the Commissioner of
17 Vermont Health Access shall adopt rules for their respective Departments
18 pursuant to 3 V.S.A. chapter 25 in order to carry out the purposes of this
19 chapter.

1 § 10458. DOCUMENTATION OF HEALTH INSURANCE COVERAGE

2 (a) An applicable individual who indicates on a Vermont income tax return
3 that the individual had minimum essential coverage shall provide to the
4 Department of Taxes, upon the Department’s request, a copy of the statement
5 of coverage furnished to the individual pursuant to 26 U.S.C. § 6055 by the
6 provider of the individual’s minimum essential coverage.

7 (b) In the event that the requirement for providers of minimum essential
8 coverage to furnish a statement of coverage to individuals pursuant to 26
9 U.S.C. § 6055 is suspended or eliminated for any taxable year, the Department
10 of Vermont Health Access and each employer, health insurance carrier, and
11 other entity providing minimum essential coverage to residents of this State
12 shall submit a return to the Department of Taxes including the same
13 information as had been provided to the Internal Revenue Service pursuant to
14 26 U.S.C. § 6055 at such time and in such form as the Commissioner of Taxes
15 shall require.

16 § 10459. OUTREACH TO UNINSURED VERMONTERS

17 The Department of Vermont Health Access, in consultation with the Office
18 of the Health Care Advocate and other interested stakeholders, shall use
19 information obtained from the Department of Taxes regarding Vermont
20 residents without minimum essential coverage to provide targeted outreach to

1 assist those residents in identifying and enrolling in appropriate and affordable
2 health insurance or other health coverage.

3 Sec. 2. 32 V.S.A. § 3102(e) is amended to read:

4 (e) The Commissioner may, in his or her discretion and subject to such
5 conditions and requirements as he or she may provide, including any
6 confidentiality requirements of the Internal Revenue Service, disclose a return
7 or return information:

9 (20) To the Department of Vermont Health Access for purposes of
10 providing outreach to Vermont residents without minimum essential coverage
11 pursuant to section 10459 of this title.

13 § 3112. ALLOCATION OF PAYMENTS

14 (a) Any payment received by the Commissioner from any taxpayer may,
15 notwithstanding any direction by the taxpayer to the contrary, be applied to the
16 taxpayer's liability for any period for any tax administered by the
17 Commissioner and for ~~any period~~ the penalty for failure to maintain minimum
18 essential coverage pursuant to chapter 244 of this title. Any payment may,
19 with respect to any taxable period, be applied first to the amount of any
20 interest; next to the amount of any penalty; next to the amount of any fee; and
21 finally to the amount of any unpaid tax liability for that period.

1 (b) The Commissioner may treat any refund payment owed by the
2 Commissioner to a taxpayer as if it were a payment received from the taxpayer
3 and may apply the payment in accordance with subsection (a) of this section.

4 (c) The provisions of this section shall apply notwithstanding any appeal by
5 the taxpayer.

9 § 4080. REQUIRED POLICY PROVISIONS

10 (a) No ~~such~~ group insurance policy shall contain any provision relative to
11 notice of claim, proofs of loss, time of payment of claims, or time within which
12 legal action must be brought upon the policy ~~which~~ that, in the opinion of the
13 Commissioner, is less favorable to the persons insured than would be permitted
14 by the provisions set forth in section 4065 of this title. In addition, each such
15 policy shall contain in substance the following provisions:

16 * * *

17 (b)(1) Preexisting condition exclusions.

18 (A) A group insurance policy shall not contain any provision that
19 excludes, restricts, or otherwise limits coverage under the policy for one or
20 more preexisting health conditions.

1 (B) As used in this subdivision (1), “group insurance policy” shall
2 not include a policy providing coverage for a specified disease or other limited
3 benefit coverage.

4 (2) Annual limitations on cost sharing.

5 (A)(i) The annual limitation on cost sharing for self-only coverage
6 for any year shall be the same as the dollar limit established by the federal
7 government for self-only coverage for that year in accordance with 45 C.F.R.
8 § 156.130.

9 (ii) The annual limitation on cost sharing for other than self-only
10 coverage for any year shall be twice the dollar limit for self-only coverage
11 described in subdivision (i) of this subdivision (A).

12 (B)(i) In the event that the federal government does not establish an
13 annual limitation on cost sharing for any plan year, the annual limitation on
14 cost sharing for self-only coverage for that year shall be the dollar limit for
15 self-only coverage in the preceding calendar year, increased by any percentage
16 by which the average per capita premium for health insurance coverage in
17 Vermont for the preceding calendar year exceeds the average per capita
18 premium for the year before that.

19 (ii) The annual limitation on cost-sharing for other than self-only
20 coverage for any year in which the federal government does not establish an

1 annual limitation on cost sharing shall be twice the dollar limit for self-only
2 coverage described in subdivision (i) of this subdivision (B).

3 (3) Ban on annual and lifetime limits. A group insurance policy shall
4 not establish any annual or lifetime limit on the dollar amount of essential
5 health benefits, as defined in Section 1302(b) of the Patient Protection and
6 Affordable Care Act of 2010, Pub. L. No. 111-148, as amended by the Health
7 Care and Education Reconciliation Act of 2010, Pub. L. No. 111-152, and
8 applicable regulations and federal guidance, for any individual insured under
9 the policy, regardless of whether the services are provided in-network or out-
10 of-network.

11 (4)(A) No cost sharing for preventive services. A group insurance
12 policy shall not impose any co-payment, coinsurance, or deductible
13 requirements for:

14 (i) preventive services that have an “A” or “B” rating in the
15 current recommendations of the U.S. Preventive Services Task Force;

16 (ii) immunizations for routine use in children, adolescents, and
17 adults that have in effect a recommendation from the Advisory Committee on
18 Immunization Practices of the Centers for Disease Control and Prevention with
19 respect to the individual involved;

20 (iii) with respect to infants, children, and adolescents, evidence-
21 informed preventive care and screenings as set forth in comprehensive

1 guidelines supported by the federal Health Resources and Services

13 (a) As used in this section, “health insurance plan” ~~shall mean~~ means any
14 group or individual policy; nonprofit hospital or medical service corporation
15 subscriber contract; health maintenance organization contract; self-insured
16 group plan, to the extent permitted under federal law; and prepaid health
17 insurance plans delivered, issued for delivery, renewed, replaced, or assumed
18 by another insurer, or in any other way continued in force in this State.

19 (b) A health insurance plan that provides dependent coverage of children
20 shall continue to make that coverage available for an adult child until the child
21 attains 26 years of age, provided that this subsection shall not apply to a plan

11 § 1811. HEALTH BENEFIT PLANS FOR INDIVIDUALS AND SMALL
12 EMPLOYERS

13 (a) As used in this section:

14 (1) “Health benefit plan” means a ~~health insurance policy, a nonprofit~~
15 ~~hospital or medical service corporation service contract, or a health~~
16 ~~maintenance organization health benefit plan offered through the Vermont~~
17 ~~Health Benefit Exchange or a reflective silver plan offered in accordance with~~
18 ~~section 1813 of this title that is issued to an individual or to an employee of a~~
19 ~~small employer policy, contract, certificate, or agreement offered or issued to~~
20 an individual or to an employee of a small employer by a registered carrier to
21 provide, deliver, arrange for, pay for, or reimburse any of the costs of health

1 services. The term includes plans offered through the Vermont Health Benefit
2 Exchange and reflective silver plans offered in accordance with section 1813
3 of this title, but it does not include coverage only for accident or disability
4 income insurance, liability insurance, coverage issued as a supplement to
5 liability insurance, workers' compensation or similar insurance, automobile

13 similar benefits excluded under the Affordable Care Act.

14 (2) "Registered carrier" means any person, except an insurance agent,
15 broker, appraiser, or adjuster, who issues a health benefit plan and who has a
16 registration in effect with the Commissioner of Financial Regulation as
17 required by this section.
