Re: H.57

I am writing this letter regarding H.57 legislation. I appreciate you considering my below thoughts and comments related to the bill.

In Vermont we work hard to tackle hard issues for the good of many. Our laws support works for children, sick, wounded, low income, consumers, the environment, criminals, elderly – many with few voices. These are complicated issues. The State provides many programs and funding for the noted mentioned issues.
