# S.163 An act relating to housing safety and rehabilitation -

Proposal of Amendment from House Committee on General, Housing, and Military Affairs Draft 3.1

The bill proposes to adopt miscellaneous housing proposals relating to health and safety, rehabilitation, and weatherization. The following are sections of the bill that have potential fiscal implications. Yet, many of the provision of this bill, as passed by the Senate, are contingent upon the appropriation of funds in fiscal year 2020.

- New home construction contractors \$240 biennially<sup>2</sup>

#### Iowa

2018 population: 3,156,145

Requires contractors that do business in Iowa and make more than \$2,000 per year to register with the State and pay a \$50 fee. Contractors are required to select a NAICS code that encompasses the contracting activities upon registering<sup>3</sup>.

#### Alaska

2018 population: 737,438

Requires licensing for three types of contracting activities<sup>4</sup>:

- Handyman contractor does not advertise services and performs less than \$10,000 of work annually. \$250 biennially
- General Contractor
  - O With residential endorsement oversees new home construction or performs work at a value greater than 25% of the overall value of the structure<sup>5</sup>. \$350 for registering as contractor and \$350 for residential endorsement.
  - o Without residential endorsement \$350 fee for general contractor license.
- Specialty contractor registration required for work that requires the use of not more than three trades. \$350 licensing fee.

#### Montana

2018 population: 1,062,305

Requires registration for contracting activities as follows<sup>6</sup>:

- <u>Construction contractors</u> engaged in construction industry and has employees, or is manager-managed LLC, or corporation. \$70 biennial fee
- <u>Independent contractor</u> independently established trade, occupation, profession or business, free from control/direction of hiring agent, and not covered by MT worker's compensation policy. \$125 biennial fee
