Jury Service Information

- <u>Orientation and Jury Draw</u>: Your first appearance at court is for orientation and "jury draw". Court staff will greet you and direct you to the orientation room. You will receive information about jury service and have an opportunity to ask questions. After orientation, the judge will begin jury draw, which is a process for selecting jurors for specific cases.
- <u>Schedule</u>: Plan to stay at court until 4:30 PM.
- <u>Lunch</u>: You may bring a lunch, or go out during the lunch break.
- <u>Length of Service</u>: You may be required to serve up to three jury draws and additional days as required to complete up to three trials. The court will not summon you to appear for jury duty for at least two years after you have served on a jury. 4 V.S.A. § 963.
- Please bring your calendar to Court for jury draw.
- Vermont law permits the payment of jurors. If you are not compensated by your employer, you may request payment from the court. It is recommended that you check with your personnel department regarding your Employer's policy on jury service <u>prior</u> to coming to court.
- You will not be eligible to request payment for jury service if you appear at the Court without checking the phone message or website the night before to make sure your appearance is still required.
- If you cannot appear, submit a written request to be excused with your <u>completed</u> questionnaire. The Court will consider your request and notify you of its decision.
- <u>Weapons</u>: Do not bring weapons to the courthouse. You may pass through a metal detector upon entering the courthouse. Your belongings may be searched.
- <u>Americans with Disabilities Act (ADA) Notice</u>: Individuals with disabilities who need a reasonable accommodation to participate in this proceeding are entitled to the reasonable provisions for assistance. If you require an accommodation, please submit your request with your questionnaire.
