I've participated in a great many civic discussions aired on Channel 17 including those on the Burlington Town Center, the Champlain Parkway, and the F-35s. including as moderator of my show, Toward a Livable City. As a two-time candidate for Burlington City Council, I participated in debates on city issues that were essential for the democratic process. What's not to like?

At the same time, the landscape of information media is bleak. Fewer and fewer corporations own the airwaves and their bottom line focus has meant that they prioritize entertainment and news-as-entertainment over in-depth discussion of issues essential to civic engagement. The apparent privatization of Burlington Telecom--I say apparent because the issue is still before regulators--is indicative of this trent away from municipal control and access.

My name is Julia Vallera and I live in Winooski, Vermont. I am submitting this official testimony to be used in regard to the Public Hearing on PEG Access Television happening on October 21, 2019, at Vermont State House. Unfortunately, I cannot be there in person due to work obligations.

I want to stress the value that PEG access channels have for me and my community. I am a college professor, technology consultant and digital media specialist. I work with nonprofit organizations across North Ameria on projects related to digital inclusion, web literacy, net neutrality, and data privacy. The work I do cannot happen without PEG access channels and services so it is urgent that we find a way to sustain it here in Vermont and elsewhere. Here are some recent examples:

1. Daily coverage of community news and information: Public Access Centers like CCTV Channel 17 in Burlington Vermont provide unbiased coverage of local news and information.

2. Outreach to low-income residents: PEG channels are one of the only free or very low-cost places to get training on media technologies.

3. **Marginalized voices and free speech:** PEG channels give every citizen an opportunity to express their opinion through broadcast and internet technology. This is especially important because there no other outlets that provide this service to our towns and cities in Vermont.

4. Local Government Transparency: Public Access Centers like CCTV Channel 17 in Burlington Vermont is the only source for Livestream coverage of official city government meetings. This is vital to provide a level of transparency necessary to convey clarity of day to day government.

5. **Collaboration:** PEG collaborates with other organizations to enhance the quality of life in our cities and towns. They provide an outlet and platform for collaboration around specific issues and projects.

6. An extension of the classroom: PEG centers provide a link between local school districts, colleges, and residents. PEG offers supplemental material, job training, internships and more to enhance learning at any stage in one's professional or personal endeavors.

Dear Members of the PEG Access Study Committee,

I am a member of the League of Women Voters of Vermont, a nonpartisan volunteer organization which encourages the active and informed participation of citizens in government. I am the organizer for the League's Northeast Kingdom chapter.

The LWVNEK often partners with Kingdom Access TV in St. Johnsbury, either by requesting that they record and re-broadcast our public programs like candidate forums or speakers or that they help us produce informational videos which they will then broadcast as part of their programming and which we can also share in a link via email, Facebook and Front Porch Forum, etc.

Just a couple of days ago, I interviewed St. Johnsbury's Superintendent of Schools about a proposed bond to fund improvements to the St. J School building, an issue which St. J's voters will have to vote on in early November, so that St. J's voters can know the facts before they head to the polls. Earlier this year, the LWVNEK interviewed candidates for Select Board in advance of Town Meeting Day, because we often hear from voters that it is very difficult to know who to vote for in local elections because of a dearth of information. Last year, we interviewed St. J's Town Clerk on KATV about the nuts and bolts of registering and voting. We hope to create a nonpartisan program on KATV about "How to Judge a Candidate", to help voters navigate 2020's election cycle.

KATV and PEG Access stations like it across Vermont help the League to educate and engage many more citizens than we could otherwise do, and they do this for us for free. We really need them!

It is also crucial to transparency of government that KATV is there at most of our local government's meetings.

Please find a way to fund PEG Access TV stations like KATV, so that they will continue to be available to build and enliven Vermont's communities.

The Value of PEG Television.

"Threats to freedom of speech, writing and action, though often trivial in isolation, are cumulative in their effect and, unless checked, lead to a general disrespect for the rights of the citizen." – *George Orwell*

PEG television provides citizens the opportunity to think for themselves and express those thoughts to others – how do we place value on that?

My name is Micheal Smith. I am currently President of the Board of Falls Area Community Television (FACT) based in Bellows Falls Vermont. FACT is one of the smallest community access providers in the State of Vermont. We have two full time employees.

Bellows Falls has no Local commercial television station, no local commercial radio station, and no local daily newspaper. FACT broadcasts 24/7 on two channels on Comcast and two channels on Vtel. We live stream on Facebook, maintain a website where we upload all our content and we upload content to our Youtube channel so that it can be accessed on demand.

Falls Area Community Television records and broadcasts the meetings of the Town of Rockingham, the Village of Bellows Falls, the Village of Saxtons River, the Town of Westminster, the Town of Grafton, and the Town of Brookline. We also record and broadcast all the school board meetings for Windham Northeast Supervisory Union and other local boards. Local governments use our recordings as a backup and reference to their meeting minutes.

Falls Area Community Television has provided locally focused programming on social issues, Indigenous people's perspectives, suicide prevention, homelessness, and the opioid crisis. FACT worked in cooperation with the local recovery center, the Rotary Club, healthcare providers and social service agencies to host a program called "The Importance of Hope, stories of recovery".

FACT also provides a venue for community organizations to educate the public about what they do and announce their events and activities. There is a live local events show weekly, numerous shows by religious organizations and always entertaining shows from "Reading with Grandma Kitty" to "Strange Events at the Vilas Bridge" and "The Cellar Hole Investigators

In addition to broadcast activity, Falls Area Community Television, and PEG providers in general, provide training, structure and an environment for everyone, but especially the young, to learn real technical skills in a real-life functioning work environment. Media production is a meld of creativity and technical skill, and as

such attracts people who may not feel challenged in a traditional learning environment, or people who may not be able to tolerate the structure of those environments. FACT has provided opportunities in after school and summer film programs, paid and not paid internships, and part time paid employment to the youth of South eastern Vermont. Our past two executive directors came from attending such programs at FACT when they were growing up. Kids who filmed zombie movies with us during the summer have gone on to college media programs, graduated and are now teaching media at the college level. Others are currently enrolled in college media programs and last year one of our interns won an award from Governor Scott for a Public Service Announcement he did about distracted driving

Not all flowers are roses and not all broadcast content is a polished and professional commercial product. We have learned that without milkweed we might not have monarch butterflies and dandelions, once scorned. are now valuable for the bees and a source of early salad greens. Such is PEG television. Content produced by amateurs, citizens with something to say, may seem without value or frivolous, but may also inform citizens to make local choices, engage our young to create, and everyone to express their feelings and ideas. This is freedom of speech at a fundamental level.

The lawmakers who created PEG fees, which led to public access television, saw it as a way for cable providers to pay back the communities for access to the infrastructure of power poles and right of ways which they used to create their for profit cable networks. We have come to a place and time where all of that is forgotten and the cable providers see this infrastructure as an entitlement and the PEG fees as a way to add to their profit. Under our current federal administration this is part and parcel with the payback to lobbyists. Cable providers in an effort to reap additional profits have convinced the FCC that they provide infrastructure beyond the original build out that entitles them to compensation. In my opinion, this argument has current economic value to the cable providers, but no bearing on the concept originally proposed by lawmakers at the time who seemed to be much more attuned to the public good.

I hope the committee will consider the original intent of the law, the history of public good provided by PEG providers and the current threats to freedom of expression posed by our government and the bottom-line mentality that pervades American culture. PEG Television provides for freedom of speech, freedom of religion, freedom of expression and freedom of thought in an otherwise commercial medium, where money controls and directs what we see, hear and are supposed to think.

The need to maintain access to the cable networks to provide some opportunity for diversity and freedom of creativity is critical in Vermont where basic cable may be the only media that lower income Vermonters have available to them.

Towns have a say in the level of funding for their schools, but they are not free to provide no funding at all. The reason being that all benefit from an educated population. Local TV contributes to community cohesion which is an essential condition for a functioning democracy. Given the current assaults on democracy (*fake news, cranks that spread rumors, internet echo chambers, lack of dialogue across the aisle, lack of respect for the opponent*) we must do what we can to defend mutual respect and cohesion. I like to think that Vermont has a better chance to defend basic democratic principles than most other states. I suggest to override the whims of local politics and decide on funding at state level.

Once our representatives discuss using media for local communication, I suggest to go a step further and provide funding for local internet communication. First of all, provide funding for Front Porch Forum, secondly provide funding for local websites. Road maintenance is paid by taxes; likewise local cyber traffic deserves to paid by all. When all benefit, all should contribute.
