4	Statement of purpose of bill as introduced: This bill proposes to establish
5	standards for the sale, offer for sale, exposure for sale, or distribution of hemp
6	seed in the State.
7	An act relating to establishing standards for the sale of hemp seed
8	It is hereby enacted by the General Assembly of the State of Vermont:
9	Sec. 1. 6 V.S.A. § 571 is added to read:
10	§ 571. HEMP SEED; LABELING; STANDARDS
11	(a) A person shall not sell, offer for sale, expose for sale, transport for sale,
12	or distribute in the State hemp seed that:
13	(1) is not labeled in accordance with the requirements of this section or
14	rules adopted by the Secretary;
15	(2) has false or misleading labeling or advertisement;
16	(3) fails to meet certification or germination standards if standards have
17	been adopted by the Secretary by rule; or
18	(4) consists of or contains prohibited noxious weed seeds, as that term is
19	defined in section 641 of this title.

1	(b) Hemp seed sold, offered for sale, exposed for sale, transported for sale,
2	or distributed in the State shall have a label attached to the bag or container in
3	which the seed is sold, offered for sale, exposed for sale, transported for sale,
4	or distributed. The label shall contain the following information:
5	(1) the name and kinds of each hemp seed present in excess of five
6	percent of the whole percentage by weight;
7	(2) the origin state or foreign country of the hemp seed;
8	(3) whether the hemp seed was certified by a state or foreign country;
9	(4) the percentage by weight of any weed seeds in the container or bag;
10	(5) the percentage by weight of inert matter in the container or bag;
11	(6) the percentage of germination of the seed;
12	(7) the date the seed was packed or packaged; and
13	(8) the name and address of the person who labeled the hemp seed or
14	who sells, offers for sale, exposes for sale, or distributes the hemp seed in the
15	State.
16	(c) The Secretary may issue a stop sale order for the violation of the
17	requirements of this section or rules adopted by the Secretary under this
18	chapter. The sale, processing, and movement of any seed subject to a stop sale
19	order is prohibited until the Secretary issues a release from the stop sale order.

1	(d) A violation of this section or rules adopted by the Secretary under this
2	chapter shall be subject to an administrative penalty under section 569 of this
3	title.
4	(e)(1) A person injured or damaged by a violation of this section or a rule
5	adopted by the Secretary under this chapter regarding the sale, offer for sale,
6	exposure for sale, transport for sale, or distribution of hemp seed in the State
7	may bring an action for equitable relief or damages arising from the violation.
8	(2) The cause of action authorized under this section is in addition to
9	any common law or statutory remedies otherwise available and does not amend
10	or conflict with the powers and authority of the Agency of Agriculture, Food
11	and Markets.

13	§ 566. RULEMAKING AUTHORITY
14	(a) The Secretary may adopt rules to provide for the implementation of this
15	chapter and the Program authorized under this chapter, which may include
16	rules to:
17	(1) require hemp to be tested during growth for tetrahydrocannabinol
18	levels;
19	(2) authorize or specify the method or methods of testing hemp,
20	including, where appropriate, the ratio of cannabidiol to tetrahydrocannabinol
21	levels or a taxonomic determination using genetic testing;

1	(3) require inspection and supervision of hemp during sowing, growing
2	season, harvest, storage, and processing; and
3	(4) require labels or label information for hemp products in order to
4	provide consumers with product content or source information or to conform
5	with federal requirements.
6	(b) The Secretary shall adopt rules establishing how the Agency of
7	Agriculture, Food and Markets will conduct research within the Program for
8	industrial hemp.
9	(c) The Secretary shall adopt rules establishing requirements for the
10	registration of processors of hemp and hemp-infused products.
11	(d) The Secretary shall adopt by rule requirements for the certification,
12	germination, and sale or distribution of hemp seed in the State.
13	Sec. 3. EFFECTIVE DATE
14	This act shall take effect on July 1, 2020.
