**BUSINESS GRANTS Total Business Awards: \$1,107,642, Dairy specific: \$569,581**

Standard Business Grant (\$5-24,999)

59 pre-apps totaling \$1 million (17 of these were dairy for \$297k)  
Invited for full app: 45 applicants for \$808k (16 of these dairy for \$283k)  
Awarded: 11 non-dairy, 7 dairy

Supply Chain Impact Grant (\$25,000-75,000)

32 pre-apps totaling \$1.9 million (2 of these dairy for \$145k)  
Invited for full app: 20 applicants for \$1.2 million (2 of these dairy for \$145k)  
Awarded: 3 non-dairy, 1 dairy

Market Level Impact Grant (\$50,000-150,000)

13 pre-apps totaling \$1.66 million (8 of these dairy for \$986k)  
Invited for full app: 7 applicants for \$874k (6 of these dairy for \$724k)  
Awarded: 1 non-dairy, 3 dairy

Total FY20 Business Grant Pre-applications

104 total pre-applications for \$4.6 million (27 of these dairy for \$1.43 million)  
Invited for full app: 72 applicants totaling \$2.9 million (24 of these dairy for \$1.15 million)

Matching Funds committed by all pre-applicants: \$5.12 million
