Third: In Sec. 2. 27 V.S.A. § 1462(a) after "years after" by inserting the later of

Fourth: In Sec. 2. 27 V.S.A. § 1462(a)(1) by striking out "the later of"

<u>Fifth</u>: In Sec. 2. 27 V.S.A. § 1462(a)(2)(A) by striking out "70.5" and inserting in lieu thereof 72

Sixth: In Sec. 2. 27 V.S.A. § 1469(b)(4) after "is held," by inserting or in another account of the owner's held by the same business association or financial organization,

<u>Seventh</u>: By striking out Sec. 3, effective date, in its entirety and inserting in lieu thereof a new Sec. 3 to read as follows:

Sec. 3. EFFECTIVE DATE

This act shall take effect on January 1, 2021.

19	(1) may waive, in whole or in part, interest under subsection 1594(a) of

4	Subchapter 13. Agreement to Locate Property of Apparent Owner
5	Held by Administrator
6	§ 1601. WHEN AGREEMENT TO LOCATE PROPERTY ENFORCEABLE
7	An agreement by an apparent owner and another person, the primary
8	purpose of which is to locate, deliver, recover, or assist in the location,
9	delivery, or recovery of property held by the Administrator, is enforceable only
10	if the agreement:
11	(1) is in a record that clearly states the nature of the property and the
12	services to be provided;
13	(2) is signed by or on behalf of the apparent owner; and
14	(3) states the amount or value of the property reasonably expected to be
15	recovered, computed before and after a fee or other compensation to be paid to
16	the person has been deducted.
17	§ 1602. WHEN AGREEMENT TO LOCATE PROPERTY VOID
18	(a) Subject to subsection (b) of this section, an agreement under section
19	1601 of this title is void if it is entered into during the period beginning on the
20	date the property was paid or delivered by a holder to the Administrator and
21	ending 24 months after the payment or delivery.

1	(b) If a provision in an agreement described in subsection (a) of this
2	section applies to mineral proceeds for which compensation is to be paid to the
3	other person based in whole or in part on a part of the underlying minerals or
4	mineral proceeds not then presumed abandoned, the provision is void
5	regardless of when the agreement was entered into.
6	(c) An agreement under subsection (a) of this section that provides for
7	compensation in an amount that is unconscionable is unenforceable except by
8	the apparent owner. An apparent owner that believes the compensation the
9	apparent owner has agreed to pay is unconscionable or the Administrator,
10	acting on behalf of an apparent owner, or both, may bring an action in the
11	appropriate court to reduce the compensation to the maximum amount that is
12	not unconscionable. On the final determination of an action filed under this
13	subsection, the court may, on application, award the prevailing party its
14	reasonable attorney's fees, costs, and expenses of litigation.
15	(d) An apparent owner or the Administrator may assert that an agreement
16	described in this section is void on a ground other than it provides for payment
17	of unconscionable compensation.
18	(e) This section does not apply to an apparent owner's agreement with an
19	attorney to pursue a claim for recovery of specifically identified property held
20	by the Administrator or to contest the Administrator's denial of a claim for
21	recovery of the property

1	(f) An agreement between an owner and an asset locator, the primary
2	purpose of which is to locate, deliver, recover, or assist in the recovery of
3	property that is presumed abandoned and that provides for compensation that
4	exceeds 10 percent of the value of the unclaimed property, shall be
5	unenforceable.
6	§ 1603. RIGHT OF AGENT OF APPARENT OWNER TO RECOVER
7	PROPERTY HELD BY ADMINISTRATOR
8	(a) An apparent owner that contracts with another person to locate, deliver,
9	recover, or assist in the location, delivery, or recovery of property of the
10	apparent owner which is held by the Administrator may designate the person
11	as the agent of the apparent owner. The designation must be in a record signed
12	by the apparent owner.
13	(b) The Administrator shall give the agent of the apparent owner all
14	information concerning the property that the apparent owner is entitled to
15	receive, including information that otherwise is confidential information under
16	section 1612 of this title.
17	§ 1604. ASSET LOCATORS
18	(a) All asset locators seeking to interact with the Administrator on behalf
19	of apparent owners shall first register with Administrator on forms prescribed
20	by the Administrator. Registration information shall include an asset locator's
21	previous business experience and whether the asset locator has a criminal

1	record. In order to obtain and maintain registered status, all asset locators shall
2	post a performance bond of not less than \$10,000.00 to insure the
3	Administrator against any fraudulent or mistaken claims that may arise as a
4	result of an asset locator's representation of an apparent owner. A copy of any
5	agreement, or contract, between an asset locator and an apparent owner shall
6	be filed with the Administrator, together with a signed by the apparent owner
7	and notarized "notice to claimant" form, as prescribed by the Administrator,
8	describing the rights of the apparent owner under this subchapter.
9	(b) An owner may not assign his or her rights, or property interests, under
10	this chapter to an asset locator. No power of attorney containing provisions
11	contrary to this section shall be enforceable.
12	Subchapter 14. Confidentiality and Security of Information
13	§ 1611. DEFINITIONS; APPLICABILITY
14	(a) As used in this subchapter, "personal information" means:
15	(1) information that identifies or reasonably can be used to identify an
16	individual, such as first and last name in combination with the individual's:
17	(A) Social Security number or other government-issued number or
18	identifier;
19	(B) date of birth;
20	(C) home or physical address;

1	(D) electronic-mail address or other online contact information or
2	Internet provider address;
3	(E) financial account number or credit or debit card number;
4	(F) biometric data, health or medical data, or insurance
5	information; or
6	(G) passwords or other credentials that permit access to an online or
7	other account;
8	(2) personally identifiable financial or insurance information, including
9	nonpublic personal information defined by applicable federal law; and
10	(3) any combination of data that, if accessed, disclosed, modified, or
11	destroyed without authorization of the owner of the data or if lost or misused,
12	would require notice or reporting under 9 V.S.A. chapter 62 and federal
13	privacy and data security law, whether or not the Administrator or the
14	Administrator's agent is subject to the law.
15	(b) A provision of this subchapter that applies to the Administrator or the
16	Administrator's records applies to an Administrator's agent.
17	§ 1612. CONFIDENTIAL INFORMATION.
18	(a) Except as otherwise provided in this chapter, the following are
19	confidential and exempt from public inspection or disclosure:
20	(1) records of the Administrator and the Administrator's agent related to
21	the administration of this chapter;

1	(2) reports and records of a holder in the possession of the
2	Administrator or the Administrator's agent; and
3	(3) personal information and other information derived or otherwise
4	obtained by or communicated to the Administrator or the Administrator's
5	agent from an examination under this chapter of the records of a person.
6	(b) A record or other information that is confidential under law of this
7	State other than this chapter, another state, or the United States continues to be
8	confidential when disclosed or delivered under this chapter to the
9	Administrator or Administrator's agent.
10	(c) Notwithstanding any other provision of this chapter, or of 1 V.S.A.
11	chapter 5, subchapter 3, the Administrator may withhold information
12	concerning an individual, or specific abandoned property, when in the
13	Administrator's judgment it is necessary to ensure that abandoned property is
14	returned to the rightful owner, or to otherwise protect the owner. In addition,
15	the Administrator may withhold information concerning individuals and
16	abandoned property until notice has been provided in accordance with
17	section 1503 of this title, deny requests for lists of apparent owners in any
18	format for 24 months after the date the property is paid or delivered to the
19	Administrator, and withhold information concerning uncashed checks and
20	other similar payment information prior to the property being presumed
21	abandoned as set forth in subchapter 2 of this chapter.

1	§ 1613. WHEN CONFIDENTIAL INFORMATION MAY BE DISCLOSED
2	(a) When reasonably necessary to enforce or implement this chapter, the
3	Administrator may disclose confidential information concerning property held
4	by the Administrator or the Administrator's agent only to:
5	(1) an apparent owner or the apparent owner's personal representative,
6	attorney, other legal representative, relative, or agent designated under
7	section 1603 of this title to have the information;
8	(2) the personal representative, executor, other legal representative,
9	relative of a deceased apparent owner, agent designated under section 1603 of
10	this title by the deceased apparent owner, or a person entitled to inherit from
11	the deceased apparent owner;
12	(3) another department or agency of this State or the United States;
13	(4) the person that administers the unclaimed property law of another
14	state, if the other state accords substantially reciprocal privileges to the
15	Administrator of this State, or if the other state is required to maintain the
16	confidentiality and security of information obtained in a manner substantially
17	equivalent to subchapter 14 of this chapter;
18	(5) a person subject to an examination as required by subdivision
19	1564(6) of this title.
20	(b) Except as otherwise provided in subsection 1612(a) of this title, the
21	Administrator shall include on the website or in the database required by

1	subdivision 1503(c)(2) of this title the name of each apparent owner of
2	property held by the Administrator. The Administrator may include in
3	published notices, printed publications, telecommunications, the Internet, or
4	other media and on the website or in the database additional information
5	concerning the apparent owner's property if the Administrator believes the
6	information will assist in identifying and returning property to the owner and
7	does not disclose personal information except the home or physical address of
8	an apparent owner.
9	(c) The Administrator and the Administrator's agent may not use
10	confidential information provided to them or in their possession except as
11	expressly authorized by this chapter or required by law other than this chapter
12	§ 1614. CONFIDENTIALITY AGREEMENT
13	A person to be examined under section 1562 of this title may require, as a
14	condition of disclosure of the records of the person to be examined, that each
15	person having access to the records disclosed in the examination execute and
16	deliver to the person to be examined a confidentiality agreement that:
17	(1) is in a form that is reasonably satisfactory to the Administrator; and
18	(2) requires the person having access to the records to comply with the
19	provisions of this subchapter applicable to the person.

1	§ 1615. NO CONFIDENTIAL INFORMATION IN NOTICE
2	Except as otherwise provided in sections 1501 and 1502 of this title, a
3	holder is not required under this chapter to include confidential information in
4	a notice the holder is required to provide to an apparent owner under this
5	<u>chapter.</u>
6	§ 1616. SECURITY OF INFORMATION
7	(a) If a holder is required to include confidential information in a report to
8	the Administrator, the information must be provided by a secure means.
9	(b) If confidential information in a record is provided to and maintained by
10	the Administrator or Administrator's agent as required by this chapter, the
11	Administrator or agent shall:
12	(1) implement administrative, technical, and physical safeguards to
13	protect the security, confidentiality, and integrity of the information required
14	by 9 V.S.A. chapter 62 and federal privacy and data security law whether or
15	not the Administrator or the Administrator's agent is subject to the law;
16	(2) protect against reasonably anticipated threats or hazards to the
17	security, confidentiality, or integrity of the information; and
18	(3) protect against unauthorized access to or use of the information that
19	could result in substantial harm or inconvenience to a holder or the holder's
20	customers, including insureds, annuitants, and policy or contract owners and
21	their beneficiaries.

1	(c) The Administrator:
2	(1) after notice and comment, shall adopt and implement a security plan
3	that identifies and assesses reasonably foreseeable internal and external risks to
4	confidential information in the Administrator's possession and seeks to
5	mitigate the risks; and
6	(2) shall ensure that the Administrator's agent adopts and implements a
7	similar plan with respect to confidential information in the agent's possession.
8	(d) The Administrator and the Administrator's agent shall educate and train
9	their employees regarding the plan adopted under subsection (c) of this
10	section.
11	(e) The Administrator and the Administrator's agent shall in a secure
12	manner return or destroy all confidential information no longer reasonably
13	needed under this chapter.
14	§ 1617. SECURITY BREACH
15	(a) Except to the extent prohibited by law other than this chapter, the
16	Administrator or Administrator's agent shall notify a holder as soon as
17	practicable of:
18	(1) a suspected loss, misuse or unauthorized access, disclosure,
19	modification, or destruction of confidential information obtained from the
20	holder in the possession of the Administrator or the Administrator's agent; and

1	(2) any interference with operations in any system hosting or housing
2	confidential information that:
3	(A) compromises the security, confidentiality, or integrity of the
4	information; or
5	(B) creates a substantial risk of identity fraud or theft.
6	(b) Except as necessary to inform an insurer, attorney, investigator, or
7	others as required by law, the Administrator and the Administrator's agent may
8	not disclose, without the express consent in a record of the holder, an event
9	described in subsection (a) of this section to a person whose confidential
10	information was supplied by the holder.
11	(c) If an event described in subsection (a) of this section occurs, the
12	Administrator and the Administrator's agent shall:
13	(1) take action necessary for the holder to understand and minimize the
14	effect of the event and determine its scope; and
15	(2) cooperate with the holder with respect to:
16	(A) any notification required by law concerning a data or other
17	security breach; and
18	(B) a regulatory inquiry, litigation, or similar action.
19	§ 1618. INDEMNIFICATION FOR BREACH
20	(a) If a claim is made or action commenced arising out of an event
21	described in subsection 1617(a) of this title relating to confidential information

16	subsection 1406(e) of this title.

18	§ 1621. UNIFORMITY OF APPLICATION AND CONSTRUCTION
19	In applying and construing this uniform chapter consideration must be

1	§ 1622. RELATION TO ELECTRONIC SIGNATURES IN GLOBAL AND
2	NATIONAL COMMERCE ACT
3	This chapter modifies, limits, or supersedes the Electronic Signatures in
4	Global and National Commerce Act, 15 U.S.C. Section 7001 et seq., but does
5	not modify, limit, or supersede Section 101(c) of that act, 15 U.S.C. Section
6	7001(c), or authorize electronic delivery of any of the notices described in
7	Section 103(b) of that act, 15 U.S.C. Section 7003(b).
8	§ 1623. TRANSITIONAL PROVISION
9	(a) An initial report filed under this chapter for property that was not
10	required to be reported before the effective date of this chapter, but that is
11	required to be reported under this chapter, must include all items of property
12	that would have been presumed abandoned during the 10-year period
13	preceding the effective date of this chapter as if this chapter had been in effect
14	during that period.
15	(b) This chapter does not relieve a holder of a duty that arose before the
16	effective date of this chapter to report, pay, or deliver property. Subject to
17	subsections 1520(b) and (c) of this title, a holder that did not comply with the
18	law governing unclaimed property before the effective date of this chapter is
19	subject to applicable provisions for enforcement and penalties in effect before
20	the effective date of this chapter.
