4 Subject: Education; State Advisory Panel on Special Education

5 Statement of purpose of bill as introduced: This bill proposes to amend the  
6 special education laws to ensure that the composition of the State Advisory  
7 Panel on Special Education remains in compliance with federal law.

8 An act relating to the State Advisory Panel on Special Education

9 It is hereby enacted by the General Assembly of the State of Vermont:

10 Sec. 1. 16 V.S.A. § 2945 is amended to read:

11 § 2945. STATE ADVISORY COUNCIL PANEL ON SPECIAL  
12 EDUCATION

13 ~~(a) There is created the Advisory Council on Special Education that shall~~  
14 ~~consist of 19 members. All members of the Council shall serve for a term of~~  
15 ~~three years or until their successors are appointed. Terms shall begin on April 1~~  
16 ~~of the year of appointment. A majority of the members shall be either~~  
17 ~~individuals with disabilities or parents of children with disabilities.~~

18 ~~(1) Seventeen of the members shall be appointed by the Governor with~~  
19 ~~the advice of the Secretary. Among the gubernatorial appointees shall be:~~

20 ~~(A) teachers;~~

- 1           ~~(B) representatives of State agencies involved in the financing or~~  
2           ~~delivery of related services to children with disabilities;~~
- 3           ~~(C) a representative of independent schools;~~
- 4           ~~(D) at least one representative of a vocational, community, or~~  
5           ~~business organization concerned with the provision of transition services to~~  
6           ~~children with disabilities;~~
- 7           ~~(E) a representative from the State juvenile and adult corrections~~  
8           ~~agency;~~
- 9           ~~(F) individuals with disabilities;~~
- 10          ~~(G) parents of children with disabilities, provided the child shall be~~  
11          ~~younger than 26 years old at the time his or her parent is appointed to the~~  
12          ~~Council;~~
- 13          ~~(H) State and local education officials, including officials who carry~~  
14          ~~out activities under the McKinney-Vento Homeless Assistance Act;~~
- 15          ~~(I) a representative of higher education who prepares special~~  
16          ~~education and related services personnel;~~
- 17          ~~(J) a representative from the State child welfare department~~  
18          ~~responsible for foster care;~~
- 19          ~~(K) special education administrators; and~~
- 20          ~~(L) two at-large members.~~

1           ~~(2) In addition, two members of the General Assembly shall be~~  
2           ~~appointed, one from the House of Representatives and one from the Senate.~~  
3           ~~The Speaker shall appoint the House member and the Committee on~~  
4           ~~Committees shall appoint the Senate member.~~

5           ~~(b) The Council shall elect its own chair from among its membership. The~~  
6           ~~Council shall meet annually at the call of the Chair, and other meetings may be~~  
7           ~~called by the Chair at such times and places as he or she may determine to be~~  
8           ~~necessary.~~

9           ~~(c) The members of the Council who are employees of the State shall~~  
10           ~~receive no additional compensation for their services, but actual and necessary~~  
11           ~~expenses shall be allowed State employees, and shall be charged to their~~  
12           ~~departments or institutions. The members of the Council who are not~~  
13           ~~employees of the State shall receive a per diem compensation as provided~~  
14           ~~under 32 V.S.A. § 1010 for each day of official business and reimbursement~~  
15           ~~for actual and necessary expenses at the rate allowed State employees.~~

16           ~~(d) The Council shall:~~

17           ~~(1) assume all responsibilities required of the State advisory panel by~~  
18           ~~federal law;~~

19           ~~(2) review periodically the rules, regulations, standards, and guidelines~~  
20           ~~pertaining to special education and recommend to the State Board any changes~~  
21           ~~it finds necessary;~~

1           ~~(3) comment on any new or revised rules, regulations, standards, and~~  
2 ~~guidelines proposed for issuance; and~~

3           ~~(4) advise the State Board in the development of any State plan for~~  
4 ~~provision of special education.~~

5           (a) The State Advisory Panel on Special Education (Panel) is created to  
6 provide guidance with respect to special education and related services for  
7 children with disabilities in the State. Members of the Panel shall be appointed  
8 by the Governor, with the advice of the Secretary of Education. The Panel  
9 shall perform its duties, and members of the Panel shall be appointed, in  
10 accordance with federal law. In addition to members appointed to the Panel to  
11 satisfy the requirements under federal law, the members of the Panel shall  
12 include a representative of each body designated by the State under federal law  
13 as the Parent Training and Information Center and the Protection and  
14 Advocacy System. The total number of members on the Panel shall not exceed  
15 37 members.

16           (b) The Panel shall elect an executive committee from among its members.  
17 The executive committee shall be composed of seven members of the Panel,  
18 one of whom shall be the chair of the Panel. A majority of the members of the  
19 executive committee shall be individuals with disabilities or parents of children  
20 with disabilities (ages birth through 26 years of age). The executive committee  
21 shall call meetings of the Panel and shall direct the work of the Panel.

1       (c) The Panel shall advise both the Agency of Education and the State  
2       Board of Education on those matters upon which the Panel is required, under  
3       federal law, to advise the State Education Agency.

4       (d) Members of the Panel shall be entitled to per diem compensation and  
5       reimbursement of expenses as permitted under 32 V.S.A. § 1010.

6       Sec. 2. TRANSITION

7       On or before August 1, 2020, members shall be appointed to the State  
8       Advisory Panel on Special Education under 16 V.S.A. § 2945 to ensure that  
9       the membership of the Panel complies with federal law, including the  
10       appointment of members who fulfill the requirement that a majority of the  
11       members be individuals with disabilities or parents of children with  
12       disabilities.

13       Sec. 3. EFFECTIVE DATE

14       This act shall take effect on passage.
