To whom it may concern,

I am writing to advocate regarding the state financial year 2020 budget proposal which I understand includes a proposed cut in CIS funding. I wish to make the committee aware of my clinical experience at our Autism Assessment Clinic. We have encountered several families of children under age five with a confirmed diagnosis of Autism Spectrum Disorder who have been unable to access recommended services, specifically intensive behavioral therapy based on the principles of Applied Behavioral Analysis (ABA), which are consistently recommended by expert consensus as having the best evidence for improving outcomes.

In Chittenden County CIS-EI does not currently provide intensive behavioral services though it did provide such services in the past- as it was not sustainable under the current or recent bundled funding structure. The local providers who do provide services- SD Associates and Howard Center, both have significant wait lists for the 0-3 and 3-5 populations. This shortage appears to be based on a combination of available providers (specifically BCBA's required for insurance reimbursement), and reimbursement structures. The end result is that a significant amount of children with ASD diagnosis are not getting the recommended intensity of, or even any, ABA-based services during an integral period of development.
