Executive Summary

The Mission of the Agency of Digital Services is to work together with our partners in state government to deliver simple and intuitive technology solutions that improve the lives of the citizens of Vermont.

Our Vision is to make government services secure and easily accessible to all people doing business and interacting with the State of Vermont. The agency will also manage strategic investments in technology and manage the timing and pace of digital government enhancements.

In alignment with Governor Scott's priorities, the Agency of Digital Services identified the following four goals:

- **By 2020**, improve Vermonters' experience with government by increasing online interaction.
- **By 2021**, increase accuracy of reporting and support creation of a comprehensive Executive Branch information technology (IT) budget by reviewing and categorizing all financial transactions related to technology spending.
- **By 2023**, increase the automation and reliability of services delivered to Vermonters through modern technology.
- **Continuously** defend the state data network and raise employee and citizen awareness of risks in cyberspace to reduce the likelihood of unauthorized access and misuse of Vermont data.

Executive Order

The creation of the Agency of Digital Services allows for restructuring by centralizing critical capabilities for procurement, decision making, and operations.

The Executive Order outlines in detail what the Agency of Digital Services is expected to achieve over time.

1. Improved coordination of technology procurements;
2. Improved project management practices and standards;
3. Improved communication among State agency and department technology resources;
4. Improved IT governance
5. Utilization of technology skills and resources across departments for the benefit of all agencies and departments;
6. A comprehensive understanding of IT Spending;
7. Support of results based accountability;

8. Realignment of IT resources with State priorities

ADS Crosswalk Definitions

Cost of Service Allocation Techniques (Allocation vs Demand):

In order for us to do this we need resources which translates into funding. In conjunction with Finance & Management we came to the conclusion an Internal Service Fund (ISF) model would be in the best interest of the state. The nature of an internal service fund requires allocation of the costs through the VISION Billing Module. This fund is managed by the Agency of Digital Services (ADS) and bills for services provided via five payment mechanisms: ADS Allocation, Service Level Agreement (“SLA”), Telephony/VOIP Charges, Quarterly Timesheet Billing, and Bespoke Charges.

How do we distribute our costs?

- ADS Allocation
- ADS Demand SLA (Hosting, Enterprise Application Support, Enterprise Licensing)
- ADS Demand Timesheets
- Demand Telephone/Collaboration Billing (Cost Per line + Markup for People and Non-People)
- Demand Bespoke Charges (Billed back as order is placed and paid by ADS - on a cash basis - on a 1:1 for basis)

Allocation: Annually, the allocation is calculated for each department by spreading IT costs for shared services across state government based on the number of positions in each budgeted appropriation. Charges include Software, Hardware, People Costs (with respective overhead), Contractual Services, and the Connectivity with a FY21 Allocation of \$12.6M.

Demand: Demand services are budgeted and billed for with the assumption the benefit outweighs the cost to assign these services more specifically to customers rather than the allocation methodology described above.

SLA: Many business units purchase specific services from ADS and are billed for what they consume under the SLA Billing Model. This billing is estimated annually based on a prior year reconciliation of actual costs and consumption against planned budget and known changes specific to the department's need or request. The following services are found within the SLA model.

- Telecom ACD
- Private Cloud
- Desktop Support
- Mainframe
- Enterprise Application Services
- GoToAssist Licenses
- Department Specific Security Services
- ERP Technical Services
- Enterprise Application Licenses e.g. Adobe, Microsoft
- Enterprise Application Support

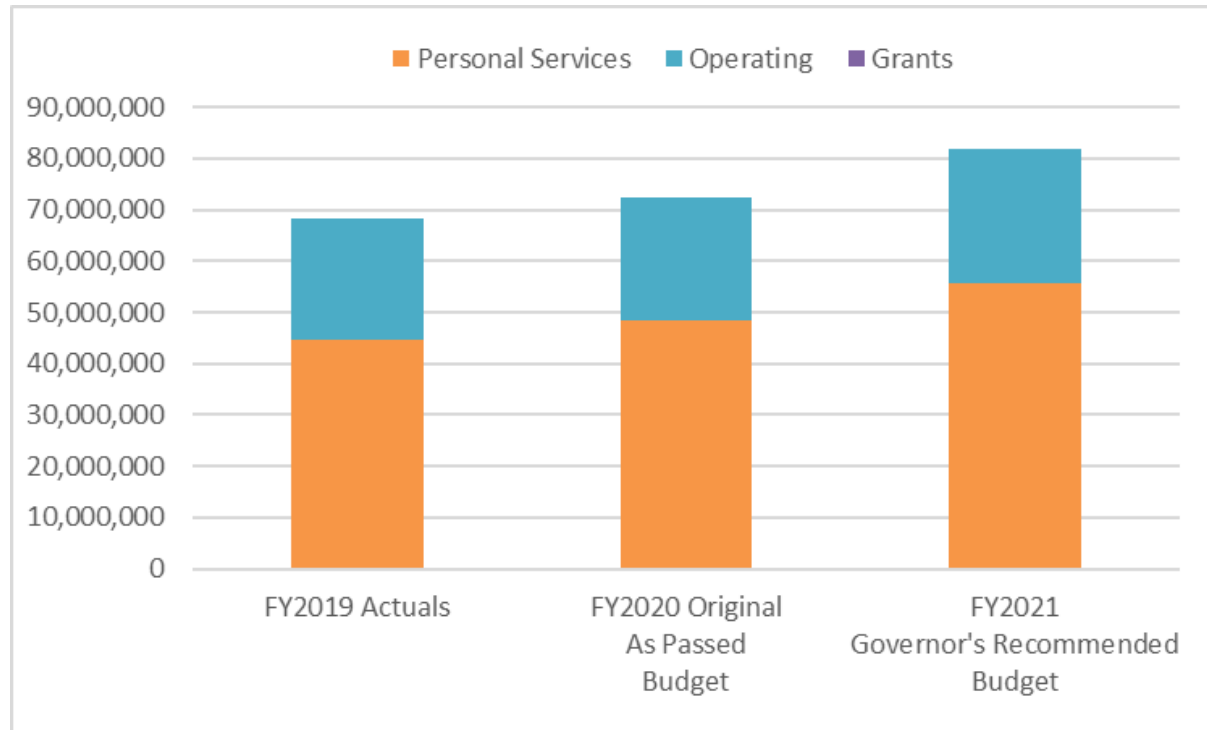
Timesheet: For project specific staff resources, ADS bills out to its customers based on a Federally approved rate. Staff which are classified as follows are captured within this rate structure:

- Enterprise Project Management, Enterprise Architecture, Security, are billed out at \$88/hour
- Non-Enterprise Application Support are billed out at a rate of \$84 per hour. These rates are calculated using currently budgeted costs divided by an estimate of hours available (1412) to bill during the fiscal year.

Telephony: Telephony/Collaboration/VoIP: The telephony/collaboration rate is established by statute for the analog/centrex lines by taking the cost per lines and charging a markup of 11.5% for the amounts paid to vendors whom we paid for the service. The VOIP rates are established in conjunction with Finance & Management and are currently across 3 service options (Standard, Foundation, and Essential) that are dependent on the phone type on the users work station. These rates are established to charge the cost ADS pays to the vendor with a markup that covers the implementation costs of the VOIP project, replacement cycle for the phones, staff time to support the service, and any ancillary software, hardware, and contractual services.

Bespoke Charges: Certain costs are required to be billed back on a [bespoke](#) basis (Hardware and other end-user devices, Software, Independent reviews, other contractual services, specific training related to projects/systems, hardware outside the SLA charges, Wireless Access Points, and telephony equipment associated with ACD).

The chart below is meant to visualize the change from FY19 Actuals to FY20 As Passed to FY21 As Proposed



Observations:

- The key drivers of the FY21 increase in spending authority:
 - Necessary Investments in Cyber Security
 - Increase to Fee for Space
 - The shift of Leased Space fees for staff which have been assumed by ADS as part of the consolidation of IT professionals which occurred in FY19
 - VCGI Parcel Mapping Program which is moving from a federally funded model to a State funded model.

ADS Highlights and Successes

The information included in our 2020 Annual Report submission highlights our successes from calendar year 2019. When ADS was created in April 2017, we made it our mission to keep our IT staff embedded in the agencies they support. This model has created many positive outcomes for our partner agencies. We have highlighted some of those successes in this report. In addition, we have highlighted the major successes achieved this year in each of our ADS Divisions. The wide range of successes across all agencies and departments indicates that the entire Executive Branch is benefitting from centralized IT.

- Upgraded our Internet Edge Traffic Throughput from 1Gb to 10Gb
- Successful Implementation of several High-Profile Projects:
 - Department of Liquor Control (DLC) Point of Sale
 - Agency of Administration (AOA) Human Resource Talent Acquisition Management Solution

Governors Security Initiative

The State of Vermont, like other businesses or organizations, faces evolving cyber-security threats. Some of the main threats we see are viruses, malware, spam, phishing, ransomware, denial of service (DoS) and network intrusion attempts. To combat the rise of cyber threats to the State of Vermont, ADS created a partnership with the Norwich University Applied Research Institute (NUARI) to provide a security operation center (SOC) which would add additional visibility into our network and resources to identify and respond to incidents. In FY20, ADS expanded its capabilities through NUARI with additional hours for analyst coverage, reducing the time to identify and respond to incidents. The expansion of services also allows the State to take advantage of the resources of our partner and the capabilities of assessments, penetration tests, and network optimization. The SOC initiative also ties the State into an expanded information sharing network and provides opportunities for policy development and training to broader industry standards. By working closely with NUARI we have a solid pipeline to cybersecurity talent. Some of whom are already familiar with our network because of their work in the SOC.

To expand further on this important work, ADS is requesting an additional \$1.075M. This money would be added to the allocation, which means it would be spread across the headcount of state government. Cybersecurity threats are growing at an alarming pace across all sectors of industry and government. According to Statescoop, a leading public sector media company, of all ransom attacks, 60% are directed against government entities, with the city of Baltimore paying over \$18 in 2019 alone. Maine being one of the latest to encounter a serious ransomware attack to its network. Whether through email compromise, malware infections, or the direct actions of hackers, State networks face an uphill battle to protect our systems and the data and information which those systems store. Inspecting our existing technologies for flaws and keeping our technology current is critical as our adversaries become more sophisticated and prey upon systems that fall behind. Implementation of these complementary technologies will support the Governor's Cybersecurity Strategy and represent the logical evolution of the requirements for the Vermont Security Operations Center function within the Agency of Digital Services.
