- 20 <u>Subchapter 15. Supplemental Voting Registry</u>

1	<u>§ 1501. ELIGIBILITY OF NON-CITIZEN VOTERS</u>
2	In addition to 17 V.S.A. § 2121, any person may register to vote in
3	Montpelier City elections who, on election day:
4	(1) is a legal resident of the United States;
5	(2) is a resident of the City of Montpelier as defined in 17 V.S.A.
6	<u>§ 2122(b);</u>
7	(3) has taken the voter's oath; and
8	(4) is 18 years of age or older.
9	<u>§ 1502. SUPPLEMENTAL VOTER REGISTRY; CITY CLERK DUTIES TO</u>
10	MAINTAIN
11	Any non-citizen voter shall be placed on a separate, supplemental voter
12	registry held by the City Clerk. This supplemental voter registry shall be
13	treated and maintained in the same manner as a voter checklist under
14	17 V.S.A. chapter 43, subchapter 2. The City Clerk shall develop all necessary
15	forms and procedures for implementation of this subchapter.
16	<u>§ 1503. CITY ELECTION BALLOT</u>
17	In any election involving a federal, State, county, special district, or school
18	district office or question and a City question or City office, the City Clerk
19	shall prepare and provide to any non-citizen voter a ballot that contains only
20	the City questions and candidates.

1	<u>§ 1504. DEFINITIONS</u>
2	As used in this subchapter:
3	(1) "Legal resident of the United States" means any non-citizen who
4	resides in the United States on a permanent or indefinite basis in compliance
5	with federal immigration laws.
6	(2) "Non-citizen voter" means any voter who registers and qualifies to
7	vote in City elections under section 1501 of this charter but is not a citizen of
8	the United States. A non-citizen voter shall not be eligible to vote on any State
9	or federal candidate or question by virtue of registration under section 1501 of
10	this charter.
11	(3) "Supplemental voter registry" means a voter checklist populated by
12	voters who qualify under section 1501 of this charter but are not citizens of the
13	United States. The checklist shall be held separate from any other voter list
14	held or maintained by the City.
15	Sec. 3. EFFECTIVE DATE
16	This act shall take effect on passage.
