14	(a) An employee of an employer who joins the Vermont Municipal
15	Employees' System may become a member of the System on the effective date
16	of participation of said employer or at a later date if he or she has completed
17	three or more years of continuous service as an employee. If an employee does
18	not elect to join on the effective date of the System, he or she may join on the
19	first of any subsequent month.

BILL AS INTRODUCED 2019

1	(b) Any employee who is hired subsequent to the effective date of
2	participation of his or her employer shall become a member of the System on
3	the date the employee is hired.
4	(c) A municipality may elect to join the Vermont Municipal Employees'
5	Retirement System by a vote of the legislative body of such municipality for
6	all its employees or for employees of one or more groups of employees that
7	have a similarity of interest, needs, and general conditions of employment or
8	dates of hire, as determined by the legislative body and approved by the Board.
9	The effective date of participation for such employers shall be designated by
10	the Retirement Board. The vote by the legislative body of a municipality to
11	join the Vermont Municipal Employees' Retirement System shall be
12	irrevocable.
13	(d) The Retirement Board may, upon application of the legislative body
14	and an employee, exempt individual employees from membership in the
15	System, provided that the Board determines that the employee is participating
16	in an alternative retirement system, including a retirement plan qualifying
17	under Section 401(a) or 457 of the Internal Revenue Code, which better meets
18	the retirement needs of the employee.
19	(e) A county sheriff's department may elect to join the Vermont Municipal
20	Employees' Retirement System for its permanent full-time and part-time
21	employees who are not paid by the State of Vermont. The sheriff's department
