Through the Federal CURES act, Vermont is eligible for DHHS SAMHSA's non-competitive two-year State Opioid Response (SOR) grant with \$4 million awarded annually in September 2018 and September 2019. The proposed activities funded by the SOR grant in Vermont will support the continuation and expansion of activities started under the State Targeted Response to the Opioid Crisis (STR) grant.

The SOR grant program aims to address the opioid crisis by increasing access to medication-assisted treatment of opioid use disorder (OUD), reducing unmet treatment need, and reducing opioid overdose related deaths through the provision of prevention, treatment, and recovery activities for OUD including prescription opioids, heroin, and illicit activities secondary to OUD.

Vermont's proposed SOR grant activities aim to increase access to MAT, increase workforce capacity to treat substance use disorder (SUD), increase regional capacity to implement community-specific opioid strategies, and decrease opioid overdose-related deaths. The activities will focus on the following three populations to improve treatment access and engagement: 1) individuals who are in need of but not actively seeking OUD treatment, 2) individuals awaiting administration of MAT, and 3) individuals who may be at heightened risk for opioid overdose. Vermont will achieve these goals by implementing activities that support and enhance direct service and capitalize on Vermont's existing prevention, treatment, and recovery systems to address opioid misuse and serve all 623,657 Vermonters.

Determining Use of Funds

SAMHSA's Opioid SOR grant funds support evidence-based prevention, treatment, and recovery support activities to address the opioid crisis. Grantees may use up to 5% of their grant award for state administrative costs and 2% of their grant award for data collection. Required activities include:

- Implement service delivery models that enable the full spectrum of treatment and recovery support services that facilitate positive treatment outcomes and long-term recovery.
- Implement community recovery support services such as peer supports, recovery coaches, and
 recovery housing. Grantees must ensure that recovery housing supported under this grant is in
 an appropriate and legitimate facility. Individuals in recovery should have a meaningful role in
 developing the service array used in your program.
- Implement prevention and education services including training of healthcare professionals on
 the assessment and treatment of OUD, training of peers and first responders on recognition of
 opioid overdose and appropriate use of the opioid overdose antidote naloxone, develop
 evidence-based community prevention efforts including evidence-based strategic messaging on
 the consequence of opioid misuse, and purchase and distribute naloxone and train on its use.
- Provide treatment transition and coverage for patients reentering communities from criminal justice settings or other rehabilitative settings.
- Make use of the SAMHSA-funded Opioid TA/T grantee resources to assist in providing training and technical assistance on evidence-based practices to healthcare providers in your state who will render services to treat OUD in individuals seeking treatment and recovery services.

The process for determining the use of the funds includes recommendations from:
