1	TO THE HONORABLE SENATE:
2	The Committee on Health and Welfare to which was referred Senate Bill
3	No. 94 entitled "An act relating to expanding Medicaid beneficiaries' access to
4	dental care and establishing the VDent dental assistance program" respectfully
5	reports that it has considered the same and recommends that the bill be
6	amended by striking out all after the enacting clause and inserting in lieu
7	thereof the following:
8	Sec. 1. 33 V.S.A. chapter 19, subchapter 4 is added to read:
9	Subchapter 4. Coverage for Dental Services
10	§ 1991. DEFINITIONS
11	As used in this chapter:
12	(1) "Dental hygienist" means an individual licensed to practice as a
13	dental hygienist under 26 V.S.A. chapter 12.
14	(2) "Dental services" means preventive, diagnostic, or corrective
15	procedures related to the teeth and associated structures of the oral cavity.
16	(3) "Dental therapist" means an individual licensed to practice as a
17	dental therapist under 26 V.S.A. chapter 12.
18	(4) "Dentist" means an individual licensed to practice dentistry under
19	26 V.S.A. chapter 12.

1	§ 1992. MEDICAID COVERAGE FOR ADULT DENTAL SERVICES
2	(a) Vermont Medicaid shall provide coverage for medically necessary
3	dental services provided by a dentist, dental therapist, or dental hygienist
4	working within the scope of the provider's license as follows:
5	(1) Up to two visits per calendar year for preventive services, including
6	prophylaxis and fluoride treatment, with no co-payment. These services shall
7	not be counted toward the annual maximum benefit amount set forth in
8	subdivision (2) of this subsection.
9	(2) Diagnostic, restorative, and endodontic procedures, to a maximum of
10	\$1,000.00 per calendar year, provided that the Department of Vermont Health
11	Access may approve expenditures in excess of that amount when exceptional
12	medical circumstances so require.
13	(3) Other dental services as determined by the Department by rule.
14	(b) The Department of Vermont Health Access shall develop a
15	reimbursement structure for dental services in the Vermont Medicaid program
16	that encourages dentists, dental therapists, and dental hygienists to provide
17	preventive care.

1	Sec. 2. DENTAL ACCESS AND REIMBURSEMENT WORKING GROUP
2	REPORT
3	(a) The Department of Vermont Health Access, in consultation with the
4	Board of Dental Examiners and the Vermont State Dental Society, shall
5	convene a working group of interested stakeholders to:
6	(1) evaluate current Medicaid reimbursement rates to dentists, dental
7	therapists, and other providers of dental services and determine the amount of
8	fiscally responsible increases to the rates for specific services that would be
9	needed in order to attract additional providers to participate in the Vermont
10	Medicaid program;
11	(2) determine the feasibility of and costs associated with establishing a
12	State dental assistance program to provide access to affordable dental services
13	for Vermont residents who have lower income and are enrolled in Medicare;
14	<u>and</u>
15	(3) explore opportunities to further expand access to dental care in
16	Vermont, including:
17	(A) examining the potential to reimburse dentists, dental therapists,
18	and dental hygienists for teledentistry services; and
19	(B) exploring the possible integration of dental services into the
20	scope of services provided through accountable care organizations.

1	(b)(1) On or before November 1, 2019, the Department of Vermont Health
2	Access shall provide to the House Committee on Health Care and the Senate
3	Committee on Health and Welfare the working group's findings and
4	recommendations regarding the feasibility and costs of creating a dental
5	assistance program for Medicare beneficiaries as described in subdivision
6	(a)(2) of this section and on opportunities to further expand access to dental
7	care as described in subdivision (a)(3) of this section. The report shall also
8	include the amount of funding that would be needed to achieve
9	the reimbursement rates determined by the working group pursuant to
10	subdivision (a)(1) of this section.
11	(2) The Department of Vermont Health Access shall report on the amount
12	of funding necessary to achieve the reimbursement rates determined by the
13	working group pursuant to subdivision (a)(1) of this section as part of the
14	Department's fiscal year 2021 budget presentation.
15	Sec. 3. AMENDMENT TO MEDICAID STATE PLAN
16	If necessary, the Secretary of Human Services shall request approval from
17	the Centers for Medicare and Medicaid Services for an amendment to
18	Vermont's Medicaid State Plan to include the expanded Medicaid dental
19	benefits set forth in 33 V.S.A. § 1992.

1	Sec. 4. EFFECTIVE DATES
2	(a) Sec. 1 (33 V.S.A. § 1991), Sec. 2 (dental access and reimbursement
3	working group), Sec. 3 (State Plan amendment), and this section shall take
4	effect on passage.
5	(b) Sec. 1 (33 V.S.A. § 1992) shall take effect on the later of July 1, 2019
6	or approval from the Centers for Medicare and Medicaid Services of the State
7	Plan amendment for expanded Medicaid dental benefits.
8	and that after passage the title of the bill be amended to read: "An act
9	relating to expanding Medicaid beneficiaries' access to dental care"
