Recovery House Inc. - Serenity House/Grace House Senate Institutions Committee FY 2020 Capital Bill April 9, 2019

In the 2018 Legislative session, Recovery House came forward requesting \$400,000.00 to partially fund the cost of an addition at Serenity House in Wallingford, Vermont. We are grateful for the \$300,000 that the Legislature awarded this project.

Much of the recent focus has been on outpatient services, but many people need residential programs. Residential care, for those with substance abuse disorder, is a very important part of recovery - people may need to get away from everything that triggers their addiction and focus on their recovery. Patients live at the program during their entire stay. Their days are structured in such a way as to support their recovery, and they are held accountable. This is often the safest and healthiest place for them to be.

Recovery House provides needed alcohol detoxification services at a rate far below what is typically charged in a hospital setting. The cost savings is approximately \$1000/client/day. Given the cost of serving alcohol detoxification clients in hospitals in Vermont, Serenity House represents substantial long-term savings to Vermonters. Conversations with our Legislators indicated that, in last year's difficult budget year, \$300,000 was what could be provided, and that a return to the Legislature with an ask for the remaining \$100,000.00 would be reasonable. That brings us to our request this year.

The ten new beds consist of six beds for alcohol detoxification suitable to Vermonters in need of Substance Use Disorder treatment, and four beds for opioid detoxification and/or treatment and alcohol treatment for males or females.

The construction is almost complete. There were, of course, pitfalls along the way, such as foundation reengineering and design when excess water was discovered during excavation and framing modifications, all of which added substantially to the cost of the project. Recognizing the need for increased funding for the project, Recovery House applied for, and received, a USDA Rural Development Equipment Grant that offset a portion of expenses. This grant provides 35% of the material costs (not installation) for limited aspects of the project.
