4	WHEREAS, under the Agriculture Improvement Act of 2018, also known as the
5	2018 Farm Bill, hemp was removed from the list of controlled substances and production
6	was therefore legalized throughout the United States; and
7	WHEREAS, a variety of products can be made from hemp through the use of its
8	fiber, seed, seed oil, or floral extracts. Hemp can be found in products such as paper.
9	fabric, auto parts, animal bedding, body care products, and essential oils; and
Ю	WHEREAS, cannabidiol (CBD) is a chemical compound of Cannabis sativa.
11	bearing little to no psychoactive effects, and is being evaluated for its role as a food
12	additive or health supplement; and
13	WHEREAS, in 2019, the Kentucky Department of Agriculture approved 200
14	processors and the production of 60,000 acres of hemp; and
15	WHEREAS, 102 of 120 counties in Kentucky grew hemp in 2019; and
16	WHEREAS, the federal government defines bemp in the 2018 Farm Bill as "the
17	plant Cannabis sativa L. and any part of that plant, including the seeds thereof and all
18	derivatives, extracts, cannabinoids, isomers, acids, salts, and salts of isomers, whether
19	growing or not, with a delta-9 tetrahydrocannabinol concentration of not more than 0.3
20	percent on a dry weight basis"; and
21	WHEREAS, hemp farmers and processors encourage Congress to reassess the
22	definition of hemp as referenced in the 2018 Farm Bill and increase the farm production
23	values to one percent (1%) tetrahydrocannabinol (THC) in order to allow hemp farmers to
24	increase yield potential per acre and profitability for all hemp grown in the
25	Commonwealth; and
26	WHEREAS, increasing yield potential per acre equates to increased profit potential
